## TO: MAYOR AND MEMBERS OF THE CITY COUNCIL

A Special Meeting is being called for Monday, March 12, 2012 at 5:00 p.m. to be held in the City Council Chambers. The purpose of the meeting is for the following.

- 1) PUBLIC COMMENT
- 2) ELEVATED WATER TANK PAINTING: Dolton Rd. & Crandon Ave. (Public Works) &161<sup>st</sup> St. & Torrence Ave. (River Oaks)
  - Results of Bids opened on February 14, 2012.
  - Motion to award the bid to the low bidder Tecorp, Inc. in the amount of \$ 954,855.00 and direct the City Treasurer to create an account in the 2012-2013 appropriation ordinance in the water fund and remit payment from the newly created account.
  - Motion to approve construction engineering in the amount of \$50,000.00 for Robinson Engineering; direct the City Treasurer to remit payment from the newly created account.
- 3) 2012 ROADWAY PROJECTS AND FUNDING SOURCES.
- 4) SIBLEY BLVD. RESURFACING AND DRAINING IMPROVEMENT.

## 5) COMBINED SEWER PUMP STATION RENNOVATION.

- Waive the bidding process, due to a single source vendor, and approve a preequipment purchase with Metropolitan Pump with the estimated payout schedule; direct the Treasurer to make the necessary payouts per the schedule from the appropriate account created in the water/sewer fund payable from the newly created account.
- Authorize the City Clerk to advertise the replacement of the State Street combined sewer pump station with a bid opening in October, 2012.
   (Bid documents and plans prepared by Robinson Engineering previously approved at April 14, 2011 council meeting.
- Authorize Robinson Engineering to perform construction engineering for the combined sewer pump station for an amount not to exceed \$300,000.00 and direct the City Treasurer to remit payment from the newly created account.
- Direct the City Treasurer to transfer TIF monies owed the Corporate Fund and to transfer said Corporate Funds to the Sewer Fund; create an account number for this project and direct payment from said account.
- 6) WATER MAIN REPLACEMENT REPORT.
  - Approve replacing the water main on Lincoln Avenue from 163<sup>rd</sup> Street to 166<sup>th</sup> Street authorize the City Engineer to prepare plans and specifications for a cost not to exceed \$36,000.00 and authorize the City Clerk to advertise for bids; direct the City Treasurer to remit payment from account #030-36-2-349.
- 7) SEWER LINING AND VIDEO PROGRAM UPDATE.
  - Recommendations and possible action to approve project 2012-2013.
