## CITY COUNCIL REPORTS

Mayor Michelle - report Mayor Michelle Markiewicz Qualkinbush: 'Water pollution degrades surface waters making them unsafe for drinking, fishing, swimming, and other activities. As authorized by the Clean Water Act, the National Pollutant Discharge Elimination System (NPDES) permit program controls water pollution by regulating sewers and ditches and the areas tributary into the sewers and ditches that discharge pollutants into waters of the United States and the detention basins.

In 2003, the Illinois EPA (IEPA) required all Municipal Separate Storm Sewer Systems (MS4's) to file a Notice of Intent to describe how they were going to comply with the statewide general permit conditions. Each MS4 community will be required to obtain an NOI and have a fully implemented program, addressing each of the six minimum controls (as identified by the EPA). The NOI was last updated by the City in August 2013. The new 5-year cycle began April 1, 2014 and should through March 31, 2019.

However the IEPA recently revised the MS4 permit in which the new permit became effective on March 1, 2016 and will expire February 28, 2021. MS4's have 180 days (or until September 1, 2016) to be in compliance with the new permit requirements.

The six minimal control measures included in the NOI are:

- 1) Public Outreach and Education (on Storm Water Quality Issues)
- 2) Public Involvement & Participation
- 3) Illicit Discharge Detection and Elimination

Mayor's Report (cont'd)

- 4) Construction Site Storm Water Runoff Control
- 5) Post Construction Storm Water Runoff Control (in New Developments & Redevelopments)
- 6) Pollution Prevention & Good Housekeeping for Municipal Operations

Please note that the city's Public Works Department along with the City Engineer have worked directly with the Illinois EPA to assure compliance with the Six (6) Minimum Control Measures for this upcoming reporting period.

That report is on behalf of the city engineers."

Mayor Michelle: "I would like to report that the City of Calumet City in joining Thornton Township for the 22<sup>nd</sup> Annual Job Fair at South Suburban College scheduled for Tuesday, May 23, 2017 at the South Suburban Fitness Center.

More information will be coming in the next meetings. I would like say the gentleman who talked about the electronics in the alleys. That is a state law. The state prohibits garbage haulers or anyone from putting electronics into the dump sites.

Some of you may have attended the different aldermen have an electronic recycling collections where we will collect TV's and old electronics so they can be disposed of properly by companies and we paid for that to happen.

I did hear everyone's concerns during the public portion of the meeting, including about the minimum and the immigration issue that has been put before the city council.

The City Attorney advised me tonight that he has concluded the review of what was submitted by the residents that came to my office. At the next meeting, we should have an analysis of his review and what his recommendations are for the city council. That will happen at the next meeting."

City Clerk Figgs - report

At this time in the meeting, City Clerk Figgs presented the winners of the Calumet City Vehicle Sticker Art Contest.

"City Clerk Figgs: "This is the 5<sup>th</sup> year conducting the contest. Years ago, as your new City Clerk, I wanted to find a way to have youth became engaged in local government.

I wanted to develop their interests, current events and inspire their creativity. The topics of the art contest are directly related to current events that is happening in our community or our country.

### City Clerk Figgs - report

On behalf of the Franciscan Health Hammond Emergency Department and the Chest Pain Center Committee, I would like to thank you and your crews for a continual job well done. For as long as anyone can remember, the Calumet City Fire Department and Saint Margaret's in Hammond has enjoyed an extremely valuable and unique relationship as we both strive to provide quality emergency care to the community we serve; the uniqueness owing to the fact that, though we are an Indiana hospital, a substantial majority of your calls are transported to us. Though we receive the highest percentage of our patients from your department (as your crews work tirelessly around the clock), the quality of patient care is never compromised.

Of all the agencies that transport to our ED, the Calumet City Fire Department leads them all in quality and innovation. I can safely say that the percentage of compliance with 12-lead transmission and patient care report submission is very close to 100%. Unfortunately, the runner-ups are not even close to 75%. In my two years as EMS Coordinator, I cannot even count on one hand the number of call reviews I have received regarding your crews (which is no small feat considering I receive an average of 3 call reviews per week). Aside from choosing quality personnel to serve on your department, I owe this success to the leadership you provide.

Every concern I have ever brought to your attention (no matter how small), you have handled immediately and with tremendous results. You have been the first to offer new solutions such as allowing us the ability to access your patient care reports through ESO. It was also you who initiated the discussion which prompted me to add CPAP to the Omnicells at all three of my facilities. **ORDINANCE NO.: 17-9**

**AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE  
OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS**

**BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

**Section 1.** That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

615 Saginaw Avenue

**Section 2.** The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.


**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.


