Mayor's report Presentation by Economic Development Coordinator Saunders: "I am here to give

what has become my semi-regular, bi-monthly report on economic development

activities.

I am going to start off with a couple activities that are related to economic development but directly in terms of the business climate in the city but two

strategies that are in progress right now.

First is Rain Ready, which is a program to look at flooding concerns in the Calumet City area where we are coordinating with the Center for Neighborhood

technology.

A community meeting was held at the end of August where we had about 40 to 50

community members in attendance in the council chambers.

We looked at where flooding concerns were greatest and looking at strategies to do what could be considered non-traditional flood mitigation measures throughout

the community.

We will be hearing more about the proposals that are going to be presented by the

team at a subsequent council meeting.

Also the complete streets draft policy has been put together by a Steering

Committee of staff with the city.

The complete streets policy is a policy that looks at immigration of street design and construction that accounts for all sorts of transportation activities. Whether they be bikes, trails and the light so that we have a full range of transportation

uses available to us.

P. Saunders (cont'd)

Those are recommendation that are going to be coming to the council in a future meeting as well. Again, a couple of activities that are under my pervue that I wanted to give you a heads about.

In terms of direct economic development activities, there are two things that are proceeding right now Divita Dialysis on Sibley. The exterior is up. The interior is being worked on right now. There are certainly on pace for a fall opening at that location.

Fullers Car Wash on Torrence Avenue. We had a utility issue with ComEd which required some coordination and assistance from the city.

We think we have a resolution on that, which has halted construction, but we hope to see construction start up again and hoping to have a spring opening.

Wicks Furniture space on River Oaks Drive. We have a Class 8 application that has come through for a furniture store at that location. I think that it will be a wonderful opportunity.

The leaser of that sight is one that has done some furniture store business in the area and has been impressed by the success of Bob's Furniture and sees this as an opportunity for their store to compete more directly with Bob's Furniture and see this is as a good climate for that kind of business.

That is a project that will be coming before the city council also. Shrimp Express vacant site on River Oaks, it looks like they are ready to re-open. They have also submitted a Class 8 property tax incentive application and they will be coming before the council.

Not too far from there, the former Pancake House has been painted and a new sign has been installed called "The Shack". I had some preliminary conversations with the owners of that site. They look like they are also going to be submitting an application and putting forth a new business at that site that would provide a sit down seafood restaurant at that locations.

The Fuddruckers site, I have been receiving numerous inquiries about that site that range from banquet halls and sport bars. It is kind of interesting because the number of inquiries has really risen substantially.

There are probably about 4 to 5 different serious inquiries that are competing with each other for moving to that site.

I am also looking at the possibility of franchise restaurants at that location as well. I think it is an opportunity for us to seek out the best and the highest use for that site. I think it is a wonderful opportunity.

P. Saunders (cont'd)

I am very close to landing a significant food processing manufacturer on 100 Riverside next to Gelita. We are hoping for a redevelopment agreement with that business. They would be bringing at the time they would move in about 20-25 jobs into the area but they see the potential to expand to as many 70 to 100 jobs within the next 3 years should everything work out for that business.

I think it would be an opportunity for us to turn that area along Riverside Drive combining them and Gelita and other uses in the area into what could really be a food manufacturing type of District corridor.

I am also working with Meats by Linz who has been looking at an expansion and renovation of their site. We have been going back and forth on some incentive and redevelopment issues and negotiations and we are hoping to tie that about in the next 6 weeks or so.

Related to the mall, if there is anything that I get regular questions or inquiries about is what's going on with the mall. I think the last time I was here was prior to the announcement Macy's made that they were going to be closing some 100 stores nationwide.

I don't have any indication that Macy's at River Oaks is going to be on that list, in fact, I hear otherwise that they are invested in the site and wish to remain there.

On our side what we are doing is working hard to provide them with the best service that our city can offer to them. We are going to have a coordination meeting as we go into the holiday season where we will bring police and fire so that we have a chance to provide shoppers and residents with a safe and pleasant shopping environment throughout the holiday season. That will be coming up with the mall management.

Lastly, the economic development strategy that I eluded too at the last presentation I made. I am endeavoring on that and still moving forward. Right now I am doing a commercial corridor analysis and looking at the districts and trying to quanify commercial space in the area, not only the space but the amount of vacant land the amount of vacant spaces.

In just having that as a starting point in terms of our data base. That we have the information so we can move forward with the right strategies and a strategic plan. I think once we have that information we will look at each of the corridors like Sibley, north part of Torrence and south part of Torrence, Burnham, River Oaks Drive, looking at the River Oaks Mall and River Oaks West as separate entities as well.

I think we will start to look at what are the best uses put forward, per site, so that we can strengthen our ability to have functioning and successful businesses in the areas. That is where I am right and I welcome any questions."

Mayor Michelle Markiewicz Qualkinbush: "Thank you Pete, I know you will be back. This is under the Mayor's report does anyone have any questions."

Alderman Jones: "Could I ask him a question. You presented a lot of businesses that you said are hoping to come to Calumet City but none of materialized and this plan has been going on for how long?"

Pete Saunders: "Well, those are two different things. One I have been working on several businesses and there is a process for bringing those businesses here. They have all been going to meet with attorneys to talk about property tax incentives.

They have been doing there own due diligence. They have been working on the purchases of those properties over lease agreements with those properties and that is one thing.

As far as the strategic plan goes, I am doing my own due diligence in getting the information about our corridors here so that I have the information that will plague into the strategies that we will have for the community."

Alderman Jones: "With all due respect Mayor, we can't afford to keep bringing in furniture store after furniture store, this is the economic development plan, then I want to know if he comes before the city council again, the number of businesses that are closed and what we are going to do, instead of coming and saying businesses may come to Calumet City.

This is the second presentation where there maybe businesses coming to Calumet City."

City Treasurer Tarka

City Treasurer Tarka; "This past Saturday, The Treasurer's Treasure Trek Family Bike Ride and Bike Registration took place at Castaways Bowl from 10:00 a.m. to 2:00 p.m.

The rain passed through early in the day and turned out to be a great day. My thanks go out to Castaways Bowling alley for allowing us to use their parking lot and the Calumet City Police Department for bringing out the Nascar and the Mobile Command Center.

Everyone who brought a bike to the event that day now has their bike registered with the Calumet City Police Department. If something should happen to that bike and the police department recovers it, we can now return to their rightful owner now that the bikes are registered.

Thanks goes out to Mayor Michelle for her assistance in planning the event and City Clerk Figgs for stopping by to say hello. My thanks go out to Commissioner Billy Manousopoulos and Public Works staff.

It was tabled, the city attorney made the statement that any aldermen doesn't have to put a motion on there for an ordinance to be drafted., so we will happily draft it if we got the request.

At the last meeting, I said I would call you so you can draft those ordinances for me and he said he would.

I replied and sent him the email. So I have the email, so you don't have to provide them a copy because I copied everyone on it.

You can start by what you said, but you are not a voting member of this and you shouldn't be recognized to impune what I say on this council. You are a city attorney who is getting paid.

You are not voting member of this council."

City Attorney Horvath: "Whether I am a voting member of the council or not, you tell the truth."

Alderman Jones: "Mayor he is out of order and he is not supposed to direct comments to an aldermen."

Mayor Michelle Markiewicz Qualkinbush: "I am chairing the meeting, I can say who is out of order or not. Do you have anything else that you want to add to this."

Alderman Jones: "It is disrespectful for the city attorney to impune the aldermen at a council meeting."

ORDINANCE NO.: 16-32

AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

11-164th Street

1462 State Line Road

304-155th Place

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

Ald. Jones - statement

So when you wonder why your water bill is raised and high taxes remember that. At the next city council meeting, I will definitely propose to this city council that we reduce the legal fees and hiring new police officers.
