ORDINANCE NUMBER 18-32

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE IV, SECTIONS 401-411,  
OF THE MUNICIPAL CODE OF CALUMET CITY, COOK COUNTY, ILLINOIS  
(DIRECTOR OF PURCHASING AND PERSONNEL;  
CREATING THE OFFICE OF CITY ADMINISTRATOR/COMPTROLLER)

WHEREAS, the City of Calumet City, Cook County, Illinois (the ACity@) is a municipality and home rule unit of government under Section 6 of Article VIII of the 1970 Constitution of the State of Illinois, and

WHEREAS, the City of Calumet City has a position entitled "Director of Purchasing and Personnel" (Ch. 2, Article IV, Sec. 401-411); and

WHEREAS, the Director of Purchasing and Personnel has traditionally also acted as the administrative representative of the City at meetings, where a high ranking City Administrator must be present; and

WHEREAS, most cities the size of Calumet City have a City Administrator that assists the Mayor with administrative duties, including attending meetings and directing other employees; and

WHEREAS, it would be in the best interests of the City that the office of City Administrator be created; and

WHEREAS, the City Administrator would serve as the Chief Administrative Officer under the direction and supervision of the Mayor; and

WHEREAS, the Mayor would appoint the City Administrator; and

WHEREAS, the City Administrator would assume all duties and responsibilities currently assigned to the position of Director of Purchasing and Personnel; and

WHEREAS, the Mayor and Aldermen consider it in the best interests of the City that the office of Comptroller be created and all duties of that office be those of the City Administrator; and



**WHEREAS**, the Illinois State Statute, 65 ILCS 5/3.1-30-5 allows the Mayor to appoint a Comptroller; and

**WHEREAS**, the Illinois State Statute, 65 ILCS 5/3.1-35-100, allows the corporate authorities to confer upon the Comptroller, “the powers and provide for the performance of the duties that the corporate authorities deem necessary and proper”; and

**WHEREAS**, 65 ILCS 5/3.1-35-105, 110, and 115, allow certain duties and responsibilities to be placed upon the Comptroller including, pursuant to Sec. 3.1-35-115, the responsibility and duty to exercise a general supervision over all the offices of the municipality charged in any manner with the receipt, collection, or disbursement of the municipal revenue, or the collection and return of the municipal revenue into the treasury; and

**WHEREAS**, 65 ILCS 5/3.1-35-115, Sections (b) and (c) also confer certain duties on the Comptroller; and

**WHEREAS**, the corporate authorities desire, and pursuant to this Ordinance, do hereby create the office of Comptroller to include all duties and powers, as defined in 65 ILCS 5/3.1-35-100, and to replace all existing references in the Municipal Code to other officers, and reflect that those duties are now assigned to the “comptroller” or “comptroller’s office”, except those duties and powers currently exercised by the Treasurer, who shall continue to perform the duties pursuant to the ordinances of the City; and

**WHEREAS**, the corporate authorities are concerned about the processing of liens and slow collection of outstanding monies due and owing the City; and

**WHEREAS**, under the supervision and authority of the Comptroller, the monies due and owing the City, as well as future debts owed to the City, shall be collected in an expedited and efficient manner; and

**WHEREAS**, the compensation to be paid to the City Administrator/Comptroller shall remain the same as paid to the Director of Purchasing and Personnel until adjusted by the Mayor and City Council.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1. City Administrator.** There is hereby created the office of City Administrator/Comptroller pursuant to the above recitals and provisions herein, and included in this Section as if restated herein.

**Section 2. Appointment.** The City Administrator shall be appointed by the Mayor, and report directly to the Mayor.

**Section 3. Director of Purchasing and Personnel Abolished.** All of the duties of the Director of Purchasing and Personnel found in 2-401, *et seq.*, of the Municipal Code of Calumet City shall be incorporated and included as the duties of the City Administrator with the result being the office of Director of Purchasing and Personnel shall be abolished.

**Section 4. Comptroller.** There is hereby created the office of Comptroller, as stated in the recitals and provisions above, and incorporated and repeated herein, pursuant to the Illinois Statutes as recited above and repeated herein.

**Section 5. Appointment - Comptroller.** The Comptroller shall be appointed by the Mayor, and report directly to the Mayor.

**Section 6. Duties of Comptroller.** The Comptroller shall perform all duties as specified in the Illinois Statutes as set forth in the recitals and incorporated herein.

**Section 7. Combined Office.** The offices of City Administrator and Comptroller shall be combined and performed by one person and any authorized subordinates, and known as the office of City Administrator/Comptroller.

**Section 8. Compensation.** The City Administrator/Comptroller shall be paid the same as currently designated for the office of Director of Purchasing and Personnel until adjusted by the Mayor and City Council.

**Section 9. Effective Date.** The creation and combination of offices as specified herein shall become effective after passed and signed by the City Council and Mayor, respectively.

**Section 10.** The provisions of this Ordinance are hereby declared to be separable, and if any section, phrase or provision of this Ordinance shall for any reason be declared invalid, such declaration shall not affect the remainder of the sections, phrases and provisions of this Ordinance.

**Section 11.** All ordinances, resolutions or orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded, and this Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form.







**Section 4. Compensation.** The City Administrator shall be paid the same as currently designated for the office of Director of Purchasing and Personnel until adjusted by the Mayor and City Council.

**Section 5. Effective Date.** The creation and combination of offices as specified herein shall become effective after passed and signed by the City Council and Mayor, respectively.

**Section 6.** The provisions of this Ordinance are hereby declared to be separable, and if any section, phrase or provision of this Ordinance shall for any reason be declared invalid, such declaration shall not affect the remainder of the sections, phrases and provisions of this Ordinance.



**Section 7.** All ordinances, resolutions or orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded, and this Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form.

**ORDINANCE NO. 18-34**

**AN ORDINANCE AMENDING CHAPTER 90, ARTICLE VIII, SECTION 90-584,  
OF THE MUNICIPAL CODE OF CALUMET CITY, COOK COUNTY, ILLINOIS  
(TRAFFIC AND VEHICLES)**

**WHEREAS**, the City of Calumet City, Cook County, Illinois (the "*City*") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "*Home Rule Powers*"); and

**WHEREAS**, the Mayor and the City Council of the City of Calumet City (the "*Corporate Authorities*") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interests of the City; and

**WHEREAS**, the Corporate Authorities are charged with the responsibility of overseeing implementation of the terms and provisions of the City's Motor Vehicle License Ordinance, including regulating and assessing the fees charged to residents who have served in the Armed Forces of the United States of America, have been honorably discharged from the branch of the Armed Forces in which they served, and by virtue of their honorable service are entitled to consideration for their dedication to our country.

**NOW, THEREFORE**, be it ordained by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**SECTION 1:** That the above recitals are incorporated herein and made a part hereof, as it fully set forth in their entirety.

**SECTION 2:** That Chapter 90 ("*Traffic and Vehicles*"), Article VIII ("*Vehicle Licenses*"), Section 90-584, ("*Fee*"), of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the underlined language as follows:

(e) Any person who was in the Armed Forces of the United States of America, was honorably discharged, and has been issued a DD-214 Form verifying their status as an honorably discharged veteran, shall be entitled to a \$25.00 discount to be subtracted from the license fee charged for any passenger vehicle, motor scooter, motor tricycle, or motor bicycle vehicle. The \$25.00 discount will be allowed for only one (1) such vehicle license to be issued to said person.

**SECTION 3:** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

**SECTION 4:** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**SECTION 5:** This ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

**AN ORDINANCE AMENDING CHAPTER 2, ARTICLE IV, SECTIONS 401-411,  
OF THE MUNICIPAL CODE OF CALUMET CITY, COOK COUNTY, ILLINOIS  
(DIRECTOR OF PURCHASING AND PERSONNEL;  
CREATING THE OFFICE OF CITY ADMINISTRATOR)**

**WHEREAS**, the City of Calumet City, Cook County, Illinois (the *ACity@*) is a municipality and home rule unit of government under Section 6 of Article VIII of the 1970 Constitution of the State of Illinois, and

**WHEREAS**, the City of Calumet City has a position entitled "Director of Purchasing and Personnel" (Ch. 2, Article IV, Sec. 401-411); and

**WHEREAS**, the Director of Purchasing and Personnel has traditionally also acted as the administrative representative of the City at meetings, where a high ranking City administrator must be present; and

**WHEREAS**, many cities the size of Calumet City have a City Administrator that assists the Mayor with administrative duties, including attending meetings and directing other employees; and

**WHEREAS**, it would be in the best interests of the City that the office of City Administrator be created; and

**WHEREAS**, the City Administrator would serve as the Chief Administrative Officer under the direction and supervision of the Mayor; and

**WHEREAS**, the Mayor would appoint the City Administrator; and

**WHEREAS**, the City Administrator would assume all duties and responsibilities currently assigned to the position of Director of Purchasing and Personnel; and

**WHEREAS**, the compensation to be paid to the City Administrator shall remain the same as paid to the Director of Purchasing and Personnel until adjusted by the Mayor and City Council.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1. City Administrator.** There is hereby created the office of City Administrator pursuant to the above recitals and provisions herein, and included in this Section as if restated herein.

**Section 2. Appointment.** The City Administrator shall be appointed by the Mayor, and report directly to the Mayor.

**Section 3. Director of Purchasing and Personnel Abolished.** All of the duties of the Director of Purchasing and Personnel found in 2-401, *et seq.*, of the Municipal Code of Calumet City shall be incorporated and included as the duties of the City Administrator with the result being the office of Director of Purchasing and Personnel shall be abolished.

**Section 4. Compensation.** The City Administrator shall be paid the same as currently designated for the office of Director of Purchasing and Personnel until adjusted by the Mayor and City Council.

**Section 5. Effective Date.** The creation and combination of offices as specified herein shall become effective after passed and signed by the City Council and Mayor, respectively.

**Section 6.** The provisions of this Ordinance are hereby declared to be separable, and if any section, phrase or provision of this Ordinance shall for any reason be declared invalid, such declaration shall not affect the remainder of the sections, phrases and provisions of this Ordinance.

**Section 7.** All ordinances, resolutions or orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded, and this Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form.





**AN ORDINANCE AMENDING ORDINANCE #17-22 ESTABLISHING THE SALARIES AND OTHER FRINGE BENEFITS OF APPOINTED OFFICIALS, SUPERVISORY PERSONNEL, AND OTHER FULL-TIME AND PART-TIME EMPLOYEES NOT COVERED BY A COLLECTIVE BARGAINING AGREEMENT FOR THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS**

**WHEREAS**, the City of Calumet City, Cook County, Illinois is a home rule unit pursuant to Article VII of the Constitution of the State of Illinois;

**WHEREAS**, the City of Calumet City as a home rule unit, may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the Mayor and City Council of the City of Calumet City, deem it advisable to increase the salaries and affix the type of fringe benefits received by appointed officials, supervisory personnel and other full-time and part-time employees not covered by a collective bargaining agreement.

**BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, in the exercise of its home rule powers as follows:

**SECTION 1. Salary of Appointed Officials**

Below is a list of appointed officials and the annual salary they are to receive for the performance of their duties, effective May 1, 2017, for those officials actively employed as of the date of adoption of this ordinance:

Effective May 1, 2018, all positions noted in Group A are entitled to COLA increases based on the Consumer Price Index-Chicago Region based on the prior calendar year with a floor of 1.5% and a ceiling of 2.5%.

For new employees hired into the above positions (other than Group B), the City Council may pay said positions a lower annual salary or hourly rate.

The salaries earned for each position listed above will be paid in twenty-six (26) installments to be paid every two weeks as set by the Treasurer's office, except for the salaries of the Finance Director, Police and Fire Commissioners, the Zoning Board of Appeals Commissioners, City Attorney and Corporation Counsel which will be paid on the following workday after a regularly scheduled Council Meeting.

Salaries of appointed officials provided herein shall remain in full force and effect, subject to the unrestricted right of the Mayor and City Council to alter, amend, reduce or increase salaries and benefits of appointed officials, who are not subject to any collective bargaining agreement or separate contract in subsequent budget years.

**SECTION 2. Full-Time Employees**

Below is a list of full-time employees and their annual salary they are to receive for the performance of their duties, effective May 1, 2017, for those officials actively employed as of the date of adoption of this ordinance:

The salaries earned for each position listed above will be paid in twenty-six (26) installments to be paid every two weeks as set by the Treasurer's office.

For new employees hired into these positions, the City Council may pay said positions a lower annual salary.

Salaries of full-time employees provided herein shall remain in full force and effect, subject to the unrestricted right of the Mayor and City Council to alter, amend, reduce or increase salaries and benefits of these full-time employees, who are not subject to any collective bargaining agreement in subsequent budget years.

### **SECTION 3. Part-time and Seasonal Employees**

Below is a list of part-time employees and the salary they are to receive for the performance of their duties, effective May 1, 2017 who are actively employed as of the date of adoption of this ordinance:

Emergency Service Patrol	15.00 per hour

The salaries earned for each position listed above will be paid in twenty-six (26) installments to be paid every two weeks as set by the Treasurer's office.

For new employees hired into these positions, the City Council may pay said positions a lower annual salary.

Salaries of part-time employees provided herein shall remain in full force and effect, subject to the unrestricted right of the Mayor and City Council to alter, amend, reduce or increase salaries and benefits of these part-time employees, who are not subject to any collective bargaining agreement in subsequent budget years.

#### **SECTION 4. Legislative Secretaries**

It is the policy of the City of Calumet City, Cook County, Illinois, that the seven (7) elected Aldermen are entitled to legislative secretaries. A monthly amount of \$1,000 is allocated to each Alderman for his/her legislative secretaries effective May 1, 2017.

#### **SECTION 5. Comp Time**

As management and exempt employees, during the tenure of their length of service under this ordinance they shall not be entitled to comp time. Department heads shall retain whatever comp time or other benefits permitted by the collective bargaining agreements of the City relative to their employment prior to becoming a department head. Payment of comp time or other benefits permitted by the collective bargaining agreements of the City relative to their employment prior to becoming a department head will be paid at the rank attained at the time prior to appointment. All comp time will be paid at the time of separation of employment, if said separation does not involve termination for cause.

#### **SECTION 6. Insurance**

To the extent that insurance is not covered under the collective bargaining agreement, the City shall continue to make available to individuals eligible to be covered under Sections 1 (Group A) and Section 2 of this ordinance as well as the positions of Finance Director, Corporation Counsel and Office of Professional Standards – Director/FOIA Officer and their dependents, substantially similar group health and hospitalization insurance, dental insurance and life insurance coverage and any benefits that exist at the time of passage of this ordinance.

The City retains the right to elect a different insurance carrier, provide coverage through "HMO" systems or self-insure. It is the intent of this ordinance that such benefits shall be covered and shall not be terminated except as permitted by law. The City Council may, by a majority vote, approve improved insurance benefits for those employees covered under Sections 1 (Group A) and Section 2 at any time during the term of this and subsequent ordinances.

The City shall deduct from said individuals' salaries for Health and Hospitalization insurance effective May 1, 2009. Said deduction will be done on a monthly basis, depending upon the type of coverage. Employees selecting HMO coverage shall contribute \$80.00 per month for single coverage and \$100.00 per month for family coverage toward the cost of the premium. Employees selecting PPO coverage shall contribute 20.0% of the cost of the premium, whether electing single or family coverage. If the employees should select "HMO - Blue Advantage" the monthly premium for single would be \$70.00 per month and family \$80.00 per month. Premium adjustments are made each August 1, under the current providers.

Individuals covered under this section, who have provided fifteen (15) years of service to the City and who reached the age of fifty (50), or reach the age of 50 in any calendar year of which this ordinance is in effect, may upon notice of the individual's intent to retire or separate from service, request to participate in the City's health and dental insurance coverage after retirement and will pay the same contribution rate as active employees under this ordinance including any future adjustments. To remain eligible, retired or separated individuals must continue to make their contribution payments. Individuals will continue to make contribution payments for insurance coverage until such time as the retired or separated individuals reaches Medicare coverage age, at which time the retiree or separated individuals shall be eligible for any then existing supplemental insurance program paid by the City. Employees who are discharged for cause or who are found guilty of a crime involving honesty, trust, moral turpitude or any fiduciary relationship will not be eligible for this benefit.

The City shall supply each individual covered under this section a life insurance policy of Twenty Thousand (\$20,000) dollars while an active employee and Five Thousand (\$5,000) once the employee has retired.

#### SECTION 7. Sick Days

It is the policy of the City of Calumet City, Cook County, Illinois, that eligible individuals who are covered under Sections 1 (Group A) and Section 2 of this ordinance and which are classified as full-time employees shall accrue one (1) day (8 hours) of sick-time for each month worked. Said sick-time will be accounted for in the personnel office. When one of the above mentioned individuals uses a sick day, said time reports should designate when a sick day is being used. For extended non-occupational injuries or illness's said individuals covered under this section will continue to be paid from the number of unpaid accrued sick days they have accumulated. In no event, shall said individuals be paid beyond those accumulated sick days.

If said individuals need to extend sick day pay beyond what they have accumulated, then they can petition the Council for additional time off with pay. The Council can approve additional time-off with pay for a maximum period of six months. When said individual does return to work under these circumstances new sick days accumulated will be offset by those days paid when the City Council granted additional time off.

If an individual included in this section resigns or is terminated, said individual will not be entitled to buy-back of any unused sick days earned while covered under this ordinance.

For full-time employees that are assigned to one of the positions covered under this ordinance and prior to new assignment, if they were part of a collective bargaining unit, sick days accumulated under the collective bargaining agreement will be frozen at the time of positional change and computation of sick days will be determined at the hourly rate of the individuals rank attained prior to being appointed to a full-time position (Sections 1 (Group A) and Section 2) covered under this ordinance. Any sick days used will first be subtracted from the accumulated days earned under their new position, and only after all accumulated days earned under the new position have been used, can the accumulated days earned under their old position be used.

**SECTION 8. Longevity**

All individuals under Sections 1 (Group A) and Section 2 will be eligible for longevity pay. Longevity pay will be determined by the number of years served in the positions covered above. The years served will be determined by the number of years they have served in their current positions. Other positions held by the employee working for the City, will not count toward years of service (Example – If an employee served 3 years as the Purchasing Director and then is moved to a new position under this ordinance, the three years served will not count toward years of service for his/her new position.

The longevity schedule is listed below. The City agrees to pay this additional percentage of the employee's annual base salary, according to the following schedule:

End of three (3) years of service	9%
End of six (6) years of service	12%
End of nine (9) years of service	15%
End of twelve (12) years of service	18%
End of fifteen (15) years of service	21%
End of eighteen (18) years of service	24%
End of twenty (20) years of service	27%

**SECTION 9. Severance Pay**

All management and full-time employees under Section 1 (Group A) and Section 2 of this Ordinance shall be entitled to one month's severance pay upon the City terminating said individuals. If an employee retires no severance pay will be due. If individuals continue employment with the City, but in a different job title, then no severance pay will be due. The City also retains the right to withhold said payment for just cause.

**SECTION 10. Vacation Pay/Personal Days**

All individuals under Sections 1 (Group A) and Section 2 and who are paid an annual salary shall be designated as full time employees and shall be entitled to vacation time with pay pursuant to the following schedule:

End of six months .....	(1) one week
Start of second year .....	(2) two weeks
End of 5th year .....	(3) three weeks
End of 10th year .....	(4) four weeks
End of 15th year .....	(5) five weeks
End of 20th year .....	(6) six weeks

All individuals may divide their vacation into (1) one week segments. For all individuals who have separated time with the City and later return, shall be reinstated for their time earned while employed by the City for the purpose of the vacation schedule.

All individuals under Sections 1 (Group A) and Section 2 shall be entitled to 4 personal days per fiscal year. Unused personal days at the end of the fiscal year will be lost. No personal days can be carried forward.

**SECTION 11. Repeal**

All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**SECTION 12. Effective Date**

This Ordinance shall be in full force and effect immediately upon its passage to ensure that the health, safety and welfare of the residents of the City are duly protected and served.

**SECTION 13. Legislative Act**

This Ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such Ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a matter or regarding a matter not delegated to municipalities by state law. It is the intent of the Corporate Authorities of the City of Calumet City that the extent that the terms of this Ordinance should be inconsistent with any non-preemptive state law, that this Ordinance shall supersede state law in that regard within its jurisdiction.

ORDINANCE AMENDING CHAPTER 82 BY CREATING ARTICLE XV TITLED  
"VEHICLE FUEL TAX" IMPOSING A VEHICLE FUEL TAX IN THE CITY OF  
CALUMET CITY, COOK COUNTY, ILLINOIS

---

**WHEREAS**, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

**WHEREAS**, the City as a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs, including the power to regulate for the protection of public morals and welfare; and

**WHEREAS**, the City is required by State and Federal mandates to provide more and more services, programs, and facilities to its citizens; and

**WHEREAS**, the costs of complying with the State and Federal mandates, the reasonable demands of the citizenry and maintaining, repairing, and replacing the public infrastructure of the City is estimated to exceed present funding availability; and

**WHEREAS**, a new source of revenue is needed by the City to meet its estimated funding needs for mandates and infrastructure maintenance and improvements; and

**WHEREAS**, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") have determined it to be in the best interest of the health, safety and welfare of the residents of the City to impose a vehicle fuel tax in order to raise the necessary revenue to maintain, repair, and replace the City's public infrastructure, and meet its mandated obligations.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That Chapter 82, "Taxation," of the Municipal Code of Calumet City, Illinois, is hereby amended by adding Article XV, "Vehicle Fuel Tax," which shall state as follows:

**Article XV. – VEHICLE FUEL TAX**

**Sec. 82-521. – Definitions.**

For the purpose of this article, when any of the following words or terms are used herein, they shall have the meaning or construction ascribed to them in this section:

*City* means the City of Calumet City, Illinois.

*Calumet City's Vehicle Fuel Tax* shall be used as a short citation to refer to this Article.

*Distributor* or *vehicle fuel distributor* means any person who produces, refines, blends, compounds or manufactures vehicle fuel in the City, or transports or has transported vehicle fuel to any location in the City, or receives in the City vehicle fuel on which the City's Vehicle Fuel Tax has not been paid; or sells vehicle fuel to a retail dealer for resale in the City.

*Distributor* shall include any person who transports vehicle fuel into the City or receives vehicle fuel in the City for his own use and consumption, and not for sale or resale.

*Person* means any individual, firm, trust, estate, partnership, association, corporation, joint venture, joint stock company, receiver, trustee, conservator, legal representative, or other legally recognized entity.

*Retail dealer* or *retail vehicle fuel dealer* means any person who is engaged in the business of selling vehicle fuel in the City to a purchaser for the purchaser's use or consumption, and not for resale in any form.

*Sale, resale, or purchase* means any transfer of ownership or title or both, any exchange or any barter, whether conditional or otherwise, in any manner or by any means whatsoever for consideration.

*Sale at retail* means any sale to a person for that person's use or consumption and not for resale to another.

*Tax* means City's Vehicle Fuel Tax.

*Use* means the exercise of any right to or power over vehicle fuel incident to the ownership thereof including but not limited to, the receipt of vehicle fuel by any person into a fuel supply tank of a vehicle.

*Vehicle* means any machine or device in, upon or by which any person or property is or may be transported or drawn upon a rail, street, road, highway or otherwise upon land, in or upon water, or through the air. *Vehicle* includes without limitation automobiles, trucks, buses, trains, motorcycles, boats, airplanes, and helicopters.

*Vehicle fuel* means any volatile and inflammable liquid or gas produced, blended or compounded for the purpose of or which is suitable for operating a vehicle, or which is used in propelling a vehicle. *Vehicle fuel* includes without limitation gasoline, gasohol, diesel oil, motor benzol, motor benzene, propane gas fuel, kerosene and "special fuel" as defined in the Illinois Motor Fuel Tax Law.

**Sec. 82-522. – Tax Imposed.**

A tax is hereby imposed upon the privilege of purchasing or using, in the City of Calumet City, vehicle fuel purchased in a sale at retail. The tax shall be at a rate of \$.05 per gallon of vehicle fuel. The ultimate incidence of and liability for payment of the tax shall be upon the purchaser or user of the vehicle fuel, and nothing in this Article shall be construed to impose a tax upon the occupation of selling or distributing vehicle fuel. It shall be a violation of this Article for any distributor or retail dealer to fail to add this tax to the retail price of vehicle fuel or to absorb the tax. The tax shall be in addition to any and all other taxes.

**Sec. 82-523. – Payment on Retail Purchase**

*Use in the City* shall be deemed to occur only at the place in the City where the vehicle fuel is transferred into the vehicle by which it is to be consumed. To the extent that a person has paid the tax imposed herein on the retail purchase of vehicle fuel, he shall be exempt from the

payment of and liability for said tax on the use of such fuel.

**Sec. 82-524. – Collection.**

The City's Vehicle Fuel Tax shall be collected by each vehicle fuel distributor who sells such fuel to a retail vehicle fuel dealer doing business in the City. Any distributor who shall pay the tax to the City shall collect the tax from any retail dealer to whom the distributor sells vehicle fuel. The retail dealer shall in turn then collect the tax from the purchaser of the vehicle fuel. Any distributor who sells vehicle fuel directly to a purchaser or user, for delivery in the City, and not for resale, shall collect the tax from the purchaser or user.

If any retail vehicle fuel dealer receives vehicle fuel upon which the City's Vehicle Fuel Tax has not been collected by the distributor, the retail dealer shall remit such tax directly to the City Clerk or Comptroller, as specified by ordinance, by the last day of the month following the month in which he received such vehicle fuel, and shall collect such tax from his purchasers.

If any purchaser or user receives vehicle fuel upon which the City's Vehicle Fuel Tax has not been collected by the distributor or retail dealer, such purchaser or user shall pay the tax directly to the City by the last day of the month following the month in which such purchaser or user made the taxable purchase or use of the vehicle fuel.

Any tax remittance required to be made directly to the City shall be made to the City Clerk or Comptroller, as specified by ordinance, and shall be accompanied by a remittance form prescribed by the City Clerk, or Comptroller, as specified by ordinance.

Any person who collects the City's Vehicle Fuel Tax shall do so as a trustee for and on account of the City of Calumet City.

**Sec. 82-525. – Registration, Return, and Filing.**

Every vehicle fuel distributor doing business on June 1, 2018, shall register with the City Clerk or Comptroller, as specified by ordinance, by June 30, 2018. Every person becoming a distributor after that date shall register with the City Clerk, or Comptroller, as required by ordinance, within 30 days after the commencement of such business. Every distributor shall file each month with the City Clerk, or Comptroller, as required by ordinance, a remittance return, containing a report of his sales of vehicle fuel to retail dealers or users in the City occurring in the prior month. The return shall be in a form prescribed and furnished by the City Clerk, or Comptroller, as required by ordinance. If mailed, the return must be postmarked on or before the last day of the month following the month for which the report is due. Each such return shall be accompanied by a remittance of the appropriate amount of tax applicable to the sales reported. Payment shall be made to the City Clerk or Comptroller, as required by ordinance.

**Sec. 82-526. – Inventory report.**

By July 1, 2018, every retail vehicle fuel dealer shall file with the City Clerk or Comptroller, as prescribed by ordinance, on forms supplied by the City Clerk or Comptroller, as prescribed by ordinance, for that purpose, an inventory of all vehicle fuel in the retail dealer's possession on June 15, 2018 at 12:01 am. The owner or chief executive officer of the retail dealer shall sign the inventory report and attest under oath to its accuracy. With the inventory report, the retail dealer shall pay to the City the City's Vehicle Fuel Tax due on the sale of all vehicle fuel in the retail dealer's possession on June 15, 2018 at 12:01 a.m. and for which such tax has not been collected on behalf of the City by a vehicle fuel distributor.

**Sec. 82-527. – Commission on tax paid when due.**

A distributor or retail dealer remitting the tax to the City shall be entitled to a commission of one (1%) percent of the tax remitted, to compensate him for the cost of collection, filing returns, and supplying information to the City Clerk or Comptroller, as prescribed by ordinance, but in no event shall any commission be allowed on any tax not remitted when due.

**Sec. 82-528. – Failure to pay or file- Penalties and interest.**

Failure to pay or remit the tax or to file the remittance return required by this Article shall be subject to the following penalties and interest:

- (a) Any tax not paid or remitted when due shall bear interest at the rate of two percent per month, or fraction thereof, until the tax is paid or remitted;
- (b) In addition to any interest charged, any person who fails to pay or to remit the tax when due shall be subject to a late penalty of ten (10%) percent of such tax;
- (c) In addition to any interest or penalty charged above, any person who fails to file a remittance return when due shall be subject to a late filing penalty of ten (10%) percent of the total tax liability due for the reporting period.

Where the failure to pay or to remit the tax or to file the remittance return, in a timely manner is due to reasonable cause beyond the control of the person charged with filing and paying the tax, the penalties described in subsections (b) and (c) may be waived by the City Clerk or Comptroller, as prescribed by ordinance.

**Sec. 82-529. – Recordkeeping.**

Every distributor and every retail dealer required to collect and remit the tax imposed herein shall keep accurate and complete books and records of his business of selling vehicle

fuel, including the maintenance of all invoices and other source documents. Every purchaser or user shall keep accurate and complete books and records of his purchases and uses of vehicle fuel in the City, including the maintenance of all invoices and other source documents. All books and records shall be subject to inspection by the City Clerk or Comptroller, as prescribed by ordinance, or duly authorized agents or employees thereof, at all times during regular business hours.

**Sec. 82-5210. – Sales and Uses Presumed Taxable - Burden of Proof.**

It shall be presumed that all sales and uses of vehicle fuel in the City are subject to tax under this Article until the contrary is established. The burden of proving that a sale or use is not taxable hereunder shall be upon the distributor, retail dealer, purchaser or user so claiming.

**Sec. 82-5211. – Exemptions.**

The tax imposed by this Article shall not apply to the following sales or uses of vehicle fuel:

- (a) Sale by a distributor to another distributor holding a valid registration certificate;
- (b) Sale by a distributor to a retailer of vehicle fuel whose place of business is outside the City;
- (c) Sale or use for purposes other than for propulsion or operation of a vehicle;
- (d) Sale to or use by any “transportation agency” as defined in the Regional Transportation Authority Act, which is operated by, receiving a grant from or has a service agreement with the Regional Transportation Authority or any of its service boards;
- (e) Sale or use to the extent the tax imposed by this Article would violate the Illinois or United States Constitution;
- (f) Sale to or use by the federal government or any state or local governmental



body;

- (g) Sale to or use by any air common carrier, certified by the carrier to be used for consumption, shipment or storage in the conduct of its business as an air common carrier, for a flight destined for a destination outside the United States

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

**ORDINANCE NO. 18- 30**

**AN ORDINANCE REQUIRING THE OWNERS, MANAGEMENT AND OPERATORS OF REGIONAL RETAIL SHOPPING MALLS TO ESTABLISH A PUBLIC SECURITY POLICY AND TO IMPLEMENT PUBLIC SAFETY REGULATIONS**

**WHEREAS**, the City of Calumet City, Cook County, Illinois (the "*City*") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "*Home Rule Powers*"); and

**WHEREAS**, the Mayor and the City Council of the City of Calumet City of Cook County (the "*Corporate Authorities*") have determined it to be necessary and in the best interests of the health, safety and welfare of the residents of the City to provide for minimum security regulations to be implemented by the owners, management and operators of any regional retail shopping mall (hereinafter "*mall*") located within the corporate limits of the City; and

**WHEREAS**, the Corporate Authorities have also determined it is necessary and in the best interests of the health, safety and welfare of the citizens and consumers who visit the mall, shop as customers of the mall and work at the retail establishments located in a mall for the owners, management and operators of the mall to provide and implement minimum security regulations and measures; and

**WHEREAS**, the Corporate Authorities consider it necessary to impose minimum security requirements because the owners, management and operators of the mall have failed and refused to do so even though security and safety measures are necessary to protect the public.

**NOW, THEREFORE**, be it ordained by the Corporate Authorities, by and through its Home Rule Powers, as follows:

**SECTION 1: INCORPORATION OF RECITALS.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**SECTION 2: DEFINITIONS.** A regional retail mall is one which has two or more main department stores and a minimum of twenty (20) smaller retail specialty shops.

**SECTION 3: TIME REQUIREMENT.** The owners, management and operators of all regional retail malls located within the corporate limits of Calumet City are required, within twenty-one (21) days of adoption of this Ordinance, to present a written security plan to the Chief of Police or his designee for approval.

**SECTION 4: SECURITY REQUIREMENT.** The security plan prepared by the owners, management and operators of all malls shall provide the following minimum requirements and crime prevention and security strategies:

A. Designate at a minimum three (3) employees of the mall who will be responsible to the Chief of Police or his designee concerning matters related to security matters and operations. The names, phone numbers and email addresses of these individuals, will be provided by mall management to the Chief of Police within twenty-one (21) days of the effective date of this Ordinance.

B. Provide properly uniformed security officers to patrol both the interior and exterior of the mall in well-marked vehicles.

C. The minimum number of security personnel during all hours the mall is open for business and for a minimum of two (2) hours before opening and two (2) hours after the mall is closed shall be as follows:

1. On all Mondays, Tuesdays, Wednesdays and Thursdays, a minimum of four (4) security officers per shift will be on duty. One of the officers working on each shift will be a supervisor who has working knowledge of the mall.

2. On all Fridays, Saturdays and Sundays, a minimum of six (6) security officers per shift will be on duty. One of the officers working in each shift will be a supervisor who has working knowledge of the mall.

3. On all days of the week, twenty-four (24) hours per day, Sunday through Saturdays, inclusive, a minimum of one (1) security officer in addition to those required in subparagraphs C(1) and C(2) will be employed to work in a marked security vehicle to patrol the exterior of the mall and parking area.

D. Records will be kept by the mall management on site in its office at the mall establishing compliance with the minimum security officer manpower requirements set forth in subparagraphs C(1), (2) and (3) above. These records will be made available for inspection and review by the Chief of Police or his designee upon forty-eight (48) hours email notice to one of the designated employees of mall management responsible to respond to the Chief of Police or his designee concerning matters related to mall security.

E. The security staff shall either be contract or in-house and may be augmented by off-duty sworn police officers.

F. Provide at the expense of the mall owners or mall management for a community policing kiosk or substation to be located in the mall in a public place and identified as being part of the City of Calumet City Police Department.

G. Provide adequate exterior lighting in all parking and exterior areas associated with the mall.

H. Provide limits on the hours of the day after which individuals under the age of 18 and unaccompanied by a parent or adult over the age of 25 will be admitted to the mall. These limits must be enforced by mall security personnel stationed at the public entrances to the mall.

I. A designated and properly authorized member of mall management will meet with the Chief of Police or his designee to develop and implement, within twenty-one (21) days of the effective date of this Ordinance, a Mall Youth Supervision Policy. This policy will include provisions establishing hours of the days after which individuals under the age of eighteen (18) years will not be allowed entrance into the mall unless accompanied by a parent or adult over the age of twenty-five (25). This policy will also include a plan for enforcement of its provisions by mall management and mall security.

**SECTION 5: WAIVER AND REVISION.** The owners, management or operators of the mall may petition the Public Safety Committee of the City Council to waive or revise any of the minimum requirements set forth in Section 4 above. The petition shall be in writing and set forth the reasons why implementation of the provision is not practical or too costly. Submission of a petition to waive or revise any of the requirements set forth in this Ordinance will not permit the petitioner to delay submission and

implementation of a security plan in compliance with the requirements of this Ordinance until a written waiver or permission for revision is authorized by the City Council.

**SECTION 6: PENALTY.** A person, firm, partnership, corporation, limited liability company, or any other entity failing to submit and implement a security plan including the minimum requirements and crime prevention and security strategies set forth in this Ordinance within twenty-one (21) days of its effective date shall be guilty of violating this Ordinance and will be subject to a mandatory fine of not less than Seven Hundred Fifty and no/100 (\$750.00) Dollars for each violation thereof. Each day a violation is determined to exist shall constitute a separate and distinct offense and violation of this Ordinance and will be subject to a separate fine of Seven Hundred Fifty and no/100 (\$750.00) Dollars.

**SECTION 7: ENFORCEMENT.** Proceedings to enforce violations of this Ordinance may be initiated and conducted in accordance with and pursuant to the provisions of the City Ordinance providing for Administrative Adjudication of Code Violations or by any other means provided by law.

**SECTION 8: SEVERABILITY.** The various portions of this Ordinance are hereby expressly declared to be severable and the invalidity of any section, paragraph, clause or provision of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

**SECTION 9: REPEALER.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**SECTION 10: EFFECTIVE DATE.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.




