

PARTICIPANT AUTHORIZATION AND RELEASE

_____ (“Participant”), Wm. J. Cassidy Tire & Auto Supply, LLC (“Cassidy Tire”), and the City of Calumet City, hereby agree to the following terms and conditions contained in this Participant Authorization and Release (“Agreement”):

As a result of an increase in the number of catalytic converters being stolen from vehicles, the City of Calumet City Police Department has created an initiative to allow residents of Calumet City to voluntarily mark their catalytic converters in the hopes of decreasing theft and in order to better track the sale of stolen auto parts.

Cassidy Tire has volunteered to provide services to allow the Calumet City Police Department to begin marking residents’ catalytic convertors.

Participant voluntarily wishes to participate in the Calumet City Police Department Program (“Program”) and agrees that any and all work related to the marking of catalytic converter by Cassidy Tire and its agents will be subject to the following terms and releases and in consideration of the services being performed by Cassidy Tire the parties agree as follows:

Participant hereby authorizes Cassidy Tire and its agents and the Calumet City Police Department to raise or lift Participant’s vehicle and take such actions as necessary to mark the catalytic convertor in accordance with directions from the Calumet Police Department including, but not limited to, the use of spray paint, numbering system, or such other markings as directed by the Calumet City Police Department.

Participant understands and acknowledges that this program is voluntary and Participant is not required to participate in any such program.

Participant hereby represents and warrants that Participant has the authority to enter into this Agreement and authorizes Cassidy Tire to perform the services described in this Agreement and such other services as necessary related to the Program.

Participant understands and acknowledges that participating in the Program does not guarantee the safety or security of the vehicle, the catalytic convertor or any other property and Participant releases, waives and relinquishes any and all claims, liabilities, damages, costs or suits against Cassidy Tire related to the theft of any catalytic convertor or vehicle of Participant.

Participant further understands and acknowledges that participating in the Program does not guarantee the safety or security of the vehicle, the catalytic convertor or any other property and Participant releases, waives and relinquishes any and all claims, liabilities, damages, costs or suits against the City of Calumet City related to the theft of any catalytic convertor or vehicle of Participant.

Participant understands that the lifting of any vehicle has inherent risk and Participant represents and warrants that he/she/they have identified any frame damage or such other damage that may increase the risk of further damage to the vehicle as a result of any lifting of the vehicle or performance of any services related to the Program. Participant hereby waives, releases and relinquishes any and all liability, claims, damages, suits, and costs against Cassidy Tire related to the lifting of Participant's vehicle and any resulting damage of any kind.

Participant further understands that the lifting of any vehicle has inherent risk and Participant represents and warrants that he/she/they have identified any frame damage or such other damage that may increase the risk of further damage to the vehicle as a result of any lifting of the vehicle or performance of any services related to the Program. Participant hereby waives, releases and relinquishes any and all liability, claims, damages, suits, and costs against the City of Calumet City related to the lifting of Participant's vehicle and any resulting damage of any kind.

Participant hereby waives, releases, and relinquishes any and all liability, claims, suits, damages, and costs against Cassidy Tire related to any services performed by Cassidy Tire for Participant related to the Program and related to Participant's vehicle.

Participant also waives, releases, and relinquishes any and all liability, claims, suits, damages, and costs against the City of Calumet City related to any services performed by the City of Calumet City for Participant related to the Program and related to Participant's vehicle.

Participant shall indemnify, defend, and hold Cassidy Tire harmless from and against any and all suits, claims, damages, costs, fees and liabilities related to the services performed by Cassidy Tire on Participant's vehicle in relation to the Program.

Participant shall also indemnify, defend, and hold the City of Calumet City harmless from and against any and all suits, claims, damages, costs, fees and liabilities related to the services performed by the City of Calumet City on Participant's vehicle in relation to the Program.

By signing this agreement, Participant certifies that they are 18 years of age or older and have the full authority and permission to authorize the services related to the Program to be performed and shall be bound by the terms of this Agreement.
