Chief of Police Report      Police Chief Kevin Kolosh gave a report regarding crime in the City of Calumet City for 2023.  
Chief Kolosh announced the number of Homicides decreased in 2023.  
Chief Kolosh reported there has been an increase in firearms retrieved from last year.  
Chief Kolosh announced that Domestic Violence reports and arrests have increased from 2022.  
Chief Kolosh reported car theft in the city has decreased and that the department is encouraging residents to use steering wheel locks.  
Chief Kolosh reported that retail theft has increased but the hope is to receive a \$60,000.00 grant that will help provide more cameras around the city.  
Chief Kolosh announced that the percentage of traffic stops has increased by 87%.  
Police Chief Kolosh concluded his report by informing the council that tickets have increased due to the amount of patrolling the officers are doing in the neighborhoods.


