
























UPDATES FROM CALUMET CITY ADMINISTRATION AND COUNCIL MEMBERS



ALDERMAN MICHAEL NAVERRETE 1ST WARD

ABOUT CALUMET CITY & THE 1ST WARD

Formerly known as the "Village of West Hammond," Calumet City has always made a name for itself in the region. Calumet City was shaped by memorable people such as the Schrum Family, who were among the first settlers; Faith Bailey, a nurse who was a crusader in public health; and, even by such figures as crime baron and beer overlord of the 1920's, Al Capone.

Calumet City also progressed in the areas of real estate, construction, public safety and industry. In the early 1900s, the population more than doubled and construction businesses could not keep pace with the demand for homes. Water mains and hydrants to supply water for domestic and fire protection were laid on nearly every street and wooden sidewalks were constructed. A second fire department was established in order to protect the entire Calumet City territory, and one of the greatest improvements was the construction of an electric light plant that was expanded to provide street and incandescent lighting.

After the great fire of 1901 that destroyed the only major industry in West Hammond at the time, the G.H. Hammond Meat Packing Plant, other industries had to step up to fill the economic gap left behind. Some of the businesses that helped the community recover included the Hirsch Stein Starch Company, Bernard J Burczyk's Printing Company and the West Hammond Brewing Company.

The 1st Ward is the eastern most part of the community, sharing a border with the State of Indiana. The Ward is home to the City Hall, Woodrow Wilson Elementary School, Wentworth Junior High School, Memorial Park, the Burnham Greenway, VFW Post 8141, Fire Station No. 1, and the former St. Victor Catholic Church. The Burnham Avenue corridor has long been known as the premier commercial corridor in town, and State Street is home to many long-standing industrial businesses. As Alderman of the 1st Ward, I am determined to

bring back the vibrancy of Burnham Avenue and continue to bring more business to State Street.

THE 1ST WARD VISION

Based on feedback from the Walk the Ward event, a vision was created for Calumet City's 1st Ward. The vision is written to be aspirational, narrating an ideal the community should strive towards over the long term based on the feedback of the community's goals and desires.

Over the next 20 years, Calumet City's 1st Ward will grow as a community that is welcoming and responsive to resident's needs. The City will proactively work towards addressing the community's priorities, including improving public safety, quality of and access to education, and public parks and open spaces. Sufficient funding will be allocated to priority services and departments to improve quality of life and the character of the Ward. This includes the Public Works and Infrastructure, Community and Economic Development, and Inspections and Code Enforcement departments.

Through a collaborative effort with local organizations, agencies, and residents, recent planning initiatives will come to fruition, including the Burnham and Memorial Drive intersection improvements, Burnham Avenue street reconfiguration, State Street Road diet, and Memorial Drive and Pulaski intersection improvement projects. St. Victor Church will be redeveloped or repurposed, possibly into a neighborhood resource center, such as a youth, senior rehab, job training, and/or community center. The 1st Ward will grow into a neighborhood where residents can live, work, shop, play, and relax, all within walking distance of their homes.



Burnham Avenue will thrive as the center of local businesses, offering a variety of shops, services, restaurants, and entertainment options. Existing neighborhood parks, like Memorial Park, will be modernized and programmed with new amenities for all ages. Opportunities for community gathering and socializing will also be promoted with new community events and enhanced public green spaces. Residents will be able to safely walk and bike to natural assets in the area, including the Burnham Greenway, Marsh Nature Preserve, and Sand Ridge Nature Preserve.

RECOMMENDATIONS AND NEXT STEPS

1. Develop a Master Plan for the St. Victor Site

The City, in conjunction with the Archdiocese of Chicago and the neighborhood, will begin to develop a master plan or a more broad subarea area plan to address redevelopment opportunities at St. Victor and the nearby intersection of Burnham Avenue and Memorial Drive. The plan will include the following:

Zoning Code Review and District Amendment

The Comprehensive Plan shows the St. Victor site as an "Institutional" land use. This land use category "encompasses the lands which benefit the public including properties owned by the federal, state, or local governments. Uses such as public or private schools, churches, and cemeteries are also included in this category. This land use category aligns with the existing zoning district as a "P: Public Land Use."

Nevertheless, the Walk the Ward event revealed a multitude of other land uses that the community wants for the site. The plan will analyze whether the existing zoning designation includes these desired uses, and if not, develop a strategy to amend the zoning code to enable the desired development.

Site Design

The plan will put forward the desired location and scale of future and preserved buildings, as well as parking, access drives, landscaping, general design. This subarea/master plan will include additional community input, so that appropriate zoning and infrastructure improvements can be implemented in a coordinated manner.

2. Prioritize improvements at the intersection of Burnham and Memorial. Walk the Ward participants noted this intersection as a priority project. It is a key destination with Cecina Mexican Restaurant located near the southeast corner.

Short term improvements include:

 Updating planters to beautify the intersection and provide separation from pedestrians and vehicles • Restriping the crosswalks to ensure they are highly visible

Long-term improvements include:

- Construction bump-out at Memorial Drive to decrease crossing distances and increase safety
- New development at the intersection through active marketing of the site and use of available incentives currently offered by the City

3. Prioritize the Burnham Avenue street reconfiguration

Walk the Ward participants identified Burnham Avenue as the place they want to go to eat, shop, and feel safer. It is the spine of the community and should be prioritized for infrastructure improvements to increase safety and help spur economic growth.

Brand Burnham Avenue

Developing a brand for Burnham Avenue will help to activate the roadway and stimulate renewed interest and placemaking as noted in the *Burnham Avenue Corridor Revitalization Plan*. Branding components may include:

- Updating and adding additional planters to beautify the corridor provide separation from pedestrians and vehicles
- Eye-catching gateway and wayfinding signage along Burnham Avenue
- Improved crosswalk markings, at a minimum at Memorial and Pulaski
- Use of the brand in all city communications materials
- Use of the brand by the Calumet City Chamber of Commerce to promote events and development
- Add the Burnham Avenue Reconfiguration Project to the City's Capital Improvement Program (CIP). The reconfiguration of Burnham Avenue as shown in Burnham Avenue Corridor Revitalization Plan should be included as part of the City's capital improvement program (CIP). Including this project in the CIP will allow for planning to secure local funding and plan for grant funding and match requirements. Funding sources may include the TIF II District for the northern portion of the corridor, as well as use of CDBG and MFT funds.

DOES SEWER WATER BACKUP IN YOUR BASEMENT?

Overhead Sewer Rebate Program

The City offers the Overhead Sewer Rebate Program to mitigate sewer back in your home. Here is how it works. The City of Calumet City will rebate a maximum of \$4,000.00 to the homeowner occupying the residence. Where all pre-approved completed installation of overhead sewer repairs or replacement of sewer traps, valves or waterproofing occurs.

The application process is as follows:

- 1. Homeowner must complete rebate application and submit it to the Department of Building and Zoning located at 670 Wentworth Ave.
- 2. Two written estimates from contractors are required with application.
- 3. An on-site inspection is required but the City's Plumbing Inspector to assure compatibility for overhead sewers prior to any work being done.
- 4. Permits must then be secured. All contractors must be licensed with the City of Calumet City.
- 5. Once work is completed, the property will be inspected to verify compliance with code complaints.
- 6. When all work and inspections are final, you must submit a paid in full receipt and all other corresponding paperwork to the Department of Building and Zoning to receive reimbursements. Please allow a minimum of 4 to 6 weeks for processing.



STOP THE BLEED

The STOP THE BLEED project is a public/private collaboration involving a wide range of non-profit organizations, government agencies, companies and individuals working to create more public awareness of the STOP THE BLEED campaign and the importance of learning how to stop traumatic bleeding.

The STOP THE BLEED course, will teach you three quick techniques to help save a life before someone bleeds out:

- 1. How to use your hands to apply pressure to a wound
- 2. How to pack a wound to control bleeding
- 3. How to correctly apply a tourniquet


WATER DEPARTMENT

It was created back in 1992 by Officer Tim Zehring of the Mesa, Arizona Police Department. This program has endured many legal challenges for a variety of reasons, which has required modifications over its 30+ years of existence, yet this program is still around because of its success! Calumet City's program was implemented in 2010 and was recently updated with the creation of the Crime Free Housing Department in 2022.

We help educate landlords mainly on managerial matters, such as background checks, Fair Housing compliance, and effective verbiage for lease agreements. Landlords are required to attend the latest in-person training (from 2022 to current) as their first matter of compliance to the City's Ordinance. Landlords needing to get the training completed should look over these upcoming dates & times, and reserve a spot(s) by submitting a registration form on the Crime Free Housing Department page at www.calumetcity.org.

CALUMET CITY FAIR HOUSING

Calumet City's Fair Housing Administration works closely with the Crime Free Housing Department and the Building & Zoning Department. We strive to provide assistance to citizens currently living in Calumet City, and those wanting to call Calumet City home, in resolving any possible, or actual, discriminatory actions.

With the 2024 calendar year underway, we remind everyone about new Fair Housing laws that are in place:

 The Illinois Landlord and Tenant Act has been amended to add a new section entitled, "Ban on Electronic funds Transfers as Exclusive Method of Payment" (765 ILCS 705/4). This prohibits landlords from requiring tenants to use electronic funds transfers (EFT), or similar electronic methods, as the only means of paying rent or other rentrelated payments.

- The Illinois Human Rights Act has been amended to add "Immigration Status" to the current list of protected classes within the State. This protection still allows a landlord to request documentation for citizenship as a means of confirming a person's identification. However, the restriction is based upon any discrimination due to an individual's real or assumed citizenship or immigration status (i.e. refusing to rent to someone because they are not able to provide documentation of legal citizenship).
- The Illinois Electric Vehicle Charging Act (765 ILCS 1085) was created to address the emergence in popularity of vehicles that require battery charging stations at their home. The Act affects both residential and commercial properties and has information for new single-family homes and multi-unit residential buildings, but it also addresses properties that undergo renovation after January 1, 2024. The responsibility for getting code-compliant charging stations, and who pays for them, are outlined in this act.

Calumet City Ordinance #21-25 requires property owners, or responsible parties from the banking world, to register their vacant or foreclosing property. The registration process is conducted with our approved vendor, MuniReg, LLC (www.munireg.com), and the program is monitored through the Crime Free Housing Department.

Vacant properties are a blight to any community and can lead to an increase of criminal opportunities and lower property values. It is the intention of Calumet City's Administration to revitalize our neighborhoods by getting these properties cleaned up, renovated to current building codes, and once again legally occupied.

These efforts will directly impact the quality of life for Calumet City residents, and we hope to see improvements come quickly. Please understand that some properties require lengthy legal action before our goals can be obtained. If you have a vacant property on your block, please notify the Mayor's Office, your Alderman, or any Calumet City Department to provide the exact address of the affected property.



As the Spring season approaches and temperatures begin to rise, two offer the following safety tips:

KEEP YOUR PROPERTY SECURE

- Check all windows and doors. Make sure all entry points have updated locks and keep everything locked when you're away even just for a few minutes.
- Trim overgrown bushes and trees around your home.
- Keep lights on while you are away to keep your house from looking empty. If you are going to be away for a long time, ask a neighbor to accept your mail.
- Consider installing an alarm system / security cameras
- Keep your vehicle secure. Lock the doors, close the windows, and keep valuables out of sight.

MAKE SURE YOUR DIGITAL INFO IS PROTECTED

- Password protect all devices, including cell phones and tablets, with unique passwords.
- Be aware of what you post on social media sometimes addresses, locations, or other personal information appear on photos by accident.
- If you are posting sensitive information such as photos of your children, vacation itineraries, etc., make sure that your privacy settings are all up to date.
- Talk to your kids often about what they are doing online, who they are communicating with, and what information they can share.

TRAFFIC SAFETY

- Slow down and obey all traffic laws.
- Be extra vigilant of pedestrians and children playing outdoors. The warmer weather will bring more people outdoors walking, jogging, and biking.
- When biking, wear bright colored or reflective clothing and ensure your bike has reflective equipment.

INTERNATIONAL WOMEN'S DAY

In 1977, when the women who would establish the National Women's History Alliance began planning a women's history week, March 8th, International Women's Day, was chosen as the focal date.

The selection was based on wanting to ensure that the celebration of women's history would include a multicultural perspective, an international connection between and among all women, and the recognition of women as significant in the paid workforce.

United States women's history became the primary focus of the curriculum and resources developed. At that time, there were no school districts in the country teaching women's history. The goal, although it most often seemed a dream, was to first impact the local schools, then the nation, and finally the world. It is a dream that is becoming a reality. Women's History Week, always the week that included March 8th, became National Women's History Week in 1981 and in 1987 National Women's History Week became National Women's History Month. The expansion from local to national and from week to month was the result of a lobbying effort that included hundreds of individuals and dozens of women's, educational, and historical organizations. It was an effort mobilized and spearheaded by the National Women's History Alliance.

National Women's History Month is now recognized throughout the world. Women from Germany, China, Saudi Arabia, Canada, Japan, Russia, the Ukraine, and diverse African nations have visited the National Women's History Alliance's office or attended their events. One result from this contact has been the establishment of a women's history program and museum in the Ukraine. 1989 The National Women's History Alliance accepted an invitation from the government of Spain to address an international women's conference on the importance of women's history and the impact of National Women's History Month. In 2001 a sistership with the Working Women's Institute of Japan was established resulting in the National Women's History's posters and display sets being featured in the organizations first exhibit.

The National Women's History Alliance's website reaches the global community. They receive emails from individuals throughout the world. Each year hundreds of National Women's History Month posters are distributed to military bases and Department of Defense schools throughout the world for special programs and events that celebrate and recognize women's accomplishments. It is the hope of the National Women's History Alliance that the celebrations at these different venues will ignite a sense of celebration and recognition that honors women of all nations.

CALUMET CITY OBSERVES CASIMIR PULASKI DAY MONDAY, MARCH 4, 2024

Casimir Pulaski Day is a local holiday officially observed in Illinois, on the first Monday of March in memory of Casimir Pulaski (March 6, 1745 – October 11, 1779), a Revolutionary War cavalry officer born in Poland as Kazimierz Pulaski.

Born in Poland around 1745 to 1747, Casimir Pulaski was the son of a Polish count who became a professional soldier early in life. Pulaski came of age when the partitions of Poland by its autocratic neighbors were in response to the desire for rights and protections for non-land holders to be codified into law by the Polish government. This resulted in the introduction of the Polish May 3rd Constitution (the second oldest democratic constitution in the world modeled after -and second only to - our American Constitution) that gave substantial rights and protections to commoners.

The Russian, Austro-Hungarian, and Prussian empires feared such measures that basically eliminated serfdom (the condition of a tenant farmer bound to a hereditary plot of land and to the will of a landlord) would spread to their countries, so they began to take lands belonging to the Polish-Lithuanian Commonwealth diminishing what was the largest and most populous European Kingdom of the 16th and 17th centuries. It's important to note that the rights that were granted by the Polish Constitution included significant religious freedoms which resulted in a major population shift in Europe. Jews at this time were persecuted in much of the European continent. That is why Poland had the largest Jewish population in Europe by the time of the outbreak of the second world war.

In 1768, Pulaski's father, Józef, joined in an insurrection known as the Confederation of Bar, and became the military leader of the confederation. Casimir Pulaski also participated in the uprising, commanding a military detachment that battled Russian forces for nearly four years. His father died in the struggle against the First Partition of Poland in 1773. The younger Pulaski only escaped death by fleeing first to Turkey and then to France.

In Paris, he met Benjamin Franklin, then attempting to negotiate an alliance between France and the United States, and won his friendship. Noting the young Polish soldier's experience as a military officer, Franklin urged Pulaski to join George Washington's Continental Army as a volunteer and provided him with a letter of introduction. Washington quickly assigned Pulaski to the cavalry following his arrival in July 1777. During the Battle of Brandywine, his first military action in the American Revolution, Pulaski served General George Washington as part of his personal bodyguard and gathered battlefield intelligence. Immediately after the engagement, he was promoted to brigadier general and given command of the small force of Continental cavalry. He was indeed a great soldier and leader.

Pulaski went on to play a significant role in the military during the American Revolution. His experience and valor earned him the command of his own cavalry unit. Pulaski's establishment of this Cavalry (much at his own personal expense) earned him the title "Father of the American Cavalry" and one of only eight persons ever to be granted honorary American citizenship along with other notables such as Sir Winston Churchill and Mother Theresa.

With his calvary, in 1779, Pulaski journeyed to South Carolina to help defend the southern Continental Army, which was under fierce attack from the British. After participating in a successful defense of Charleston, South Carolina, Pulaski was mortally wounded in the siege of Savannah and died on October 11, 1779. In his first letter to General George Washington, after arriving in America, Pulaski had written, "I came here, where freedom is being defended, to serve it, and to live or die for it."

LITTLE KNOWN FACTS ABOUT KASIMIR PULASKI - DID YOU KNOW?

- Pulaski's real name is Kazimierz Michal Wladyslaw Wiktor Pulaski
- When many of his comrades' owned slaves, he did not and refused to do so.
- Pulaski's countryman, Thaddeus Kosciusko, left all his American holdings to be sold off and used to buy freedom of slaves and educate former slaves.
- The executor of Kosciusko's estate was Thomas Jefferson who never got around to fulfilling Kosciusko's will.
- Everyone knows Benedict Arnold! The papers that Arnold gave the British that labeled him a traitor were Kosciusko's plans for the fortifications at West Point that would strengthen West Point against attack.

Calumet City commemorates General Pulaski's heroism and service, and honors generations of immigrants who followed in his path – as we also celebrate our Nation's rich Polish American heritage. Every day, the contributions of over 9 million Polish Americans help make this country a beacon of hope and opportunity. And, for those who may wonder, because it was a time of slavery, Casimir Pulaski "did not own slaves"! He was very much a believer in freedom of humanity... he thought all people should be free." This community is proud to observe Casimir Pulaski Day!

SPRING FLOODING PREVENTION

If you are experiencing flooding the City of Calumet City and the Calumet City Public Library are here to help.

- To find out if you are in the floodplain call the Department of Inspectional Services at (708) 891-8120 or go to the Adult Services desk at the library and look at the Flood Insurance Rate Maps.
- An Elevation Certificate records the lowest floor elevation of a structure and is prepared by a licensed professional Land Surveyor or Civil Engineer. If the elevation of a structure is shown to be above the Base Flood Elevation (BFE) in the Special Flood Hazard Area, the owner may apply for a Letter of Map Revision from FEMA in order to be removed from the Special Flood Hazard Area. Elevation certificates are available to the public for review at The Department of Inspectional Services at (708) 891-8120. Please note: if any alteration to the structure has taken place, such as a window or door at ground level, a new Certificate of Elevation will need to be obtained.
- For advice on how to protect your home call the Dept. of Inspectional Services at (708) 891-8120 or visit the library and look at information on floodproofing and property protection. The library has the Homeowner's Guide to Retrofitting: Six Ways to Protect Your House from Flooding (FEMA publication 312). You can also download a copy from FEMA's website by searching for FEMA 312.
- For more info visit www.calumetcity.org and select Flood Info
- To learn more about staying safe before and during a flood, visit FloodSmart.gov.
- Contact your insurance agent and ask about getting a flood insurance policy. Flood insurance is available to everyone, and the rates are lower if you are outside of the mapped floodplain.
- Always check with the Department of Inspectional Services before you build on, fill, alter, or regrade your property. A permit is needed to ensure that such projects do not cause problems with other properties.
- If you are experiencing sewer backups or have connections of sump pumps or downspouts into the sanitary sewers you may be eligible for the City's Overhead Sewer and Sump Pump Flood Assistance Rebate Program. Applications are available at the Inspectional Services Department.
- If you have experienced flooding and would like assistance or tips to reduce future flooding the Department of Inspectional Services can provide help by visiting your property to perform a drainage assessment. For information call (708) 891-8120.
- Keep storm drain inlets clear of debris and leaves. If you see dumping or debris in ditches, filling or construction near property lines or filling or construction in the floodplain without a permit sign posted us. Dumping in our ditches and stormwater basins is a violation of the City Code.




