Director Celmer discusses the upgrades of the radio system in the 9-1-1 center, as well as for the main radio equipment.

Radios were last upgraded in 2016. Kolosh advised that he put together a committee of Celmer, Supervisor Astor, Siems to work on getting information for what this upgrade would entail. Bachert advised he would also join the committee. Celmer advised meeting with Chicago Communications on January 11, 2024, and would see what options are available.
