Discussion of

Severe Weather

Mayor Jones reported regarding the recent flood. Mayor Jones stated here was 11.5 inches of rain in Calumet City in two hours. Several roads and expressways were closed due to the flood. Mayor Jones also reported Fire and Police Departments rescued residents who were stuck in their homes and cars. Wes' Towing pulled vehicles from the flooded streets.

City

Assistance

Mayor Jones stated he will inquire with the governor about declaring the September 17, 2023 storm a natural disaster this will allow the city to apply Federal funds and the residents will be to apply for FEMA assistance. Mayor Jones reported the City will apply for SBA Assistance so that the Council will be able to aid the residents. Mayor Jones reported he will issue an Executive Order declaring the

September 17, 2023 storm a Disaster.

Mayor Jones went on to say that this will allow Calumet

City to be able to apply for Cook County funds. Mayor Jones stated that

the City will apply for America Rescue Plan Act (ARPA) funds.

Pump Stations

Mayor Jones reported the water/ sewer system is 100 years old and it is very expensive to fix. Mayor Jones referenced the 2022 Bond meeting

were the council discussed funds being used from the bond for the water and sewer system.

Mayor Jones informed the Council that the City has restored about 46 homes and currently is working with 2 companies that have agreed to keep the cost low. In order to continue to restore homes the council would have to agree to use ARPA (American Rescue Plan Act) funds. The estimated cost to continue to restore homes in Calumet City would be \$9,000.00 per house.

Sewer Rehabilitation

There was a detailed discussion about the pump stations and the percentage the pumps were operating at. Mayor Jones will provide a report to the Aldermen showing the functionality of the pump stations from the City Engineer. Treasurer Tarka suggested speaking with the Metropolitan Water Reclamation District (MWRD) to obtain a report on the Deep Tunnel Project.

Alderwoman Wilson informed the council of streets and sewers that she has reported from her ward that have been having issues are the same streets that caved.

The council discussed how to assist residents and how flood and sewer insurance will determine the amount of assistance the city will provide. Mayor Jones reported that restoration assistance the city would provide will be for the underinsured residents that are not covered for sewer back up. The restoration project would not provide assistance for business owners or landlords of apartment buildings.

Finance Director John Kasperek

Finance Director Kasperek spoke about an application process which would include a maximum cap for assistance; the application will available online and at City hall.

Mayor Jones

Mayor Jones advised that the funds will be given to the Restoration companies and not to the residents. Currently the city is using a company by the name of Restore to do the work. Resident will need to provide proof of lack of coverage and damages.
