RESOLUTION NUMBER: 22-33

Whereas, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers");

Whereas, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") have determined that significant residential community interests are served by providing the Calumet City Residential Assistance Program (CC-RAP) under the American Rescue Plan Act (ARPA);

Whereas, The CC-RAP is designed to help improve/enhance quality of life for residents who live within the corporate boundaries of Calumet City and to ensure their sustainability within their homes;

Whereas, eligible residents for *CC-RAP* may only utilize funds for expenses (resulting from the Covid Pandemic) relative to property in which they live;

Whereas, eligible spending may be used for property rehabilitation, appliance purchases, past due property taxes, past-due utility bills, and other associated property costs – not to exceed \$500.00:

Whereas, eligible residents must show need based on application criteria and documents requested; and

Whereas, it is now the desire of the Corporate Authorities to formally establish the policies and practices of the *Mayor's Residential Assistance Program*.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

- Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.
- Section 2. The CC-RAP criteria, as contained within this Resolution, is hereby approved as the policy and practices of the CC-RAP, with such necessary changes as determined by the City Council to effectively operate and manage the CC-RAP.
- Section 3. The officials and officers of the City are hereby authorized and directed to take any and all such action as is required to enact the CC-RAP and carry out its intent and purpose.
- Section 4. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.
- Section 5. All ordinances, resolutions, motions, or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

A RESOLUTION RECOGNIZING THE MEN AND WOMEN OF THE CALUMET CITY FIRE DEPARTMENT AND POLICE DEPARTMENTS FOR THEIR BRAVERY DURING THE PARK OF RIVER OAKS FIRE

WHEREAS, on May 30, 2022 Calumet City firefighters, paramedics and police responded to the Park of River Oaks condominiums in Calumet City and encountered "heavy fire" coming from a second-floor unit at the rear of the building, with the fire extending to the seventh floor; and

WHEREAS, at the time of the fire, winds from the south were gusting over 30 MPH. The winds drove the flames all the way to the seventh floor; and

WHEREAS, several people had to be rescued from the building using ladder trucks; and WHEREAS, four residents and three firefighters were transported to local hospitals with non-life-threatening injuries. One resident died in the fire; and

WHEREAS, the loss of life would have been much higher were it not for the bravery of the City of Calumet City fire and police departments; and

NOW, THEREFORE BE IT RESOLVED Mayor and City Council of the City of Calumet City that:

Section 1: The above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2: The City Council hereby recognizes the men and women of the Calumet City Fire Department and Police Department for their bravery during the Park of River Oaks fire.

Section 3: If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

A RESOLUTION TO FEDERAL OFFICIALS TO CONSIDER PASSAGE OF UNIVERSAL BACKGROUND CHECKS

WHEREAS, individuals with guns injure more than 100,000 people a year and kill more than 30,000 a year including through homicides, suicides, and accidental deaths; and

WHEREAS far more Americans have been killed with guns in the U.S. than have died in all our wars combined; and

WHEREAS, there have been at least 246 mass shootings in the United States through June 5 this year and in 2021 there were 692 mass shootings;

WHEREAS, under current federal law, background checks are only required when the seller is a licensed dealer. Federal law does not require an unlicensed or private gun dealer to run a background check before selling a gun; and

WHEREAS, background checks are an essential tool to keep guns from getting into the hands of individuals who might use a gun to harm themselves or others.

NOW, THEREFORE BE IT RESOLVED Mayor and City Council of the City of Calumet City that:

- Section 1: The above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.
- Section 2: The City Council hereby encourages the United States Congress to pass a bill requiring universal background checks for the sale of all guns.
- Section 3: If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.
- Section 4: All ordinances, resolutions, motions, or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 5: This Resolution shall be in full force and effect upon its passage, approval, and publication as provided by law.

A RESOLUTION RECOGNIZING JUNE AS NATIONAL GUN VIOLENCE PREVENTION MONTH

WHEREAS, the City of Calumet City recognizes June as National Gun Violence Prevention Month and declares that we as a country must do more to reduce gun violence in the United States; and

WHEREAS, an average of 124 people died each day from gun violence in the United States; and

WHEREAS, according to the US Centers for Disease Control and Prevention ("CDC"), a total of 45,222 people died from gun-related injuries during 2020; and

WHEREAS, in 2020, guns were the leading cause of death among children; and

WHEREAS, there have been at least 246 mass shootings in the United States through June 5 this year. There were 692 mass shootings in the United States in 2021; and

ORDINANCE NO. 22-11

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF CHAPTER 90, ARTICLE V, DIVISION 1 OF THE MUNICIPAL CODE OF CALUMET CITY, COOK COUNTY, ILLINOIS GOVERNING HANDICAP PARKING

WHEREAS, Calumet City is an Illinois home rule unit of local government with authority to legislate in matters concerning its local government and affairs; and

WHEREAS, the Council approved certain petitions for handicap parking spaces and desires to designate certain locations as handicap parking only;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of Calumet City, Cook County, Illinois, as follows:

Section 1. That Chapter 90, Article V, Division 1, Section 90-317 (g) of the Calumet City Municipal Code is hereby amended to add the underlined text and locations as indicated:

Sec. 90-317. Handicapped parking.

(g) Signed areas. The following areas are hereby designated as restricted handicapped parking areas by the city council, and appropriate signs shall be posted clearly indicating such areas:

341 Luella Ave

Section 2: Superseder. In the event a conflict exists between the terms of this Ordinance and any other ordinance or resolution of the City, the terms of this Ordinance shall govern.

<u>Section 3:</u> <u>Severability.</u> This Ordinance and every provision thereof shall be considered severable and the invalidity of any section clause, paragraph, sentence or provision of this Ordinance will not affect the validity of any other portion of this Ordinance.

Section 4: Effective Date. This Ordinance shall be in full force and effect upon its passage and publication in pamphlet form, in accordance with law, and the provisions of the Calumet City's Municipal Code amended herein shall be reprinted with the changes.
