## A RESOLUTION APPROVING AND AUTHORIZING EXECUTION OF AN INTERGOVERNMENTAL AGREEMENT WITH COOK COUNTY CONCERNING RIVERSIDE DRIVE IMPROVEMENTS

WHEREAS, the City of Calumet City ("City") is a home rule municipality located in Cook County, Illinois; and

WHEREAS, Cook County ("County") is an Illinois home rule county located in the State of Illinois; and

WHEREAS, the City is authorized to contract and be contracted with (65 ILCS 5/2-2-12); and

WHEREAS, to protect the public investment in the highway system and provide a safe, efficient and sustainable highway for its residents, the City desires to enter into an Intergovernmental Agreement ("Agreement") with the County (collectively "Parties"), which is attached and made part of this Resolution as Exhibit A; and

WHEREAS, the City is authorized to enter into this Agreement by virtue of its home rule powers, as well as pursuant to Article VII, Section 10 of the Illinois Constitution, and by the provisions of the Illinois Governmental Cooperation Act (5 ILCS 220/1 et seq.); and

WHEREAS, the Mayor and City Council hereby find and determine that (a) it is in the City's best interests to approve the Agreement, and (b) approving the Agreement will advance the City's interests and promote the public health, safety, and welfare.

NOW, THEREFORE, BE IT RESOLVED by the City Council for the City of Calumet City, Cook County, Illinois, as follows:

Section 1. The foregoing recitals are incorporated as the findings of the City Council and, together with this Resolution's exhibits, are hereby incorporated into and made a part of this Resolution.

Section 2. The Agreement is hereby approved, and the Mayor and City Clerk are authorized and directed to execute the Agreement on the City's behalf.

<u>Section 3.</u> The Mayor or their designee is authorized and directed to take all steps necessary to implement and enforce the Agreement's terms.

<u>Section 4.</u> All ordinances, resolutions, or parts thereof in conflict with this Resolution are repealed to the extent of any such conflict.

<u>Section 5.</u> Any section or provision of this Resolution that is found to be invalid or void shall not affect the remaining sections or provisions of this Resolution, which shall remain in full force and effect.

<u>Section 6</u>. This Resolution shall be in full force and effect upon its passage, approval, and publication in pamphlet form in the manner provided by law.
