Collections and Business Report By Cleo Jones Collections Manager Cleo Jones gave a report on the collections efforts that he has made in 2023. Manager Jones reported that as today the Clerks office has collected millions and millions of dollars in delinquent taxes. Businesses can start submitting their 2024 applications for their license on November 01, 2023. Manager Jones gave a list of requirements for a business to be issued a license and maintain that license. Manager Jones reported that over 40 million dollars in delinquent taxes has been collected.

The Aldermen will receive a spreadsheet that highlights the businesses in their wards. Manager Jones informed the council of a Share point file where the council will have access to the businesses in their wards.

Recovery Efforts
Report from
Chief Bendinelli

Assistant Chief Bendinelli reported on the timeline of events from the September 17, 2023 flood event. Assistant Chief Bendinelli immediately contacted the county and started the process of getting Calumet City's flood deemed as a natural disaster. their damages. There has been 1451 residents who completed the damage assessment form. The damage assessment form was created by IT Megan Wilson and Assistant Chief Bendinelli for the residents to document damages. On September 20, 2023 the council voted to assist residents by using one million dollars of the American Rescue Plan Act funds (ARPA) for restoration and recovery. The American Red Cross distributed kits to aid residents in cleaning their homes. On October 04, 2023 Cook County declared the flood event a disaster. Between October 11, 2023 and October 17, 2023 the county and FEMA walked calumet city neighborhoods and knocked on residents doors to get an account of the damages. It was documented that 499 homes sustained damages. Due to the ARPA funds the city has been able to complete 43 homes. Assistant Chief

Bendinelli recommended that residents be educated on homeowners insurance.

There was a brief discussion regarding reimbursement for residents that paid out of pocket for repairs.

Assistant Chief Bendinelli informed the council of the difference between the SBA Loan and the FEMA grant.

There was a brief discussion regarding the invoices that came in over the \$9,000.00 maximum the council agreed upon.

Alderman Navarrete motioned for discussion regarding reimbursing residents that have already paid for repairs. The Council decided that the last day to apply for with the city will be October 31, 2023.
