A Special Meeting has been called for Friday, June 24, 2016 at 5:00 p.m. The purpose of the meeting is for consideration of and possible passage of the following resolutions:

- 1) Resolution placing referendum question on the November 8, 2016 General Election ballot "Shall the City of Calumet City allow taverns (bars) to remain open until 2:00 a.m. on Fridays and Saturdays".
- 2) Resolution placing referendum question on the November 8, 2016 General Election ballot "Shall any Calumet City elected official be able to receive two (2) pensions by being allowed to participate in the Illinois Municipal Retirement Fund if they are a member of the Illinois General Assembly Retirement System".
- 3) Resolution placing a binding referendum question on the November 8, 2016 General Election ballot "Shall the City of Calumet City, Cook County, Illinois, adopt the following term limits for the Office of Mayor to be effective for and applicable to all persons who are candidates for Mayor being elected at the Consolidated Election to be held on April 4, 2017, and subsequent elections: Mayor – No person shall be eligible to seek election to, or hold the office of mayor where that person has held the elected office of either mayor or alderman of the City of Calumet City for four (4) consecutive full four (4) year terms. All prior consecutive terms of a current officeholder as either alderman or mayor shall be considered in the determination of eligibility".

No business may be transacted other than the topics set forth above.
