Ald. Jones - budget

Alderman Jones: "On July 29, 2014 we passed a budget in this city council. I would like to make a statement. It kind of disappoints me that we had no residents present to hear the revenues and the expenses of the city council. No residents showed up for the public forum and no residents showed up for the budget hearing which is disappointing.

I think it is incumbent on us to make sure that we get people to understand what we do with our budget. I voted against the budget. This is the second budget in my 18 years on this city council that I voted against. I voted against the budget for two reasons. We have almost 35 million dollars in revenue and probably 34.9 million dollars in expenses. To say that this budget is a balance budget when we have a surplus of \$70,000 dollars is not a balanced budget.

I also voted against this budget because it took out Neighborhood Development funds; community funds for residents. Also it did not include summer employment for our youth. Any budget that doesn't include money for Neighborhood Development Programs or money for our youth, I voted against. I make on that record that I voted against that budget. I don't feel like there was a budget that we should have passed.

I hope that we can do more and I just want to make sure that our residents are aware that it is time that everyone get involved in learning the expenses and revenues of this city and what we spend money on. Hopefully, throughout this year, I will make sure we get more people involved in learning what our budget is.

The next item is I would like to thank Alderman Williams. We had the 3rd and 4th Ward Community Cookout which was held this past Saturday, August 9, 2014. We had many sponsors who came through. Not only Coca Cola. We had Frito Lay and Johnny's Barbeque who not only did the food for the residents but featured his specialty barbeque sauce. We want to thank the residents who came out and everyone who participated in giving out the school supplies.

I am sure that Alderman Williams will mention the list of people who not only supported this event but also the people who came out and helped the residents.

AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

305-156th Place

1641 Downs Drive

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

AN ORDINANCE AUTHORIZING A SITE AGREEMENT SITE ID #CH25XC900 BY AND BETWEEN SPRINTCOM, INC. AND THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS FOR THE INSTALLATION OF A CELL TOWER AT 96 RIVER OAKS CENTER, IN THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the SprintCom, Inc. desires to lease certain property, commonly known as 96 River Oaks Center, Calumet City, Illinois 60409, from the City for the installation of a cell tower for a four (5) year term at a base rent of two thousand two hundred fifty dollars (\$2,250.00) payable monthly, (the "Site Agreement"), a copy of which is attached hereto and made a part hereof as Exhibit A, in accordance with the terms and conditions therein specified; and

WHEREAS, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") deem it advisable and in the best interest of the health, safety and welfare of the residents of the City to enter into the Site Agreement.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Site Agreement by and between SprintCom, Inc. and the City of Calumet City, a copy of which is attached hereto and made a part hereof as Exhibit A, is hereby

approved substantially in the form presented to this City Council, with such necessary changes as determined by either the City Attorney or the Mayor, said revisions being approved by execution and delivery of such Agreement by the Mayor.

- Section 3. The Mayor is hereby authorized and directed to execute and deliver the Site Agreement and any and all other documents necessary to implement the provisions, terms and conditions thereof, as therein described.
- Section 4. The officials and officers of the City are hereby authorized to undertake actions on the part of the City as contained in the Site Agreement to complete satisfaction of the provisions, terms or conditions stated therein.
- Section 5. The City Engineer is hereby authorized to review all necessary documents or inspect the necessary premises to ensure that the City's water tower can withstand any alterations that will result from the Site Agreement.
- Section 6. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- Section 7. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 8**. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
