





WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the President and Board of Commissioners of the County of Cook have enacted an ordinance known as the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Classification Ordinance"), which provides for a tax assessment incentive classification designed to encourage development throughout Cook County by offering a real estate tax incentive for the development of new facilities, the rehabilitation of existing structures and the utilization of abandoned buildings in order to create employment opportunities and expand the tax base; and

WHEREAS, Sibley Cal City Property Group, LLC (the "Sibley Property Group") is the owner of a certain parcel of property within the City commonly known as 1236-1250 E. 147<sup>th</sup> Street, Calumet City, Illinois which is on the north side of Sibley Boulevard between Manistee and Muskegon, identified by certain permanent index numbers (PINs) and hereinafter legally described on Exhibit A, a copy of which is attached hereto and made a part hereof (the "Property"); and

WHEREAS, Sibley Property Group has requested that the Mayor and City Council of the

City of Calumet City (the "Corporate Authorities") support and consent to the Cook County Class 8 Real Estate Tax Assessment Classification for the Property, as said term is defined in the Classification Ordinance (the "Class 8 Tax Assessment Classification); and

WHEREAS, the adoption of a resolution by the Corporate Authorities is required and must be filed by Sibley Property Group with its application with the County of Cook in order for the Property to receive the Class 8 Tax Assessment Classification; and

WHEREAS, Sibley Property Group is proposing to construct a kidney dialysis center which would employ approximately 25 full time persons, all of which is dependent on the approval and grant of the Class 8 Tax Assessment Classification; and

WHEREAS, to ensure the viability of the facility, the establishment of numerous employment positions in the City and to safeguard the tax base of the City, the Corporate Authorities have determined that it is necessary and in the best interests of the City to approve the Class 8 Real Estate Tax Assessment Classification for the Property for the redevelopment and revitalization of the Property, pursuant to the Classification Ordinance.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1**. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

The Corporate Authorities find that the proposed redevelopment contemplated herein for the Property is necessary and appropriate and that without a Class 8 Tax Assessment Classification the Property will remain vacant and underutilized and cause the continued exasperation of blighted factors within the area surrounding the Property.

### AN ORDINANCE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS, CLOSING THE CITY OF CALUMET CITY MARBLE STREET TAX INCREMENT REDEVELOPMENT PROJECT AREA SPECIAL TAX ALLOCATION FUND

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City"), is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State, and as a home rule unit may, under the powers granted by Section 6(a) of Article VII of the Constitution of the State of Illinois of 1970, "exercise any power and perform any function pertaining to its government and affairs"; and,

WHEREAS, pursuant to the Tax Increment Allocation Redevelopment Act of the State of Illinois, 65 ILCS 5/11-74.4-1 et seq., as from time to time amended (the "TIF Act"), the Mayor and City Council of the City (the "Corporate Authorities") are empowered to undertake the development or redevelopment of a designated area within the municipal boundaries of the City in which existing conditions permit such area to be classified as a "blighted area" as defined in Section 11.74.4-3(a) of the TIF Act; and,"

WHEREAS, the Corporate Authorities, pursuant to Ordinance No. 07-24, passed on April 12, 2007, did heretofore approve a redevelopment plan and redevelopment project; pursuant to Ordinance No. 07-25, passed on April 12, 2007; designated a "redevelopment project area" known as the "Marble Street Redevelopment Project Area" (the "Project Area"); and, pursuant to Ordinance No. 07-26 passed on April 12, 2007; adopted tax increment allocation financing for the Project Area and established the City of Calumet City Marble Street Tax Increment Redevelopment Project Area Special Tax Allocation Account (the "Special Tax Allocation Fund"), all in accordance with the TIF Act; and,

WHEREAS, certain costs were incurred by the City to establish the Project Area and to work on certain development proposals which were never constructed in the amount of \$83,411.38; and,

WHEREAS, the Corporate Authorities determined it to be in the best interests of the City that the Project Area be terminated and pursuant to Ordinance No. 14-64 adopted by the Corporate Authorities on December 22, 2014, terminated the designation of the Project Area as a Redevelopment Project Area pursuant to the TIF Act; and,

WHEREAS, the Project Area is contiguous to the State Street Redevelopment Project Area designated December 21, 1994 (the "State Street TIF") which currently has a balance of funds which may be transferred to the Marble Street Special Tax Allocation Fund as established Ordinance No. 07-26 in order to reimburse the City for the costs incurred in connection with the establishment of the Project Area and related activities; and,

WHEREAS, the Corporate Authorities deem it to be in the best interest of the City to make a transfer of \$83,411.38 from the State Street TIF to the Marble Street Special Tax Allocation Fund for the purpose of reimbursing the City for costs incurred all as hereinafter set forth.

**NOW, THEREFORE BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. The Incorporation of Preambles. The Corporate Authorities hereby find that all of the recitals contained in the preambles to this Ordinance are true and correct and do hereby incorporate them into this Ordinance by this reference.

Section 2. That it is hereby ordered that \$83,411.38 be transferred from the State Street Special Tax Allocation Fund to the Marble Street Special Tax Allocation and thereafter be used

to reimburse the City for costs advanced by it in connection with the establishment of the Marble Street Project Area and development proposals.

Section 3. That the Marble Street Special Tax Allocation Fund and all other matters relating to the Marble Street Project Area be closed and forever terminated upon completion of the foregoing.

**Section 4.** Repealer. All ordinances, resolutions, orders or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 5. Effective Date. That this Ordinance shall be in full force and effect upon its passage and approval, as provided by law.

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers").

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of the City of Calumet City when it is determined to be in the best interests of the City; and

WHEREAS, the Corporate Authorities have determined it is in the best interest of the health, safety, morals and welfare of the citizens of Calumet City to revise and update the Building Code.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1.** That the above recitals are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. Section 14-22 ("Adoption of International Building Code") of Division 1 ("Generally") of Article II ("Building Code") of Chapter 14 ("Buildings and Building Regulations") of the Municipal Code of the City of Calumet City is hereby amended by deleting the stricken language and adding the following underlined language to read as follows:

#### Sec. 14-22. – Adoption of 2015 International Building Code.

A certain document, one (1) copy of which is on file in the office of the city clerk, being marked up and designated as the "2006 2015 International Building Code," be and is hereby adopted as the building code of the city for the control of building and structures as herein provided; and each and all the regulations, provisions, penalties, conditions and terms of the 2006 2015 International Building Code are hereby referred to, adopted, and made a part hereof, as fully set out in this article, with the additions, insertions, deletions and changes, if any, prescribed in section 14-23.

Section 3. The modifications and amendments previously made to Sections 101.1, 103.1, 103.3, 105.7, 105.8, 108.2.1, 110.4, 112, 113.4, 302.4, 402.10, 602.1.2, 1612.3F and 3409.2 of the 2006 International Building Code, as more fully set forth in Chapter 14, Section 14.23 (Modifications and Amendments to Building Code) are hereby re-adopted in their entirety, as if fully set forth verbatim herein, as modifications and amendments to the same respective sections of the 2015 International Building Code.

**Section 4.** The modification and amendment to Section 103.2 of the 2006 International Building Code, included as part of Chapter 14, Section 14.23 (Modification and Amendments to Building Code) is hereby amended by deleting the stricken language and adding the following underlined language to read as follows:

**Section 103.2** The official shall be known as the director of inspectional services and shall be appointed by the Fire Chief Mayor of the jurisdiction.

**Section 5**. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 6.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 7.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
