#4: Reconsider motion police promotions

Reconsider a motion to authorize the Police & Fire Commission to promote the following in the police department; effective 7/20/15 due to Captain David Wojcik's retirement: (1) Lieutenant to Captain; (1) Sergeant to Lieutenant & (1) Patrolman to Sergeant; direct the City Treasurer to make the proper payroll adjustments.

#5: Approve motion not

Approve a motion not to promote a Lieutenant to Captain, Sergeant to Lieutenant to approve police promotions and Patrolman to Sergeant, due to the retirement of Police Captain David Wojcik.

Discussion police promotions Mayor Michelle Markiewicz Qualkinbush: "Alderman Collins your question about item #4."

> Alderman Collins: "Yes Mayor, is this to reconsider is to undo action that was already taken."

Mayor Michelle Markiewicz Qualkinbush: "The motion that was made at the last city council meeting was to do promotions due to a retirement. During the recent review of the appropriation ordinance, Finance Director Kasperek stated we have an extra captain.

He is supposed to tell me how that happened. The ordinance in the code book allows for so many captains and somehow we had an extra Captain. Because of the retirement we were supposed to address that at the last meeting.

Unfortunately I wasn't present because I was ill. Alderman Manousopoulos forgot to remove this item from the agenda. The only way to undo the previous action is a motion to reconsider and then a motion not to promote.

Alderman Collins: "Is this an item that can go to committee?"

Mayor Michelle Markiewicz Qualkinbush: "If it is not addressed this evening that it is approved. The only time you can reconsider a motion is at the next city council meeting after the motion is made."

Alderman Schneider: "What is item #5."

Mayor Michelle Markiewicz Qualkinbush: "Item #5 would be a motion not to promote. Once you the motion to reconsider is done then the motion would be not to promote.

So the City Council does not wish to take action on item #4 then we can remove from the agenda."

Remove item #4 & #5

Alderman Collins moved, seconded by Alderman Jones, to remove items #4 & #5 from the agenda.

Alderman Jones; "City Attorney why weren't we notified of this prior to the meeting tonight. This is an action that impacts our budget and this an action that has other ramifications

Why would we notified of the magnitude of this before tonight's meeting. I got the agenda but we got the agenda on Tuesday night."

Mayor Michelle Markiewicz Qualkinbush: "Alderman Jones, I don't know that it is a question for the City Attorney.

The question is probably more for the Finance Director and I believe it was going to be discussed at the last meeting. Again, I was not present unfortunately and it did not occur.

The only impact is that we have been carrying a Captain for sometime and he is supposed to tell us why that is.

He is the monitoring faction of this. I can't answer that question. So, at this point if we vote on the motion that is at hand and then we ask our Finance Director."

Alderman Jones: "I think it is proper to address this to the City Attorney's office because it has other ramifications. If you are saying that we have an extra Captain and we approved the salary ordinance."

Mayor Michelle Markiewicz Qualkinbush: "The appropriation ordinance reflects the extra Captain. The salary ordinance doesn't reflect the union personnel.

The appropriation ordinance I believe and I don't have a copy and I don't know what the number is. I can tell you that last year, the appropriation ordinance for the number of Captains did not match the police department chapter in the Municipal Code book for the number of Captains."

Alderman Jones; "It is permissible to go into Executive Session to discuss this item?"

Mayor Michelle Markiewicz Qualkinbush; "No,"

Alderman Jones; "You are telling us the implications that if we don't approve this it goes into effect, correct."

Mayor Michelle Markiewicz Qualkinbush: "That is correct."

City Attorney Horvath: "If you do not reconsider, then vote not to promote, then the action that was taken at the last meeting would go into effect and the promotions would go forward."

Alderman Jones: "That would mean our budget would be blown. Right now we are \$17,000.00 above. If we approve this action, we will be \$170,000.00 negative."

Mayor Michelle Markiewicz Qualkinbush: "I have a question Treasurer Tarka, do you have a signed copy of the appropriation ordinance. Do you know the number of Captains reflected.

City Treasurer Tarka: "Mayor, I have a copy in the office. Just to reiterate what you said. If you approve items #4 & #5, the budget will be correct. If you do not approve items #4 & #5 then the promotions will take effect and then the budget will be in red that we approve, because of the promotions that was passed in error at the last meeting."

Mayor Michelle Markiewicz Qualkinbush: "The appropriation ordinance reflects the correct number of the chapter of the code book that designates the numbers of Captains, Lieutenants, Sergeants, etc."

City Treasurer Tarka: "Aldermen, as close as I can discern, sometime during the course of the last fiscal year, there was a retirement in the police department and then a motion was made for the Police & Fire Commission to promote. Somehow we ended up with an extra Captain. We are trying to rectify it by making these two motions tonight."

Alderman Jones: "There has been a promotion already from this?"

Alderman Woscyznski: "No."

City Attorney Horvath: "At the last meeting Alderman, the motion to authorize the promotion was adopted. If that motion is not reconsidered and reversed, so to speak, then the promotion will go forward.

If it is reconsidered and then #5 is adopted then there will be no promotion. That is what is happening. They are trying to undo the motion that was adopted at the last meeting mistakenly, before a promotion is required to be made which will then allow for the continuation for the existence of the number of captains in excess of the number allowed by the municipal code and per the appropriation ordinance.

Alderman Jones: "So this doesn't have implications on personnel or potential litigation."

City Attorney Horvath; "Not at this point. Not if you reconsider. You have a right to reconsider."

Alderman Jones: "We don't have all the facts"

City Attorney Horvath: "No one has been promoted. That is the fact. The only other fact is that the motion that was adopted at the last meeting was apparently adopted in error.

Alderman Jones: "Who made the motion at the last meeting."

City Attorney Horvath: "Alderman, I think it was part of the consent agenda."

Mayor Michelle Markiewicz Qualkinbush: "The motion on the floor is to delete item #4 & #5.

City Attorney Horvath: "You have (2) yeas, (2) nays (1) present. There is no majority. The motion fails."

Alderman Jones: "The Mayor could vote in the case of a type breaker."

City Attorney Horvath: "The Mayor does not have to vote."

Mayor Michelle Markiewicz Qualkinbush: "There is no tie."

Alderman Jones: "Conveniently now the Mayor doesn't have to vote."

Mayor Michelle Markiewicz Qualkinbush: "Alderman Jones, there is no tie. You are present, you are a non-vote. You would go with the majority but since it is 2-2. You are not even voting."

Alderman Jones: "If you guys explain. I am sorry we are playing a 2 million dollar attorney operation to not tell us before we get to this meeting. You don't have to respond. You are not a voting member of this. I am talking now. I have the floor."

Mayor Michelle Markiewicz Qualkinbush: "Alderman Jones, I have the floor because I am running the meeting. I am recognizing you."

Alderman Jones: "Thank you. So we come before this and you are telling me that this doesn't have legal implications on it when we made a decision at the last council meeting to reconsider. You don't even know who made the motion on this issue and we got this in the budget.

We are already \$17,000.00 that we have this in our budget. We are a 67 million dollar operation, \$17,000.00 and you are telling me this doesn't have an impact on our budget. I asked you one simple question and you gave me three different answers."

City Attorney Horvath: "I didn't give you three answers. First of all, I take offense at your saying. If you look at your minutes, which you approved this evening you can then determine who made the motion.

Number two, I sat here at the last meeting no one told me anything about objecting to the motion at the time. It is not my prerogative to vote, nor it is my prerogative to tell the city council what it should be doing on a consent agenda if know one asks me.

You did not ask me nor did any other aldermen. Now this evening, I tried to explain to you. There is no legal ramification at this point in time. If the motion to reconsider does not go forward and is not adopted. Then number 5, the motion not promote, it does not go forward or is not adopted then the promotions will take place in the police department.

If the motion to reconsider is made and is approved and then number 5 is made and approved there will be no promotion. It negates what took place at the last meeting. Doing it in this fashion is the legal and the correct way.

If you want, I don't create the agenda, if you have questions about the agenda, you certainly can call, you have done that in the past, without any compunction, and we have answered your questions.

What you prefaced your remarks with at the beginning, I take issue with."

Alderman Jones: "You can take issue with all you want too, all I am saying that you have an item on the agenda and if you polled every aldermen at this meeting and asked them if they understand the ramifications of these motions I guarantee you we don't the facts number one and the impact on our budget which is \$17,000.00.

But I am not going to belabor this point. I asked you a simply question. You were at the last meeting. I shouldn't have to look at the minutes to know who made the motion. I asked you who made the motion.

It is on there for reconsideration."

Mayor Michelle Markiewicz Qualkinbush: "Minutes are not here this evening, however, I believe it was a unanimous vote of the city council. I believe you were here Alderman Jones.

To move this issue forward, if we could have a motion with regarding #4, if you don't agree with it you vote no and then it takes the action it is going to take."

Mayor Michelle Markiewicz Qualkinbush: "Do I have a motion with regarding to item #4 on the agenda.

Pass items #4 & #5

Alderman Woscyznski moved, seconded by Alderman Munda, to pass items #4 & #5 as presented.

Alderman Schneider: "Point of order. Didn't we just vote no on both of this."

Mayor Michelle Markiewicz Qualkinbush: "You voted to delete and remove from the agenda and it didn't pass."

Alderman Jones: "Could you restate the motion that is on the floor now."

City Clerk Figgs; "The motion is to approve items #4 & #5 as presented."

Alderman Munda; "If we had voted on the items on the agenda in the first place with a majority vote of yes in the favor of the items on the agenda. Then the motions #4 & #5 would have passed and the budget not have been effected.

It would have actually passed the way that we passed the budget with a positive number that we passed a balanced budget with our revenue. What was the number?"

City Treasurer Tarka: "Passing items #4 & #5 as presented is budget neutral."

Alderman Munda: "So the budget is the way we passed at the budget meeting. If we voted on Alderman Collins' motion to remove from the budget and that motion passed then it would reflect an unbalanced budget and throw the budget into the red. Am I correct."

City Treasurer Tarka: "I am not going on the record saying it would go into the red, because these are increases in salary but they are incremental increases so I don't have the incremental increases. It would raise the amount of the budget."

Alderman Munda: "But we definitely know that we passed item #4 & #5 with a majority vote that the budget would be right where we left it when we went to the public hearing and passed it."

Mayor Michelle Markiewicz Qualkinbush: "Correct."

Alderman Jones; "Thanks for that comment. It is not the easy way out. I will give you an easy way out. If the City Attorney provides me with a legal opinion in writing saying that this item is legal that we are doing tonight. I will vote yes.

I will give you an easy way out Mayor."

Mayor Michelle Markiewicz Qualkinbush: "No Alderman, you took the easy way out."

Alderman Jones: "No I am not taking the easy way out. Because I was elected just like you were Mayor."

Mayor Michelle Markiewicz Qualkinbush: "Present is no vote Alderman. I am running the meeting Alderman, finish your comments."

Alderman Jones: "You said I am taking the easy way out. My suggestion to the City Attorney you give me this is in writing that this item has no legal impact and also that it is not going to impact our budget. I will vote yes for it, since you said I am taking the easy way out Mayor."

Mayor Michelle Markiewicz Qualkinbush: "I will vote yes."

City Attorney Horvath; "Motion carries. Items #4 & #5 motion to reconsider is adopted and the motion not to promote is adopted."
