City Treasurer - report

City Treasurer Tarka: "Thank you Madam Chairman. I just wanted to go over a few items that are on the agenda for passage tonight.

The amendment of the elected officials salary ordinance and the appointed officials salary ordinance is on the agenda. Those are ordinances #5 and #6.

I want to make it clear to the public as well as to my colleagues that there is no change to any of the pay of either the elected or the appointed officials. These has to do strictly with language within the ordinances regarding the 24 pay schedule and the 26 pay schedule that we will be going on as of the first of the year.

Once again, no elected officials salaries or no appointed officials salaries are being amended in any way. This is just language to facilitate us going to the 26 pay schedule. In actuality elected officials can't change our salary ordinance it is based on the election cycle. It is governed by state statute.

All the aldermen received FAQ's in the last paycheck as well as all of our city employees. I am happy to report that we will be able to proceed with this. This was a major undertaking for our office but it is going to provide a lot of clarity as far as reporting and accounting going to the 26 pay schedule.

I would like to commend all the members of my staff who worked very diligently on this especially Denise Wheaton for all of her hard work along with the rest of the staff. I would like to request a copy of this memo put in Denise Wheaton's payroll jacket. Thank you Madam Mayor."

DEED IN LIEU OF FORECLOSURE AGREEMENT

THIS DEED IN LIEU OF FORECLOSURE AGREEMENT ("AGREEMENT") is entered into this and of December 14 by and between the CITY OF CALUMET CITY, a Municipal Corporation ("THE CITY"), and JEFF BV-VACANT, LLC, an Illinois limited liability company ("OWNER").

WITNESSETH

WHEREAS, OWNER is the record title-owner of certain real estate commonly known as 21-23 Pulaski Road, Calumet City, Illinois, and legally described as follows:

LOTS 40 & 41 IN BLOCK 1 IN WEST HAMMOND, BEING A SUBDIVISION OF THE NORTH 1896 FEET OF FRACTIONAL SECTION 17, TOWNSHIP 36 NORTH, RANGE 15, EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS.

WHEREAS, in April of 2012, prior to OWNER'S ownership, THE PROPERTY was found to be open & vacant and dangerous & unsafe to the surrounding community by THE CITY.

WHEREAS, for the health, safety, and welfare of the community THE CITY took remediation measures to make the property secure and safe by demolition of the structure.

WHEREAS, said reasonable charges for such remediation and services were not paid to THE CITY.

WHEREAS, on May 14, 2014, a Notice of Demolition Lien was filed on THE PROPERTY in the Office of the Cook County Recorder of Deeds as document No. 1413447028, for the reasonable charges due for such remediation and services.

WHEREAS, it is the intention of THE CITY to begin foreclosure proceedings regarding said lien.

WHEREAS, OWNER, has determined that it would be economically in its best interests to convey THE PROPERTY to THE CITY in lieu of said foreclosure.

WHEREAS, THE CITY has determined that it is in THE CITY'S best interest to accept the conveyance of THE PROPERTY in that the conveyance in lieu of continued foreclosure is economically in the best interest of THE CITY.

NOW THEREFORE, in consideration of the mutual promises and covenants herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, THE CITY and OWNER agree as follows:

- 1. THE CITY accepts a Warranty Deed conveying THE PROPERTY from OWNER to THE CITY as a deed in lieu of foreclosure on the claim for lien recorded as Document No. 1413447028.
- 2. Accepting the Warranty Deed, conveying THE PROPERTY from OWNER to THE CITY, hereby extinguishes any and all interests and claims THE CITY may have had in the foreclosure and collection of the claim for lien recorded as Document No. 1413447028The CITY'S
- 3. The Warranty Deed, conveying THE PROPERTY from OWNER to THE CITY, releases any and all potential obligations owed by OWNER to THE CITY regarding the payment and satisfaction of the claim for lien recorded as Document No. 1413447028.
- 4. THE CITY is taking title to the PROPERTY subject to any and all past due real estate taxes.
- 5. The parties agree that THIS AGREEMENT may be executed in multiple counterparts, which may be signed and delivered separately.
- 6. THIS AGREEMENT constitutes the entire Agreement, and supercedes any and all other Agreements, whether oral or written, between the parties. No change or modification of THIS AGREEMENT shall be valid unless the same shall be in writing and signed by THE CITY. No waiver or suspension of any provisions of THIS AGREEMENT shall be valid unless in writing and signed by THE CITY.
- 7. If any portions of THIS AGREEMENT shall be, for any reason, invalid or unenforceable, such portions shall be ineffective only to the extent of such invalidity or unenforceability, and the remaining portion or portions shall nevertheless be valid, enforceable and in full force and effect.

- 8. The foregoing recital clauses to THIS AGREEMENT are incorporated herein.
- 9. THIS AGREEMENT shall be governed in all respects, whether as to the validity, construction, capacity, performance, or otherwise, by the laws of the State of Illinois.

AN ORDINANCE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS, AUTHORING A TRANSFER OF FUNDS FROM THE STATE STREET (TIF #I) AND THE INDUSTRIAL PARK (TIF #II) SPECIAL TAX ALLOCATION FUND

WHEREAS, the City of Calumet City (the "City") is duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and

WHEREAS, pursuant Ordinance NOs 94-70, 94-71, and 94-72 adopted on December 21, 1994, in accordance with the Tax Increment Allocation Redevelopment Act of the State of Illinois, 65 ILCS 5/11-74.4-1, et seq., as from time to time amended (the "TIF Act"), the City approved the State Street Tax and Industrial Park Tax Increment Redevelopment Project Plan and Project (the "Plan"), for a specific area qualifying as a redevelopment project area under the TIF Act (the "Project Area"), and adopted tax increment financing for the purpose of implementing the Plan for the Project Area; and,

WHEREAS, in order to implement the Plan, the Corporate Authorities issued bonds the proceeds of which were used to pay necessary Redevelopment Project Costs as set forth in the Plan; and, thereafter, the City advanced the debt service payment due on said bonds until such time as the Project Area generated incremental taxes pursuant to the TIF Act; and,

WHEREAS, the Project Area has now generated incremental real estate taxes given the substantial redevelopment, which revenue may be used to pay Redevelopment Project Costs as authorized by the TIF Act or to reimburse the City for debt service payments advanced by it in connection with the debt incurred in connection with the implementation of the Plan for the Project Area.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Calumet City, Cook County, Illinois that \$1,200,000.00 of funds now held in the State Street (TIF #1) and \$800,000.00 of funds now held in the Industrial Park (TIF #II) Redevelopment Project Area Special Tax Allocation Funds be transferred by the City Treasurer to the City's Corporate Fund as reimbursement of debt service payments advanced by the City by the City in connection with the issuance of bonds, the proceeds of which were used to pay Redevelopment Project Costs incurred in connection with the implementation of the Plan for the Project Area.

This Ordinance shall be in full force and effect upon its passage and approval, as provided by law.

AN ORDINANCE AMENDING ORDINANCE #12-43 FIXING THE COMPENSATION FOR THE MAYOR, CITY CLERK, CITY TREASURER AND ALDERMEN OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") approved Ordinance Number 12-43 entitled "An Ordinance Fixing the Compensation for the Mayor, City Clerk, City Treasurer and Alderman of the City of Calumet City, Cook County, Illinois" (the "Compensation Ordinance"), as from time to time supplemented and amended.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

- **Section 1**. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.
- **Section 2**. Section 2 of the Compensation Ordinance is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

Beginning in January, 2015, and continuing in all subsequent years, all salaries shall be paid in equal semi-monthly twenty-six (26) equal installments unless provision is made to the contrary by the City Council. The Mayor and City Treasurer shall authorize the issuance of checks for the salaries indicated to be due. Deductions as provided by law shall be made for pension funds, social security and withholding (income tax) and the like.

- Section 3. The remaining provisions and terms as contained in the Compensation Ordinance are not altered, amended or otherwise modified by this Ordinance and remain in full force and effect.
- **Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.
- Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 6.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

WHEREAS, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") approved Ordinance Number 14-36 entitled "An Ordinance Establishing the Salaries and Other Fringe Benefits of Appointed Officials, Supervisory Personnel, and Other Full-Time and Part-Time Employees Not Covered by A Collective Bargaining Agreement for the City of Calumet City, Cook County, Illinois" (the "Salary Ordinance"), as from time to time supplemented and amended.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The fourth paragraph in Section 1 (Salary of Appointed Officials) of the Salary Ordinance is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

Beginning in January, 2015, and continuing in all subsequent years, the salaries earned for each position listed above will be paid in twenty-four (24) semi-monthly twenty-six (26) equal installments on the fifteenth and last day of each month except for the salaries of the Finance Director, Police and Fire Commissioners, the Zoning Board of Appeals Commissioners, Grant Writer, Office of Professional Standards Director, City Attorney and Corporation Counsel which will be paid on the following workday after a regularly scheduled Council Meeting.

Section 3. The fourth paragraph in Section 2 (Public Safety Management) of the Salary Ordinance is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

Beginning in January, 2015, and continuing in all subsequent years, the salaries earned for each position listed above will be paid in twenty-four (24) semi-monthly twenty-six (26) equal installments on the fifteenth and last day of each month. All the positions listed in this section are considered full-time.

Section 4. The third paragraph in Section 3 (Full-Time Employees) of the Salary Ordinance is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

Beginning in January, 2015, and continuing in all subsequent years, the salaries earned for each position listed above will be paid in twenty-four (24) semi-monthly twenty-six (26) equal installments on the fifteenth and last day of each month.

Section 5. The second paragraph in Section 4 (Part-Time and Seasonal Employees) of the Salary Ordinance is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

Beginning in January, 2015, and continuing in all subsequent years, the salaries earned for each position listed above will be paid in twenty-four (24) semi-monthly twenty-six (26) equal installments on the fifteenth and last day of each month.

- **Section 6**. The remaining provisions and terms as contained in the Compensation Ordinance are not altered, amended or otherwise modified by this Ordinance and remain in full force and effect.
- **Section 7**. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.
- Section 8. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 9**. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

AN ORDINANCE AUTHORIZING THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS TO OBTAIN A \$1,200,000 REVOLVING LOAN FROM MB FINANCIAL BANK, N.A. AND TO ENTER INTO A LOAN AGREEMENT WITH MB FINANCIAL BANK, N.A. AND RELATED INSTRUMENTS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City"), pursuant to the provisions of Section 6 of Article VII of the Constitution of the State of Illinois, is a home rule unit of local government and is authorized to exercise any power or perform any function pertaining to its government and affairs including, but not limited to, the power to tax and to incur indebtedness without referendum; and

WHEREAS, the City desires to obtain a \$1,200,000.00 revolving line of credit loan (the "Revolving Loan") from MB Financial Bank, N.A. (the "Bank") for working capital purposes; and

WHEREAS, the City Council has determined that it is advisable, necessary and in the best interests of the City to secure the Revolving Loan and that repayments on the Revolving Loan should be secured by the City's general obligation pledge; and

WHEREAS, the final forms of documents reflecting the Revolving Loan have been prepared and are on file with the City; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Calumet City, Cook County, Illinois, in the exercise of its home rule powers as follows:

Section 1. Recitals.

The foregoing recitals are true, correct and material to this Ordinance and shall be incorporated herein as if they were fully set forth in this Section.

Section 2. Approval of Revolving Loan.

The City approves the Loan Agreement attached as **Exhibit A**, and the Promissory Note evidencing the Revolving Loan attached hereto as **Exhibit A**. The Mayor, the City Clerk, and the City Treasurer are hereby authorized to execute such Loan Agreement and such Promissory Note containing such financial terms, and in substantially the forms attached to this Ordinance in **Exhibit A** hereto, with such changes as may be made to such Loan Agreement and

2

Promissory Note between the date of this Ordinance and the date of execution as may be approved by the City and the City Attorney, such approval to be evidenced by the execution of the Loan Agreement and Promissory Note evidencing the Revolving Loan by the Mayor and the City Clerk.

Section 3. General Obligation.

The repayment obligations of the City under the Revolving Loan shall be a general obligation of the City, for which the full faith and credit of the City are hereby irrevocably pledged and are payable from all sources available to the City to make such repayment including, without limitation, from the levy of taxes on all of the taxable property in the City, without limitation as to rate or amount. For the prompt payment of the Promissory Note, both principal and interest, at maturity, the full faith, credit and resources of the City are hereby irrevocably pledged.

Section 4. Approval and execution of other required instruments.

The Mayor, the City Clerk, and the City Treasurer are hereby authorized to execute such other instruments, documents, certificates or agreements reasonably required by MB Financial Bank, N.A. in order to effectuate the consummation of the Revolving Loan and the delivery of the Loan Agreement, the Promissory Note evidencing the Revolving Loan, and such other documents required to be executed in connection with the Revolving Loan, the approval of such documents to be subject to the review and approval of counsel to the City, such approval to be evidenced by the execution of any such other instruments, certificates or agreements by the Mayor and the City Clerk of the City.

Section 5. Home Rule.

This Ordinance, and each of its terms, shall be the effective legislative act of the City in accordance with the powers as a home rule unit under Article VII of the 1970 Illinois Constitution without regard to whether such Ordinance should: (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law; or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City Council of the City of Calumet City that to the extent that the terms of this Ordinance should be inconsistent with any non-preemptive state law, this Ordinance shall supersede state law in that regard within its jurisdiction.

Section 6. Invalidity.

In the event any portion of this ordinance is found to be invalid, the remaining portions of this ordinance shall be severable from any such invalid portion and enforced to the fullest extent possible.

Section 7. Repealer.

The specific terms and conditions of this Ordinance shall prevail against other existing ordinances of the City to the extent there may be any conflict. All existing ordinances of the City which directly conflict with the terms of this Ordinance are herein repealed.

Section 8. Effective date.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

A RESOLUTION OF THE CITY OF CALUMET CITY, COOK COUNTY ILLINOIS SUPPORTING THE RENEWAL OF A CLASS 8 REAL ESTATE TAX ASSESSMENT CLASSIFICATION FOR 1757- 1765 RIVER OAKS DRIVE (RING ROAD PLAZA INC.)

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the President and Board of Commissioners of the County of Cook have enacted an ordinance known as the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Classification Ordinance"), which provides for a tax assessment incentive classification designed to encourage development throughout Cook County by offering a real estate tax incentive for the development of new facilities, the rehabilitation of existing structures and the utilization of abandoned buildings in order to create employment opportunities and expand the tax base; and

WHEREAS, Ring Road Plaza Inc. (the "Owner") owns a certain parcel of property within the City commonly known as 1757-1765 River Oaks Drive, Calumet City, Illinois, identified by certain permanent index numbers (PIN) and hereinafter legally described on Exhibit A, a copy of which is attached hereto and made a part hereof (the "Property"); and

WHEREAS, Owner has requested that the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") support and consent to the renewal of its Cook County Class 8 Real Estate Tax Assessment Classification for the Property, as said term is defined in the Classification Ordinance (the "Class 8 Tax Assessment Classification"), and as

previously authorized by the Corporate Authorities on May 27, 2004 by Resolution No. 04-27, a copy of said authorizing document is attached hereto and made a part hereof, as <u>Exhibit B</u>; and

WHEREAS, the adoption of a resolution by the Corporate Authorities is required and must be filed by Owner with its renewal application with the County of Cook in order for the Property to maintain its Class 8 Tax Assessment Classification; and

WHEREAS, Owner is an important entity in the City whose economic viability is dependent on the continued Class 8 Tax Assessment Classification; and

WHEREAS, to ensure the ongoing viability of the facility, the continuation of numerous employment positions in the City and to safeguard the tax base of the City, the Corporate Authorities have determined that it is necessary and in the best interests of the City to approve the renewal of the Class 8 Real Estate Tax Assessment Classification for the Property.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Corporate Authorities find that the continuing economic viability of the Property is necessary and appropriate for the community and that without a Class 8 Tax Assessment Classification the Property would be underutilized and cause blight in the area surrounding the Property.

Section 3. The Corporate Authorities find that the Class 8 Tax Assessment Classification incentive program established by the County of Cook is necessary for the ongoing commercial use and habitability of the Property, which is the subject of this Resolution.

Section 4. The Corporate Authorities support and consent to the filing of a Class 8 Tax Incentive Eligibility Renewal Application by the Applicant and Owner of the Property, which is legally described on Exhibit A.

Section 5. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 6. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 7. This Resolution shall be in full force and effect upon its passage, approval and publication as provided by law.
