Alderman Munda: "Just a brief comment Madam Mayor with regard to the snow removal. As everyone can tell on the way into the meeting this evening we are starting to get some snow fall. In the event of a large snowfall or small snowfall, the city's priorities are always are in mains of the town, clearing the public safety buildings, both fire stations, the police department and the routes to the hospitals to maintain those routes are open for public safety.

After public works clear and salt the main routes. We then break into the neighborhoods and clear the streets that we consider secondary streets that connect the side streets. Once the secondary streets are clear and we have clear access or safety vehicles into the neighborhoods then public works department will begin to work on the side streets.

Once all the streets are cleared and salted for proper traffic travel, we then come back with the smaller trucks and start the curb the parking spaces for the residents. That is the general order of operations since I have been alderman. I am sure that is the way they did it before I was alderman.

That is the reason why we do it that way and in some cases we just need to be a little more patient when it comes to the side streets. The public works department works diligently and they don't take favors from certain aldermen or the mayor in regards to where they travel with their snow plows or who get plowed first. The order is always the same.

If there is something that needs to be one, the aldermen or the mayor can definitely request that something be done for a needy resident due to unforsesable circumstances like a resident that needs to get out of their house quickly for a health reason. Unless there is something detrimental going on we always follow the same protocol no matters how much snow falls.

I know there has been some complaints about how quickly it gets down or how quickly we get to each ward or side streets. Definitely know that the management at the public works are working diligently each snow storm to make sure that all the streets are accessible starting in that order.

If there is ever a problem, feel free to call the public works department and discuss with the management and they will be more than happy to take your request."

Alderman Jones: "Alderman Munda thank you for that report. I know our public works department works hard and this past snowfall was frustrating to a lot of residents. It took almost four days in some wards to be cleared. That is unacceptable and I expressed that to the people at public works and hopefully we can rectify that because that wasn't a major snowfall and what happens if we have a major snowfall and hopefully the public works department will correct that.

A lot of residents that contacted my office and I returned calls and I was out they were frustrated because it took four days after the snowfall in some respect for the streets to be cleared. That is unacceptable."

Alderman Munda: "I contacted the management at public works department and I was aware from different aldermen coming in after the snow storm due to the untimely fashion of the removal of the streets. I went to meet with them immediately and asked them what the problem was. There was definitely a situation going on continuous snowfall where they kept going back to the mains.

They were definitely concerned about the disapproval from the other aldermen and the untimely response to the residents of those aldermen. They were very concerned about it. They were very adamant about not letting that happen again. If it does the police department contact them immediately and let them know what your concerns are so they can get to work on it immediately. I apologize on behalf of the department for any other aldermen that received those type of responses from the residents.

We have a lot of good women and men working hard. We will definitely and learn from our past experiences and we are all willing to work together, the mayor all seven aldermen, the management and the staff at public works to move this city forward. Thank you."

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interests of the City.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals are incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. Section 2-261 ("Residency Requirements") of Division 2 ("Residency Requirements") of Article IV ("Officers and Employees") of Chapter 2 ("Administration") of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the underlined language to read, as follows:

Sec. 2-261. Residency requirements.

All officers and employees of the city shall be residents of the City of Calumet City at the time of appointment or employment and, if not, as a condition of appointment or employment, shall become a resident within the city within one (1) year of said appointment or employment. All current and new officers and employees must remain residents of the city during their appointment or employment by the city. These requirements shall not apply to municipal engineers, city attorneys, prosecuting attorneys, special counsel, auditors, architects, economic development coordinator or engineers of the city. Each assistant police chief or deputy fire chief shall observe the same residency

requirement as the rank and file of their respective department. This section is enacted independent of any negotiated collective bargaining agreement and nothing contained herein is intended to delete from or create any rights relative to any existing collective bargaining agreement.

- **Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- **Section 4.** All ordinances, resolution, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 5.** This Ordinance shall be in full force and effect immediately upon its passage and approval to ensure that the license herein contemplated is issued forthwith.

Alderman Jones: "I have two items. There is an item that appeared in my mailbox regarding the holiday party that was thrown. In checking with Alderman Woscyznski and with the Treasurer's Office this party was thrown on December 16, 2013 and my colleagues should have gotten one in their mailbox from Villa Cesare and my name appeared on there. I didn't approve this Holiday Party. I am trying to see through the city clerk's office if this was approved at a city council meeting or the Treasurer's Office if this was approved at the city council meeting.

Mayor Michelle: "It was approved on bill listing alderman. I would be happy to get you this information for the next meeting."

Alderman Jones: "Ok, who gave authority to have the aldermen name on there?"

Mayor Michelle: "I did. You made a statement that all the aldermen wish to have all their names on all publications that were put out by my office and I was just following the wishes of this city council."

Alderman Jones: "So don't do it arbitrarily."

Mayor Michelle "I do it all the time aldermen."

Alderman Jones: "I am asking about this event because this was held in Indiana and I didn't approve this."

Mayor Michelle "Right, it is a senior party. You were made aware of it and you actually voted to approve it at a previous bill listing."

Alderman Jones: "No I didn't."

Mayor Michelle: "We will bring that information to the next meeting and we can have the debate then Alderman."

Alderman Jones: "Why are we approving expense items."

Mayor Michelle: "We will bring the matter to the next council meeting so that we have all the details."

Alderman Jones: "Could I finish first or are you going to talk over me. If your saying and I want this for the record that we approved this at a city council meeting and this flyer was given to me in my mailbox and emailed to me on December 6, actually on December 19 is when I received from your office.

The party was held on December 18 and the expenses were incurred on December 18. I would like to know number one the total amount City Treasurer that this party cost and the authority and copies of the purchase order given to approve this to spend taxpayer dollars in Indiana for Calumet City residents at a party that was held in Indiana. Because I didn't approve this. I didn't want my name on this having a party in Indiana. So I would like to get that."

Mayor Michelle "In an answer to your statement and give me a chance to answer you. You asked for the flyer to be emailed to you on December 19 which is what my staff did. The city council did approve this as we do every year, holiday parties. We had one big party instead of 9 smaller parties.

I will get all that information to you. I will say other elected officials take seniors to Indiana for different functions. For example, to the casino and do things like that. You have approved those items. I am little surprised at your comments. But why don't you let me get all the information together for you and we can have discussion at the next council meeting."

Alderman Jones: "I am not aware of any elected officials in this city council that has approved anything, taking a resident from Calumet City to a casino outside of Calumet City."

Mayor Michelle: "I will bring that information to you also Alderman."

Alderman Jones: "If so, you should pay for it out of your campaign funds, because spending taxpayer dollars in Calumet City in Indiana, I am sure the residents wouldn't agree with that. I will like to get that information and the date that was approved at the council meeting."

Mayor Michelle: "As I said Alderman, all the information will be given at the next meeting. We can have this discussion."

Alderman Jones: "The next item, at the last meeting on December 17, we passed a motion for \$25,000 and City Treasurer to my knowledge the item that was listed was special corporate miscellaneous. I am sure the motion said that we were charging this to special needs and homeless."

Mayor Michelle: "Are you referring to the Sam's Club Holiday Needy cards?

Alderman Jones: "Yes."

Mayor Michelle: "I believe that you designated a line item for special needs and homeless."

City Treasurer Tarka: "Since the fund was going to be reactivated, we created an expense line item for it to be expended thru."

Alderman Jones: "Who gave you the authority to create that? This is the appropriation that we pass in July, without a special needs and homeless line item in there."

Mayor Michelle: "Alderman, did you not approve that expenditure at the last meeting. You approved that expenditure."

Alderman Jones: "I am asking questions of the City Treasurer."

Mayor Michelle: "The treasurer's office has the authority to create line items all the time alderman. They do it often."

Alderman Jones: "Is that going to pass our auditing Mayor."

Mayor Michelle: "Yes."

Alderman Jones: "And you approved that."

Mayor Michelle: "He set up the account. I didn't approve that. I thought there was an account. The treasurer did that at his own direction, which he does all the time with accounts."

Alderman Jones: "I will make sure I talk to the treasurer afterwards, since you can't let me finish my statement or ask a question."

Mayor Michelle: "You voted to approve this why didn't ask those questions at the last council meeting before you approved it."

Alderman Jones "Mayor I did ask those questions, if you look at the minutes."

Mayor Michelle: "You voted yes to approve purchasing them."

Alderman Jones: "Are you going to let me finish. I have two more questions, if you don't mind. Are you finished."

Mayor Michelle: "Alderman, I am running the meeting would you ask your questions please."

Alderman Jones: "This was the appropriation that was approved Mayor. So you are telling me that the treasurer has the authority create a line item and a motion that we made on December 17 that was illegal and incorrect. Because we said special needs and homeless and this was charged to special corporate miscellaneous for \$25,000."

Mayor Michelle: "Mr. Treasurer was that charged to special miscellaneous or was it charged to special needs and homeless."

City Treasurer Tarka: "It was charged to the special needs and homeless line item. Alderman, at various times during the course of the year we encounter anomalies. We recently set up a new revenue account developed with the seizure action by the State of Illinois and are starting to receive monies.

In discussion with my Deputy Treasurer we thought that we would separate these monies in order to be able to track them on behalf of the city in a much more precise manner. We created a new revenue line item to receive these monies from the state seizure accounts as opposed to just dumping it all in miscellaneous revenue line item. We have that ability and we do so when the occasion warrants."

Alderman Jones: "Ok, if you can so give me a copy of the number of the new line item that created and the amount as well. Because in our appropriation it is not created. What department did you put it under. If it is under special corporate, I would like to get a copy of that and just see. If that is fine with you, I would like to get a copy of that."

Mayor Michelle: "Would you like to make a motion."

Alderman Jones: "No I will just call the treasurer."

Mayor Michelle: "You could have done that before the meeting, but ok."

Alderman Jones: "Thank you, just like you could have notified me of this before you had the event Mayor as well."

Mayor Michelle: "If you answered your phone calls Alderman, you would have got that notification."

Alderman Jones: "I never received a phone call from you Mayor."

Mayor Michelle: "Instead of sending texts that you don't wish to talk to me. And I have that text if you would like to see it. "

Alderman Jones: "Ok, why don't you broadcast it Mayor, share it with everybody."

Mayor Michelle: "Alderman, you brought that up, I didn't."

Alderman Jones: "Mayor you did, I never said anything about a text message."

Mayor Michelle: "Do you have anything else Alderman?"

Alderman Jones: "Happy New Year to everyone. Hopefully 2014 will have a brighter Mayor and she will be more cooperative. Happy New Year to everyone."
