ORDINANCE NO. 17-5

AN ORDINANCE AMENDING CHAPTER 54, ARTICLE III, SECTION 54-134, OF THE MUNICIPAL CODE OF CALUMET CITY, COOK COUNTY, ILLINOIS (LICENSE FEES)

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interests of the City; and

WHEREAS, the Corporate Authorities are charged with the responsibility of overseeing implementation of the terms and provisions of the City's Amusement Center License Ordinance in a manner that encourages compliance by businesses licensed to operate an amusement center or amusement arcade in the City.

NOW, **THEREFORE**, be it ordained by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

SECTION 1: That the above recitals are incorporated herein and made a part hereof, as it fully set forth in their entirety.

SECTION 2: That Chapter 54 ("Licenses and Permits and Miscellaneous Business Regulations"), Article III ("Amusements"), Section 54-134, ("License Fees"), of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the underlined language to Section 54-134:

Sec, 54-134. License Fees

Amusement Arcades and Amusement Centers- A flat \$1500.00 annual license fee will apply for amusement arcades and amusement centers with not more than fifty machines. An additional license fee of \$75.00 per machine will apply for all machines in excess of fifty.

SECTION 3: If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

SECTION 4: All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

SECTION 5: All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
