ORDINANCE NO.: ___16-3

AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

325 Pulaski Road

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

Alderman Munda: "Just one matter Mayor, in regards to Alderman Schneider's motion and direction toward counsel to review the portion of the ordinance regarding the quorum and the amount of voting bodies needed to create the quorum is where the answer will be found.

The answer that you will find is no, because then anyone can miss a committee purposely and then the direction of the committee to the chair to the next person and then how do you choose seniority between the remaining two committee members which in fact which one would be a chair and one would be a member will lack three votes to have a majority vote.

We need to have two to override the three. It is going to come down to the amount of votes available at the committee and the voting members. I don't think it is right for a voting member of the committee to take over the chair of the committee in the absence of a chairman when the chairman can purposely miss the meeting and pass the power and authority to the next committee member based on the nature of the issue and even if they were allowed to do that, how would you choose between the remaining two committee members to decide which one had seniority over the other to take over the chair."
