Section 2

That the City shall maintain a written record of this Ordinance in its records during the term that the Bonds or any other such bonds to which such volume cap is allocated remain outstanding.

Section 3

That the Mayor, the City Clerk and all other proper officers, officials, agents and employees of the City are hereby authorized, empowered and directed to do all such acts and things and to execute all such documents and certificates as may be necessary to further the purposes and intent of this Ordinance.

Section 4

That the provisions of this Ordinance are hereby declared to be separable, and if any section, phrase or provision of this Ordinance shall for any reason be declared to be invalid, such declaration shall not affect the remainder of the sections, phrases and provisions of this Ordinance.

Section 5

That all ordinances, resolutions or orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded; and that this Ordinance shall be in full force and effect upon its passage and approval.

ORDINANCE NO. 15-4

AN ORDINANCE RESERVING VOLUME CAP IN CONNECTION WITH PRIVATE ACTIVITY BOND ISSUES BY THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a municipality and a home rule unit of government under Section 6 of Article VII of the 1970 Constitution of the State of Illinois; and

WHEREAS, Section 146 of the Internal Revenue Code of 1986, as amended (the "Code"), provides that for each calendar year the City will have volume cap equal to \$100.00 per resident of the City, as indicated in the most recent census estimate of the resident population of the City, which volume cap may be reserved and allocated to certain tax-exempt private activity bonds; and

WHEREAS, the Illinois Private Activity Bond Allocation Act, 30 ILCS 345/1, et seq., as supplemented and amended (the "Act"), provides that a home rule unit of government may transfer its allocation of volume cap to any other home rule unit of government, the State of Illinois or any agency thereof or any non-home rule unit of government; and

WHEREAS, it is now deemed necessary and desirable by the City to reserve all of its volume cap allocation for calendar year 2015 to be applied toward the issuance of private activity bonds (the "Bonds"), as provided in this Ordinance, or to be transferred, as permitted by this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Calumet City, Cook County, Illinois, as follows:

Section 1

That, pursuant to Section 146 of the Code and the Act, the entire volume cap of the City for calendar year 2015 is hereby reserved by the City which shall issue Bonds using such volume cap, as shall be directed by Stern Brothers & Co., or shall transfer such volume cap in such manner as shall be directed by Stern Brothers & Co., without any further action required on the part of the City, and the passage of this Ordinance shall be deemed to be an allocation of such volume cap to the issuance of the Bonds or such other bonds; provided, that any such transfer shall be evidenced by a written instrument executed by the Mayor or the City Attorney; provided further, that, upon passage of this Ordinance, there shall be paid to the City by the obligor a fee in the amount of 0.5% (50 basis points) of the principal amount of the volume cap so reserved.

ORDINANCE NUMBER _15-5

AN ORDINANCE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS IMPOSING A TEMPORARY MORATORIUM ON THE ISSUANCE OF LICENSES FOR NEW USED MOTOR VEHICLE SALES LOTS UNTIL APRIL 30, 2016

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Municipal Code of the City of Calumet City, Illinois (the "City Code") and 625 ILCS 5/5-102, as from time to time amended, requires the licensing and regulation of a used motor vehicle dealer; and

WHEREAS, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") have determined it to be in the best interest of the health, safety and welfare of the residents of the City to impose a temporary moratorium on the acceptance of an application or issuance of a City license for a new used motor vehicle sales lot, as such term is herein defined, in order to protect consumers and surrounding properties while allowing City staff to undertake a review of the City Code to investigate the feasibility of imposing additional zoning or licensing restrictions; and

WHEREAS, it is the intent of the Corporate Authorities to impose a temporary moratorium for a fixed period of time as herein specified to allow City staff to determine the necessity of appropriate restrictions and report such findings to the Corporate Authorities.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. For the purpose of this Ordinance, and the interpretation and application thereof, the following terms, phrases, words and their derivations shall have the meanings given herein, unless the context in which they are used shall indicate otherwise. When not inconsistent with the context, words used in the present tense include the future, words in the singular number include the plural number and words in the plural number include the singular number. Words or phrases not defined shall be given their common and ordinary meaning unless the context clearly indicates or requires a different meaning.

"Used Motor Vehicle Sales Lot" means a business displaying five (5) or more used motor vehicles for the purpose of wholesale or retail sale to the general public.

"Used Motor Vehicle" means every motor vehicle which has been sold, bargained, exchanged, given away, or title transferred from the person who first acquired it from the manufacturer or importer, dealer, or agent of the manufacturer or importer and so used as to have become what is commonly known as "second hand" within the ordinary meaning thereof.

Section 3. A temporary moratorium on the acceptance of an application or issuance of a City license for a Used Motor Vehicle Sales Lot not in lawful operation as of the date of this Ordinance is hereby enacted and shall be in full force and effect for a period of time beginning on May 1, 2015, and expiring at 11:59 p.m. on April 30, 2016, unless prior to that time the City Council, in its sole and absolute discretion, terminates said temporary moratorium by ordinance duly adopted. The temporary moratorium herein imposed shall not pertain to the acceptance of an application or issuance of a City license for an existing Used Motor Vehicle Sales Lot, but only for such license

application and issuance of a City license for a new Used Motor Vehicle Sales Lot.

Section 4. This temporary moratorium shall not pertain to homeowners or lessees displaying a personally owned vehicle for sale on the residential property on which that homeowner or lessee resides.

Section 5. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 6. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 7. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

ORDINANCE AUTHORIZING THE CITY CLERK TO DESTROY THE AUDIO RECORDINGS OF CERTAIN CLOSED MEETINGS IN ACCORDANCE WITH THE PROVISIONS OF 5 ILCS 120/2.06(c)

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a municipality and home rule unit of government under Section 6 of Article VIII of the 1970 Constitution of the State of Illinois, and

WHEREAS, the City Council conducts its meetings in public except when necessary and permissible pursuant to 5 ILCS 120/2(a) to consider certain subjects in closed session; and

WHEREAS, from time to time it is necessary and in the best interests of the City for its City Council to close a portion of its meetings to the public; and

WHEREAS, when a meeting, or portions of a meeting, are closed to the public, audio recordings of the closed portion of the meeting are kept and preserved until no less than eighteen (18) months after completion of the meeting and approval of the minutes in accordance with 5 ILCS 120/2.06; and

WHEREAS, the City Council has approved the minutes of certain closed meetings as required by 5 ILCS 120/2.06; and

WHEREAS, with respect to those closed meetings for which the minutes have been approved and for which more than eighteen (18) months have elapsed since approval, the City Council may authorize destruction of the audiotapes of the particular meetings.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. The recitals set forth above are incorporated by reference the same as if they were set forth verbatim herein.

Section 2. The audio recordings of the closed meetings conducted on the following dates shall be destroyed:

January 18, 2012 January 26, 2012 February 9, 2012 February 22, 2012 March 8, 2012 May 10, 2012 July 19, 2012 July 25, 2012 August 21, 2012 October 11, 2012 April 11, 2013 April 25, 2013

Section 3. The City Clerk is authorized to destroy the audiotape recordings of the closed meetings set forth in Section 2.

Section 4. The provisions of this Ordinance are hereby declared to be separable, and if any section, phrase or provision of this Ordinance shall for any reason be declared invalid, such declaration shall not affect the remainder of the sections, phrases and provisions of this Ordinance.

Section 5. All ordinances, resolutions or orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded, and this Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form.
