Alderman Collins: "Specifically the action that took place on 6/18/14."

Mayor Michelle Markiewicz Qualkinbush: "Specifically what are you speaking of alderman?"

Alderman Collins: "It is in the communication but I can say it."

Mayor Michelle Markiewicz Qualkinbush: "Alderman, I will take your request under consideration."

Alderman Collins: "Will you respond by the next city council meeting."

Mayor Michelle Markiewicz Qualkinbush; "I will respond in the time that is so set forth as it requires for a veto, yes I will."

Alderman Collins: "I appreciate it. I am not attempting to grandstand. This is a public meeting and I respectfully requesting that, while this discussion is open."

Mayor Michelle Markiewicz Qualkinbush: "There is a motion to approve these minutes as so presented."

Alderman Jones: "While we are under the discussion, City Attorney."

Mayor Michelle Markiewicz Qualkinbush: "Point of order please. Is there a motion on the floor?"

Alderman Jones: "You can't call for a point of order while we are under discussion Mayor."

Mayor Michelle Markiewicz Qualkinbush: "The point of order is there a motion on the floor and the clerk says yes there is. You have a question Alderman Jones?"

Alderman Jones: "While we are in discussion, I am directing my inquiry to the City Attorney because the time frame for you to have a veto message is at this meeting so don't be disingenuous and not say that your going to respond and give him an answer when today is the day you have to give an answer to veto it.

The ordinance in question is an ordinance with the labor agreement, city attorney. So at this meeting, the Mayor has to either veto it or the next meeting we have to have a motion to rescind it, correct."

Mayor Michelle Markiewicz Qualkinbush: "There was no ordinance Alderman Jones, I don't know what your speaking of?"

Alderman Jones: "It was an ordinance passed on 6/18/14."

Mayor Michelle Markiewicz Qualkinbush: "It was not an ordinance passed at that meeting."

Alderman Jones: "What was passed at the meeting."

Mayor Michelle Markiewicz Qualkinbush: "It was a motion to approve a collective bargaining agreement."

Alderman Jones; "The collective bargaining agreement was an ordinance."

Mayor Michelle Markiewicz Qualkinbush: "No it was not."

Alderman Jones: "Yes it was. The document that I have is a collective bargaining agreement."

Alderman Manousopoulos: "The contract is what we had in front of us."

Mayor Michelle Markiewicz Qualkinbush: "Correct, not an ordinance."

Alderman Jones: "The motion to veto would actually be to veto the action that taken which was the labor agreement. So, City Attorney are you going to response."

City Attorney Montana: (His comments were not audible)

Alderman Jones: "It wouldn't have been the June 26 meeting."

City Attorney Montana: (His comments were not audible)

Mayor Michelle Markiewicz Qualkinbush: "Was there a meeting on that date?"

Alderman Jones; "Not to belabor, could you check that and verify before the meeting is over City Attorney."

City Attorney Montana: (His comments were not audible)

Alderman Jones: "The only other action is for the action to be rescind it." A motion to rescind it."

City Attorney Montana: (His comments were not audible)

Alderman Jones: "No, a motion to rescind can be introduced at any time."

City Attorney Montana: (His comments were not audible)

Alderman Jones: "Is that an opinion of the city attorney's office? Can you put that in writing please? I would appreciate that. Your saying that the action can't be rescinded in the veto message was passed to date, which was June 23, 2014, that was a special meeting."

City Attorney Montana: "Yes, 6/18/14 is a special meeting. (His comments were not audible)

Alderman Jones: "I would like to received that in writing."

City Attorney Montana: "(His comments were not audible)

Alderman Jones; "We are not dealing with hypothetical. You are saying this is an opinion. I am not asking you a hypothetical question. I am asking you a legal opinion.

If your legal opinion is that we are passed that point."

City Attorney Montana: "For the Mayor to veto, yes."

Alderman Jones: "And we are passed the point for rescinding because the action was taken place then please put that in writing."

Mayor Michelle Markiewicz Qualkinbush: "Alderman, you were not at the meeting on June 26, 2014? You were ill."

Alderman Collins: "No, I was out of the country. I was at a wedding that I gave notice to this body months in advance that I would not be available. This issue is a issue that my residents, not me because I am only the spoke person for the residents of the 7<sup>th</sup> Ward. My vote mattered and I believe that the timing here, I won't speculate.

I am not happy with the timing of this issue in something being called when I provided my calendar to this body. The residents of the 7<sup>th</sup> Ward have not had an opportunity to allow me to say what they want me to say. I will express that now.

The residents of the 7<sup>th</sup> Ward oppose that collective bargaining agreement for record."

Mayor Michelle Markiewicz Qualkinbush: "As a point of order, my question to you Alderman Collins was were you present at the June 26, 2014 regular city council meeting?"

Alderman Collins: "Mayor, I said no."

Mayor Michelle Markiewicz Qualkinbush: "Because that is when the matter should have been discussed."

Alderman Collins: "The record will reflect that said no I was not present. I wanted to make it perfectly clear. It is just my opinion. We can move forward."

Mayor Michelle Markiewicz Qualkinbush: "Another statement that I would like to reflect in the record, if any aldermen wish me to consider vetoing or wish to have that discussion with me, certainly that could have taken place upon your return and prior to that June 26 meeting. I didn't have a call from anyone of you."

Alderman Jones: "You don't provide us courtesy."

Alderman Collins: "Alderman Jones, please. Mayor one last item. I understand what you are saying. Put yourselves in my shoes and the constituents that I represent.

What is the point in providing calendars if meetings are going to be called on important matters where everyone can't be present.

What is the purpose of me saying I am not going to be present. It is a very important issue. I have been there for the other sessions that I needed to be present for. This was something that I could not avoid. I gave my calendar in advance. I could have called you today."

Mayor Michelle Markiewicz Qualkinbush: "Prior to the June 26, alderman is what I said prior to the veto date."

Alderman Collins: "This information wasn't even on the previous meeting. It could have been on there at that time too on a meeting following June 19."

Mayor Michelle Markiewicz Qualkinbush: "What could have been on there?"

Alderman Collins: "The approval of the minutes."

Mayor Michelle Markiewicz Qualkinbush: "The minutes have nothing to do the veto or the situation. The motion on the floor is just to approve the minutes. All of this discussion has to do with is in the minutes and it doesn't have anything to do with the approval of the minutes.

As a point of order, this discussion is really out of context. The motion on the floor is to approve the minutes. The motion on the floor is not to talk about what was contained in it."

Alderman Collins: "What brought about the discussion was the action that was within the minutes. That is the reason that it is relevant. I will leave it as that."

Mayor Michelle Markiewicz Qualkinbush: "All in favor of approving the minutes, there is a motion on the floor."

Public Works

Alderman Munda: "Just a brief report Mayor, I would like to wrap up the summary of the thunderstorm that we previously experienced. I would like to commend ComEd. With the number of outages out and the affected storm area throughout the region, it was quite extensive.

ComEd latest date with people without power was three to four days, which was extremely fast for the amount of people affected throughout the whole region. They brought in contractors from other states, other workers from branches of ComEd. They worked vigorously throughout the evening trying to get the power restored and removing trees from the affected power lines.

I would also like to commend the public works department. They went at it night and day until they couldn't burn anymore hours. Some guys had to go home because they would out all night and needed to get some rest.

I would also like to commend Mayor Michelle for approving the overtime to the public works department to remove the trees. The damage was quite extensive especially on the south part of town. I thought the public works department in conjunction with ComEd did another great job.

I know it seemed long for some people, considering the severity of the storm and the amount of outages they took of Calumet City relatively quickly. There are still other towns in the region that are still experiencing problems where our power is all restored at 100 percent and our streets and trees are cleared. "

#### Mayor's report

At this time in the meeting, Mayor Michelle Markiewicz Qualkinbush recognized Detective James Burnett, Calumet City Police Department who has been honored by the State of Illinois.

"On April 22, 2013, Detective Burnett observed a man fitting the description of a suspect involved in a shooting. The suspect fled after being ordered to remove his hand from his pocket. As a foot chase ensued, a handgun was observed protruding from his pocket. The suspect fell and the gun hit the ground. As the suspect grabbed the gun, Detective Burnett drew his weapon and repeatedly commanded the suspect to drop the gun. The suspect did not comply and pointed the gun at Detective Burnett who fired two fatal shots."

At this time in the meeting, Mayor Michelle Markiewicz Qualkinbush and Police Chief Gilmore recognized\_Detective James Burnett and presented an award from the Illinois State Police.

# City Treasurer - report

City Treasurer Tarka: "I wanted to let the city council know that on Tuesday, July 2, 2014 Finance Director Kasperek and myself sat down with Moody's Investors Rating Services Agency and were interviewed on the financial status of the City of Calumet City.

We are also in the middle of answering our financial questionnaire for Standard & Poor's Rating Services. While the city face financial challenges we are hopeful that we will able to maintain our current A rating. I will keep the city council and the mayor appraised as that information is sent to me.

# ORDINANCE NO.: 14-34

# AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

**BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

659 Buffalo Avenue

334-152nd Place

# 533 Mackinaw Avenue

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
