

Dear Fire Chief Galgan and Police Chief Gilmore:

On April 22nd, I was returning from a daily walk with my daughter, Sarah Buck. We had just about reached the corner of Highland and Legion Drive when I slumped to the ground and went into cardiac arrest. Sarah ran to my other daughter's home, Melinda Pipik, who lives on the corner of Highland and Legion. Sarah pounded on her door and then ran back to me, pulled my phone out of my coat pocket and called 911 at 5:41 am. At this point I was unresponsive and not breathing. Fortunately Sarah had recently completed a CPR class and began working on me immediately. Melinda, a registered nurse, ran out of her house, took over for Sarah, and yelled for her to get our neighbor who is also in the medical field. Our neighbor took over CPR as my son-in-law, Paul Pipik, completed rescue breaths. The police arrived within two minutes; they blocked off the street and offered emotional support for my family. The ambulance and paramedics arrived within 5 minutes and worked to get me on a stretcher and into the ambulance. My daughters told me that at this point my eyes were fixed and dilated. Paramedics intubated me and my daughter said it appeared that my heart arrested again. Paramedics could not leave for the hospital until they shocked me again and got me somewhat stabilized.

The odds were against me for recovering from this cardiac event. My family was told that if I survived, I could have brain damage, paralysis, and kidney failure. It was 5 days before I regained consciousness and 17 days before I would return home. But by the grace of God and many prayers I survived and will be able to return to work sometime this month.

Police Chief Gilmore and Fire Chief Galgan, my understanding from St. Margaret's ICU staff is that the first responders were instrumental in saving my life. At this time, my family and I would like to thank and recognize Police Officers Asher Dimitroff, Tom Mottl and Brian Gerstner; Paramedics Michael Peterland and Joseph Brazzale; and FireFighters Thomas Hansen, Timothy McGannon, and Dave Saitta. It is due to their expertise, care, and quick response that I am here today. There are no words to express our gratitude and I am so proud to live in a community with such a fine fire and police department.

WHEREAS, Edward "Eddie" Gonzalez continued to improve his professional advancement by joining the Illinois State Police force, rising to the rank of Master Sergeant during his 25 year tenure of service as a decorated public safety officer; and,

WHEREAS, Edward "Eddie" Gonzalez has one of the pioneers of the Latino community in municipal government, having been appointed and subsequently elected, serving the first ward for 12 years as the first Latino Alderman of the City of Calumet City in its history and subsequently as its first Inspector General; and

ORDINANCE NUMBER 13-32

AN ORDINANCE ADOPTING THE PREVAILING RATE OF WAGES TO BE PAID TO LABORERS, MECHANICS AND OTHER WORKERS EMPLOYED IN ANY PUBLIC WORKS PROJECT IN THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the State of Illinois (the "State") enacted the Prevailing Wage Act, 820 ILCS 130/0.01 et seq., (the "Prevailing Wage Act"), which is an act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or political subdivision or by any party under contract for public works; and

WHEREAS, it is the policy of the State that a wage of no less than the general prevailing hourly rate as paid for work of a similar character in the locality in which the work is performed, shall be paid to all laborers, workers and mechanics employed by or on behalf of any and all public bodies engaged in public works; and

WHEREAS, the Prevailing Wage Act requires that the City investigate and ascertain the prevailing rate of wages as defined in the Prevailing Wage Act for laborers, mechanics and other workers constructing public works in the City; and

WHEREAS, the City has ascertained and examined the prevailing wage classifications and rates determined by the Illinois Department of Labor for the County of Cook for June 2013.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. To the extent and as required by the Prevailing Wage Act, the general prevailing rate of wages in the City for laborers, mechanics and other workers engaged in construction of public works is hereby ascertained to be the same as the prevailing rate of wages for construction work in the County of Cook as determined by the Illinois Department of Labor as of June 2013, a copy of said determination being attached hereto and made a part hereof as Exhibit A.

Section 3. As required by the Prevailing Wage Act, any and all revisions of the prevailing rate of wages by the Illinois Department of Labor shall supersede said determination and apply to any and all public works and that the definition of any terms appearing in this Ordinance, which are also used in the Prevailing Wage Act, shall be the same as in the Prevailing Wage Act.

Section 4. Nothing herein contained shall be construed to apply the prevailing rate of wages as herein ascertained to any work except public works or to the extent required by the Prevailing Wage Act.

Section 5. The City Clerk shall publicly post and keep available for inspection by any interested party in the main office of the City this determination or any revisions thereof of the prevailing rate of wage.

- Section 6. The prevailing rate of wages as determined herein, or as subsequently revised, shall be included in every contract for public work, and all ordinances, resolutions, calls for bids and bid specifications relating to any public work shall state or provide that any person performing any public works on behalf of the City shall be required to pay the prevailing rate of wages to all labors, mechanics and other workers employed for such public works. All contractors' bonds, provided by any contractor on any public works for the City shall provide a guarantee that the contractor will faithfully perform his obligation to pay the prevailing rate of wages as provided by the contract for such projects and in accordance with the Act.
- Section 7. The City Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.
- Section 8. The City Clerk shall promptly file a certified copy of this Ordinance with the Illinois Secretary of State and the Illinois Department of Labor.
- Section 9. The City Clerk shall cause to be published a public notice in a newspaper of general circulation within the City to advise the public of the adoption of this Ordinance, which publication shall constitute legal notice that the determination is effective and that this is the determination of the City.
- Section 10. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- Section 11. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 12. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
