ORDINANCE NO.: 15-29

AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

430 Yates Avenue, Unit #1

515 Forsythe Avenue

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

A RESOLUTION AUTHORIZING THE COUNTY OF COOK TO SUBMIT A NO-CASH BID TO ACQUIRE A TAX CERTIFICATE OF PURCHASE FOR THE NONPAYMENT OF TAXES ON 64 VACANT PROPERTIES VIA THE COOK COUNTY NO CASH BID PROGRAM

WHEREAS, The City of Calumet City, Cook County, Illinois (the "City") has declared economic development as one of the primary objectives of the administration; and,

WHEREAS, the City of Calumet City has also declared eradication of blight as essential to limit any deterioration of its economic base; and,

WHEREAS, the City of Calumet City has identified certain abandoned property which is vacant, underutilized, hazardous, and or does not meet minimum code requirement for building upon; and,

WHEREAS, it has been discovered that no real estate taxes have been paid on these parcels for two years or more; and

WHEREAS, the County of Cook, Illinois, seeks to further its goal of economic development by returning tax delinquent properties to a tax producing status and has established a no-cash bid process for municipalities to acquire Tax Certificates of Purchase for nonpayment of real estate taxes in order to petition for a tax deed to return such property to a viable use beneficial to the municipality.
