Public Utilities

Alderman Jones; "At the last city council meeting, I made a statement regarding the water rates and the water rate increase. Some of the dates were incorrect, which I check and verified the new and correct dates that the City Council voted to implement the water rate increase and the late fees. As I stated at the last council meeting, many of you have before the city council and complained about the water bill.

I want to thank the residents for coming. Just to refresh the dates. September 29, 2014, the Mayor requested that this city council consider raising the water rates. This city council voted on September 29, 6-0 to increase the water rates, 80 percent, which represents \$2.80 per 1,000 on water bill.

At that time, of course we all know that Hammond raised the water rates on Calumet City and local communities 243 percent. This is not only not a burden that the city had to take, but this city council had to do something.

At the time, I requested that the city council phase the water increase in, that wasn't done.

On December 12, Mayor Michelle ordered the City Clerk to begin the monthly water billing. On December 29, the city council voted 4-3 to approve changing the water billing from quarterly billing to monthly billing and added late fees.

The monthly billing was included in the ordinance that was presented to the City Council on December 29.

On January 29, 2015, the city began collecting the late fees from residents and estimated 5,800 residents have paid late fees to date.

Ald. Jones (cont'd)

That number may be off, but we will verify with the City Treasurer's Office. The \$35.00 late fee began collected in January, 2015.

On Wednesday, April 8, 2015, the City Council voted to amend the water ordinance to change the late fee from \$50.00 to \$35.00.

As I stated, I was always against raising not only the water residents, but also the late fees that have been charged. Tonight we have two ordinances on the agenda that address the late fees.

I was against raising and rushing this process because we didn't think this through. Now these ordinances that are on the agenda are seeking to correct wrongs that were done to residents and hopefully if we have another city council meeting where we discuss this as a body that we can get this corrected.

This was a statement that I made at the last council meeting. The Mayor wasn't at the last council meeting, so that is what I am making this statement again.

But I wanted the residents to have a clear time line of what happened with the water rates and who voted for it and how this city council made a decision to increase the water rates and implement the late fees. Thank you Mayor."

Mayor's Report

Mayor Michelle Markiewicz Qualkinbush: "Under the Mayor's Report, I would like to ask the Finance Director to give the clear time line of what occurred with the water rates."

Finance Director

Finance Director Kasperek: "Mayor, City Council and residents of Calumet City. My name is John Kasperek. I am the Finance Director for the City of Calumet City.

I was appointed to this position on February 1, 1990. So I have been here over 25 years serving as the city's Finance Director.

The Mayor has asked me to update the City Council on the water late fee issue.

However first, I would like to refresh the City Council's memory, as well as the public as to the water rate issues.

The 20 year contract with the City of Hammond Water Department, dated February 27, 1992, expired in 2012 and the City entered into a new contract dated June 28, 2012.

Finance Director

The City of Hammond stood firm on their increased price. Since they were lower than the rates charged by the City of Chicago, the City entered into a contract with Hammond.

(Water Rates went from 91 cents per 1,000 gallons to \$2.20 per 1,000 gallons or a 243 percent increase imposed by the City of Hammond)

At the September 25, 2014 City Council Meeting, I recommended to raise the water rates. The City absorbed the increase imposed by the City of Hammond for two years causing a \$2.5 million dollar deficit in the water fund.

The ordinance was adopted by the City Council on October 23, 2015. Six aldermen were in favor.

On December 9, 2014, a letter from the City of Hammond to Calumet City was to inform us that the water rates would be increase from \$2.20 per 1,000 to \$3.3528 per 1,000 gallons, increasing the cost of water by another 52.4 percent effective February 7, 2015.

Hammond raised the price of our water 370% in less than three years. Putting it in a dollar perspective, for the fiscal year ending April 30, 2012, which was at the old rates, Calumet City paid \$1.345 million for water.

For the fiscal year ending April 30, 2016, we anticipate paying \$5 million dollars for water.

I recommended adopting of an ordinance on December 29, 2014, changing the billing from quarterly to monthly and changing the late fee to \$35.00 due the day after the due date.

The reason for recommending monthly billing was to make the water increase more manageable for the residents to pay. The Council adopted this ordinance by a vote 4-3.

Unfortunately, I misinterpreted the language relative to late fees and therefore the late fee was administered incorrectly by the water billing department from January to August, 2015.

All accounts entitled to a credit have been identified and will be credited on the November bill due in December.

Mayor Michelle Markiewicz Qualkinbush: "Thank you Finance Director Kasperek. Christian maybe you can get this message out as I promised the smaller group of this group had met with me previously and asked that we have community forums.

You are asking that again tonight. I will talk to the council members and see what dates works for them and schedule a community forum accordingly from this date

AN ORDINANCE AMENDING CHAPTER 94 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS (WATER/SEWER RATES, BILLING CYCLE AND FEES)

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interests of the City; and

WHEREAS, the Corporate Authorities are charged with the responsibility of regulating water rates in manner to be able to continue to provide City services and for the protection of the public health, safety and welfare of its citizenry.

NOW, THEREFORE, IT BE ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

- Section 1. That the above recitals are incorporated herein and made a part hereof, as if fully set forth in their entirety.
- Section 2. That Chapter 94 ("Utilities") of the Municipal Code of Calumet City, Illinois, is hereby amended by deleting the stricken language and adding the following underlined language to read, as follows:

Sec. 94-71. Bills; penalty for late payment; persons liable.

Bills for water and sewer services shall be rendered monthly and shall be delinquent fourteen (14) days after the due date stated on the bill. In the event of failure to pay the bill within the said fourteen-day period by the said due date, a late fee of thirty-five dollars (\$35.00) shall be added to the bill five calendar days after said due date. Accounts not paid after by the due date stated on the bills shall be designated for disconnection. For any owner of any premises if water is disconnected, a fifty dollar (\$50.00) turn on fee will be assessed for reconnection. The owner will be held liable to the city, regardless of any separate private agreements that the owner may maintain with a third-party liability.

Sec. 94-74. Nonpayment of water and sewer bills.

(c) Service charge on returned checks. Any water and sewer user who tenders a check to the city in payment of a water and sewer bill, which check is returned to the city unpaid, shall be assessed a twenty-five dollar (\$25.00) service charge. If satisfactory evidence is furnished to the water department that the nonpayment was due to bank error, then said service charge fee may be waived.

Sec. 94-163. Application; turning on water; fee.

- (a) No water service shall be turned on for use on or in any premises until an application therefor in writing has been made for that purpose and filed with the water superintendent stating the purpose for which the water is to be used.
- (b) Each applicant for connection to the water system shall pay a service charge of fifty dollars (\$50.00) for the cost of making each connection; in addition, he shall deposit with his application the following sum pertaining to the premises for which application is made:
- (1) Residents and tenants, per account... \$50.00
- (2) Taverns, laundromats, car washes, restaurants, and industrial, per account..... \$100.00
- (3) All other businesses, per account.... \$50.00

Such deposit shall be held by the city as security for the payment of water used by the applicant and may be so applied when any default is made in the payment of a water bill; provided, however, that any single-family premises occupied by the owner thereof, shall not be required to pay a security deposit in the amount of fifty dollars (\$50.00).

Upon sale of property, the owner will be entitled to a refund of one-half (1/2) of the security deposit. The other one-half (1/2) of the security deposit will be applied to pay the administrative cost incurred by the City with respect to the sale.

Sec. 94-171. Established; due date.

The rate for all water supplied by the city to users who reside within the corporate boundaries of the city, payable on the first day of each period, shall be six dollars and sixty cents (\$6.60) per one thousand (1,000) gallons of water used starting January 1, 2015 or at such time thereafter upon the establishment and phased an issuance of a monthly bill cycle for water and sewer services to a user. The rate for all water supplied to those who reside in an unincorporated area, the rate shall be seven dollars and sixty cents (\$7.60) per one thousand (1,000) gallons of water used starting January 1, 2015.

Starting January 1, 2015, any water/sewer bill showing less than 1,000 gallons used will be assessed a minimum bill of six dollars and sixty cents (\$6.60) for water (or the current rate in effect) and sixty-two cents (\$0.62) for sewer (or the current rate in effect).

In addition starting January 1, 2015, water rates shall be adjusted upward automatically if the City of Hammond raises the water rates for the City and such adjustments will be administered by the Director of Finance. The dollar adjustment of water rates for the purchasers of water in the unincorporated areas will be in the same amount as adjustments for those living within the corporate boundaries of the city.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Neighborhood Watch Alderman Wosczynski announced every 1st Monday of month there is a Neighborhood Watch Meeting for the 2nd Ward in the lower level of the police department at 6:30 p.m. She encourages residents to attend to express their concerns with crime in the neighborhood.

Ald. Jones

Alderman Jones: "There is no easy way to say this. But tonight just for the public. Many residents came up tonight and talked about the late fees. The late fees didn't go anywhere. The City Council had the late fees at \$35.00 and just approved it again tonight, and changed from 14 days to 5 days.

You saw everyone that voted yes for this. But this is what you have and you have a \$35.00 late fees and also 5 days reduced from 14 days.

Just so the public understands what we did tonight, which wasn't made clear to everyone. We have the \$35.00 late fee, the 14 days was reduced to 5 days. That is the option that the council had, even thought there was another option on the agenda that we discussed at a public utilities meeting.

I appreciated my colleagues for not only attending the meeting and talking about how the late fees have impacted our residents. But I wanted to make sure that the residents understood what we just did tonight. We heard you but we didn't hear you.

Ald. Munda

(Alderman Munda's comments at the beginning of his statement were not audible)

Alderman Munda: "I invite you to my town hall meeting which will named at another council meeting. After I coordinate with the Mayor and City Clerk and check her availability.

The Mayor and City Clerk are more than welcome to attend the meeting and defend yourself against this accusations. But it is my belief that this council acted in the best interest of the residents to keep our bills paid to the City of Hammond and the late fees were implemented in order to counteract another financial issue that was going on within this city in regards to the water payments that brought to the attention of the city council by the Finance Director.

Ald. Munda (cont'd) I commend those aldermen tonight that voted for this. It is not an easy decision but it is what I feel is correct and right as a leader in my community. I know it is not easy for some people to get by.

> It hurts them financially and I understand that some people are living in financial strife and maybe the Mayor and myself can come up with some ways to help people going through those things.

But when it comes to the water rates and the increases, I stand firm by my decisions to keep the late fees in place and the water rate increases in place for good financial reason.

We can argue all night long on how it was done and how it came about and how we decided to do it through the committees. I am choosing not to let it go on forever.

I made my decision tonight and I am standing by it and I am moving forward. I would like to thank the Mayor, City Clerk, City Treasurer, Finance Director and my colleagues that did support that decision tonight.

I think you made a wonderful and right decision to keep this city afloat and up on its feet and I commend you for that. Any residents that would like to discuss those things with me feel free to contact me through my office and I will be available after the meeting if you would like to address me in person.

We will also have a town hall meeting with the Mayor and any other elected officials that wish to attend. Thank you."

Mayor Michelle

Mayor Michelle Markiewicz Qualkinbush: "I just want to add to the conversation briefly as everyone heard the Finance Director tonight explain the 14 day period does not work with monthly billing in the way that it has to be administered.

It was an error because of a misinterpretation of the ordinance and it was administered incorrectly. But the 14 days cannot work with the monthly billing as the Finance Director explained in our committee meetings and this evening.

The reason for changing it to 5 days is because that works with monthly billing. I certainly encourage my colleagues and those that don't like the monthly billing, perhaps we can have a Public Utilities or Finance Committee meeting and we discuss it again,

I hear what the residents are saying, if we go back to quarterly billing. I don't know if that truly is a good option. I think we have to listen to what the Finance Director is recommending.

The water rates, the majority of this city council listened to the Finance Director's recommendation because we have to pay the bills to Hammond. We don't agree on the monthly billing issue That is what we don't agree on. We don't agree on the late fee issue.

Mayor (cont'd)

But we agree that we have to pay the rates that are imposed by us, first of all, Chicago who dictates what Hammond charges us which is 88 percent of what Chicago charges as well. We took the least expensive way of providing water for our residents.

I agree with Alderman Munda, there is not one elected official sitting up here that wants to raise the water rates and that wants to impose this on our residents.

But we have no other option as the Finance Director has put out here before us. I will as I promised this group who met with me, a month or so before and I will attend Alderman Munda's meeting and we will schedule town hall meetings in the wards and we certainly can talk about these issues and perhaps there is another way of looking at it.

But we have to follow what the Finance Director is recommending to us. I don't see another way but certainly I am willing to listen to everyone and perhaps there is a way to help residents as well.

Again, nobody here wanted to raise the water rates, but the 14 days just doesn't work with monthly billing as the Finance Director explained. That is all I want to say on this issue this evening and I sure we will have much more conversations about this as we move forward, especially thought the town hall meetings.
