AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

416 Madison Avenue

1236 River Drive

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

ORDINANCE NUMBER: 14-48

AN ORDINANCE AMENDING CHAPTER 94 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS (WATER RATES, BILLING CYCLE AND FEES)

WHEREAS, the City of Calumet City, Cook County, Illinois (the ACity@) is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the AHome Rule Powers@); and

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interests of the City; and

WHEREAS, the Corporate Authorities are charged with the responsibility of regulating water rates in a manner to be able to continue to provide City services and for the protection of the public health, safety and welfare of its citizenry.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals are incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That Section 94-171 ("Established; Due date") of Division 1 ("Generally") of Article V ("Water Systems") of Chapter 94 ("Utilities") of the Municipal Code of Calumet City, Illinois, is hereby amended by deleting the stricken language and adding the following underlined language to read, as follows:

Sec. 94-171. Established; due date.

The rate for all water supplied by the city, to users who reside within the corporate boundaries of the city, payable on the first day of each period shall be three dollars and thirty-four cents (\$3.34) six dollars and sixty cents (\$6.60) per one thousand (1,000) gallons of water used starting January February 1, 2007 15 or at such time thereafter upon the establishment and phased in issuance of a monthly bill cycle for water and sewer services to a user. The rate for all water supplied to those who reside in an unincorporated area, the rate shall be four dollars and eighty-one cents (\$4.81) seven dollars and sixty cents (\$7.60) per one thousand (1,000) gallons of water used starting January February 1, 2007 15.

In addition starting May 1, 2008 February 1, 2015, fees shall be adjusted upward or downward consistent with the Consumer Pricing Index—Chicago Region using the annual calendar year from the preceding year in which new rate increase or decrease is to take place automatically if the City of Hammond raises the water rates for the City and such adjustments will be administered by the director of finance. The dollar adjustment for the unincorporated purchasers of water will be the same amount as those living within the corporate boundaries of the city.

Section 3. That Section 94-71 ("Bills; penalty for late payment; persons liable") of Article III ("Collection of Water and Sewer Bills") of Chapter 94 ("Utilities") of the Municipal Code of Calumet City, Illinois, is hereby amended by deleting the stricken language and adding the following underlined language to read, as follows:

Sec. 94-71. Bills; penalty for late payment; persons liable.

Bills for water and sewer services shall be rendered monthly quarterly and shall be delinquent ten (10) days after the due date stated on the bill. In the event of failure to pay the bills within the said ten-day period, an additional ten (10) percent shall be added to the bill. Accounts not paid within twenty (20) days of the due date stated on the bills shall be designated for disconnection. The owner of any premises to which any water and sewer service is rendered is liable to pay for such service and such service is to be provided by the city, regardless of any separate private agreements that the owner may maintain with a third-party liability.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 5. All ordinances, resolutions, motions or orders in conflict with this

Alderman Jones discussed item on the billing listing from Broad Street Studios relative to the pink ribbons and the overtime incurred.

Mayor Michelle Markiewicz Qualkinbush stated that the expenditure from Broad Street Studio didn't require council action prior to be approved and it was approved under the normal purchasing procedures.

UNFINISHED BUSINESS

Water Rate Increase

Alderman Jones addressed the council regarding water rate increase.

At this time in the meeting Mayor Michelle Markiewicz Qualkinbush discussed water rate increase followed by a lengthy discussion.

Mayor Michelle - statement

Mayor Michelle Markiewicz Qualkinbush: "I would like to address the statements and would like my comments for the record. It is truly unfortunate that Alderman Jones who has served as the Public Utilities Chairman which pays \$600.00 a month and has been aware of the financial impact of this increase passed onto us by the City of Hammond but he chose not to have a committee meeting in two years about anything. Not one public utilities committee meeting.

In fact, Alderman Jones had a private meeting with the Finance Director during this past summer during budget time and two years ago we were all made aware of that increase and he didn't address it.

I said as a point of information and I will address those comments. Alderman Jones you are saying that I introduced and put an ordinance on this floor alderman and you are lying Alderman just like you did in your robo call.

Ald Jones - statement

Alderman Jones: "For the record and fact residents. Two years ago I addressed this city council and said we need to deal with this water issue. For a fact I had a meeting with Finance Director Kasperek and met in these chambers addressing these issues. For a fact there is almost \$500,000 of discrepency in the Water Fund which I address at a city council meeting.

For a fact the Mayor introduced an ordinance and suggested that we increase the water rates 73 percent. For a fact in January residents will be called on to pay 73 increase in your water bill. For fact it is true that the City of Hammond and the City of Chicago raised the water rates.

Two years ago I suggested this city council deal with it. There is other ways to deal with it. I have addressed many tough votes. This vote I am not voting on because there is discrepency in the Water Funds. You can't go from 5 million dollar surplus two years to almost a 3 million dollar deficit now.

The Mayor wants to address those issues but residents should be concerned that 73 percent on your water bill you have to blame the Mayor and this City Council for doing that. I voted no. I would have yes if I would have got the answers that the Mayor stated that at this public meeting that an audit would have been done on the water fund.

I did call meetings. There is aldermen that haven't had meetings as committee chairman as well. Since the Mayor wants to make that an issue. We all work together collectively when it comes to our water funds and our meetings.

I addressed this city council almost two years ago and suggested we deal with this water increase and we didn't. I am voting no. I had the right to vote no. I explained this to residents and it wasn't like I was hiding it.

If you got your feelings hurt about me telling residents that there will be a 73 percent increase we all should have had town hall meetings and told our residents that there was 73 percent increase in the water rates.

We all should have did that. We didn't do that. I addressed at the time. I didn't want to make that an issue tonight Mayor. I simply wanted to make sure that the issues on this agenda was heard probably and you went into a tyrate. Addressing the residents there will be a 73 percent increase on your water bill in January."

I would like to now finished my report Mayor unless you are going to have another point of order?"

Install lights/Sibley Blvd.

Alderman Jones requested from the State of Illinois to install lights on Sibley Boulevard and 94. This will address residents who had concerns on Stony Island and Prairie Avenue. He will forward information to the city engineer.

IDOT will also be out to cut grass around the ramp at 94 by Stony Island and Sibley Boulevard.

Tickets from his office are \$9.00. Any residents interesting in attending the circus stop by his ward office or the City Clerk's Office.

Recognize wife & son

Alderman Williams recognized his wife and son who attended their first council meeting.

Ald. Munda - statement

Alderman Munda: "I would like to cover some bullet points in regards to the water increase. We were all aware of the water rate increases from Hammond. I want to clarify for the record.

The order of operations in the city and the city council. Information on these types of items and these type of issues come directly from the committees.

Alderman Woscyznski as the Finance Committee Chairman advises us of a committee meeting and then brings the information in regard to the budget to the city council and relays the information to the council so we can go home and digest that information. Then come back at a later meeting and vote on those issues.

To sit here and argue about not knowing about the water rate increases or that a certain alderman not raise the water rates or was aware and no one else wanted to do anything because we should have done this a long time ago.

The proper place for that in my opinion would be at public utilities meeting in regard to the water rate increases at the time that there happening. They didn't happen last year or anytime this year. To sit here and vote against the water rate increases knowing that if we don't raise those water rates and the city continue to absorb those costs next year during budget there will be a huge whole in our budget and inhibit us from doing other things with those funds.

If an issue comes up with public works like some new vehicles that were purchased that should be discussed at the public works committee and then send to the city council to be approved."

Ald. Collins - report

Alderman Collins: "No one wants to raise taxes and no one wants to give residents additional fees. I have spoken to the Finance Director and we have been going through this. According to the numbers that I have been presented with 2 ½ million dollar deficit. Roughly \$6,000 per day is what the city is responsible for.

Now this issue we are your elected officials until 2017. We can string issues out until you seat your next city council. We can push it onto somebody else. I can grand stand and say I am not voting on this issue. Everyone has a right to vote how they want to vote.

But we have to look at the numbers and according to what I have been presented with \$6,000 a day this city is on the hook for. Yes this probably could have been addressed early. The fund was solid and we had those numbers. It is a tough decision especially when people are in financial situations. You elect us to make these decisions. I have gotten phone calls and spoke to residents.

These things are being imposed on us. Really the southland we are not exempt. I am not opposed to the City of Chicago or Hammond charging fair rates so that we can support the infrastructure so we can pay for labor and delivery of the water.

We don't have any regulation in the southland. We don't have a body to govern or fight and speak with the City of Chicago that can really give us relief.

I think this issue go to the state legislature. I don't know how far it went. We do have an issue with this. There was not another choice.

I don't foresee anyway that we can up 2 ½ million dollars and we have to try to make the decisions to keep the city solvent. I am doing what I am elected to do. It is a tough choice and I don't want to raise taxes. The water rate has been increased. I am sure that this city council if there is any way we can re-visit or find other ways to realize to bring in money that would be my goal."

Garden House parking

Alderman Collins stated for the residents of Garden House on Ring Road that parking is available at Target for your guest until 12 midnight. He has spoken to the Manager

The owners of the Garden House are not willing to make available additional parking. They are landlocked unless that want to create other spaces on their grassy areas.

He will be meeting with Sam's Club to discuss parking with them.

Mayor Michelle-statement

Mayor Michelle Markiewicz Qualkinbush: "The City Council is not raising taxes that has been put out in a robo call. What we are raising are the fees that the increase in the fees that were passed on to this city by the City of Hammond.

Residents understand that every community around us South Holland, Chicago Heights, Dolton, Lansing, Lynwood, Homewood, Blue Island they all have been hit by this increase. They have been relentless. They haven't even tried to negotiate with our finance team when they went to talk to the City of Hammond.

It is unfortunate but it is something that we had to do. I want to make it clear we are not raising taxes. In fact, the city council hasn't raised taxes in two years.
