The City Council of the City of Calumet City met in the City Council Chambers at City Hall in a Regular Meeting on Thursday, October 8, 2015 at 7:35 p.m. with Alderman Wosczynski, present and presiding.

REPORTS OF STANDING COMMITTEES

Alderman Wosczynski had no report.

### Public Utilities

Alderman Jones: "There was a meeting held on Tuesday, October 6, 2015. There was an extensive agenda. Part of the agenda focused on the proposed amendment to the water bill late fee.

Although we didn't come to an agreement. I know many residents come up here this city council almost every council meeting complaining about the water bill and the late fees.

Many of those residents have placed the blame on City Clerk Nyota Figgs. I just thought tonight that it is important that many of you receive a time line or know about the time line of how this water bill, and I will be brief, because I know we have to get into the meeting. Just to know where we are and who voted.

I will repeat this in deference to the Mayor, she is not here tonight, but I will make sure to repeat this at the next city council meeting just to make sure that the Mayor has an opportunity to respond.

On September 29, 2014 Mayor Michelle proposed that the city council raise the water rates due to Hammond raising the rates on local communities including Calumet City.

At the time of that, I request and some of my colleagues requested that we consider implementing in phases instead of increasing the water rate 243% on residents. I voted against that and many others voted against that.

On December 29, 2014, the city council voted and raised the water rates, 243%.

On January 12, 2015, Mayor Michelle ordered the City Clerk to begin monthly water billing without the city council voting to approve the monthly water billing.

On February 10, 2015, the city council voted 4-3, to approve changing the water billing from quarterly billing to monthly billing where late fees were added.

On or around March 15, 2015, the city began collecting late fees.

On Wednesday, April 8, 2015, the city council voted to amend the water ordinance to change the late fee from \$50.00 to \$35.00.

The ordinance that many of you referenced had numerous errors which had the 14 day grace period that charges residents unfairly.

As Public Utilities Chairman, I am in charge in making sure that the Public Utilities Committee not only discusses water improvement, but also water rates.

Some of these items were in Public Utilities Committees that I voted against with increasing the water rates and late fees.

The end result of the Mayor rushing the passage of the water ordinance, of course, have been late fees.

This disastrous issue with the 14 day grace period, and plain and simple, this process was rushed by the Mayor and the blame should be squarely put on the Mayor, not the City Clerk.

I believe coming up, the Mayor is calling a special city council meeting to address and ask this city council to fix some of the mistakes of this water rate that was rushed.

I am going to ask my colleagues, not only not to attend that meeting, but make sure that any items that are containing those late fees be put on a regular city council meeting and not a special meeting so residents can attend.

I will submit this report, along with the dates of the meetings that resident can have of all of the items that I just explained, so that you will know for sure everything that happened and why we are at this point with late fees, with the water rate increase. So you know, how this city council moved forward with increasing rates.

That will conclude my public utilities report and I will submit this report to the City Clerk for the record."

### ORDINANCE NO.: \_\_15-41

### AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

**BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

### 513 Freeland Avenue

**Section 2.** The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
