# AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

**BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

#### 574 Freeland Avenue

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

- **Section 3**. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
  - **Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
  - **Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

# AN ORDINANCE AMENDING CHAPTER 14 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS (BUILDING AND BUILDING REGULATIONS)

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interests of the City; and

WHEREAS, the Corporate Authorities are charged with the responsibility of regulating traffic and parking in a manner to provide for the protection of the public health, safety and welfare of its citizenry.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1**. That the above recitals are incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. Section 14-751 ("Definitions") of Article XI ("Fences") of Chapter 14 ("Building and Building Regulations") of the Municipal Code of Calumet City, Illinois is hereby amended by including the underlined language to read as follows:

<u>Public Safety</u> means any organization including but not limited to; emergency management agencies, law enforcement agencies, fire departments, rescue squads, and Emergency Medical Services (EMS).

Public Safety Personnel includes police officers, peace officers, firemen, fire fighters, emergency medical technicians - ambulance, emergency medical technicians - intermediate, emergency medical technicians - paramedic, ambulance drivers, and other medical assistance or first aid personnel.

Lock means a mechanism for keeping a door, lid, etc., fastened, and typically operated only by a key of a particular form.

Section 3. Section 14-758 ("Gate required") of Article XI ("Fences") of Chapter 14 ("Building and Building Regulations") of the Municipal Code of Calumet City, Illinois is hereby amended by including the underlined language to read as follows:

- (a) A gate or opening shall be provided in all fence enclosures.
- (b) No lock, padlock or any device as defined in section 14-751 shall be placed on any gate or fence to prohibit ingress or egress of public safety personnel as defined therein.
- **Section 4**. The Commissioner of Housing is hereby authorized and directed to position the proper signs in accordance with the terms and conditions of this Ordinance.
- **Section 5.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.
- Section 6. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 7**. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

- Section 2. That Section 90-604(a) of 90-604 (Zone designations Residential permit parking zones) of Article IX ("RESIDENTIAL PERMIT PARKING") of Chapter 90 ("Traffic and

Vehicles") of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the underlined language to read, as follows:

159<sup>th</sup> Street on the north side of the street from 32 159<sup>th</sup> Street westbound to Legion Drive.

All of Forestdale Park.

Legion Drive on both sides of the street northbound from Michigan City Road to Detroit Street.

Michigan City Road on the north side of the street from Legion Drive to Wentworth Avenue.

- **Section 3**. The Commissioner of Streets and Alleys is hereby authorized and directed to position the proper signs in accordance with the terms and conditions of this Ordinance.

AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS (NO PARKING ON THE SOUTH SIDE OF MICHIGAN CITY ROAD FROM STATELINE ROAD WEST TO WENTWORTH AVENUE; ON THE NORTH SIDE OF MICHIGAN CITY ROAD FROM STATELINE ROAD WEST TO LEGION DRIVE; ON BOTH SIDES OF STATELINE ROAD FROM HIGHLAND TO MICHIGAN CITY ROAD; ON 159TH STREET AT STATELINE ROAD AROUND THE ENTIRE DEAD END CUL-DE-SAC; AND ON 159TH STREET SOUTH FROM STATELINE ROAD TO LEGION DRIVE ON THE SOUTH SIDE OF THE STREET)

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interests of the City; and

WHEREAS, the Corporate Authorities are charged with the responsibility of regulating traffic and parking in a manner to provide for the protection of the public health, safety and welfare of its citizenry.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1**. That the above recitals are incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That Section 90-301(1) ("Stop, stand or park a vehicle") of Division 1 ("Generally") of Article V ("Stopping, Standing and Parking") of Chapter 90 ("Traffic and Vehicles") of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the underlined language to read, as follows:

On the South side of Michigan City Road from Stateline Road West to Wentworth Avenue.

On the North side of Michigan City Road from Stateline Road West to Legion Drive.

On both sides of Stateline Road from Highland to Michigan City Road.

On 159<sup>th</sup> Street at Stateline Road around the entire Dead End Cul-De-Sac.

On 159th Street South from Stateline Road to Legion Drive on the South side of the street.

**Section 3**. The Commissioner of Streets and Alleys is hereby authorized and directed to position the proper signs in accordance with the terms and conditions of this Ordinance.

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

**Section 5.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6**. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

# Ord #3: amending Chap. 6 Alcoholic Liquor

Alderman Collins: "For the benefit of my colleagues that weren't present at the meeting, Alderman Jones and Alderman Munda. The ordinance that is before you that was placed on with the modifications that were made. There were changes made tonight.

Mayor Michelle Markiewicz Qualkinbush: "The committee is recommending changes to this ordinance."

That was a 3-0 recommendation of the Ordinance & Resolution Committee."

Mayor Michelle Markiewicz Qualkinbush: "And that they be required to use Calumet City Police Officers."

Alderman Collins: "Yes thank you Mayor. Also at this location anytime there is a banquet where alcohol is present, this business would be required to use a Calumet City off-duty police officer and pay them for secondary employment.

Those are the items that were not represented in the ordinance that is before you that was referred by the Ordinance & Resolution Committee tonight.

If my colleagues would like a few minutes to look it over or if this is the desire to take some sort of other action."

### Adopt Ordinance #3

Alderman Collins moved, seconded by Alderman Jones, to adopt Ordinance #3 as presented, with the amendment that the license be non-transferrable, that it require that a Calumet City Police Officer be hired under secondary employment for any event held at that location.

Mayor Michelle Markiewicz Qualkinbush: "Alderman, with all due respect that is why they had the committee meeting."

Mayor Michelle Markiewicz Qualkinbush: "So your motion is only on city wide. It is not on ward ones, correct? You said city wide."

Alderman Jones: "I will clarify that and put the motion in writing just so we are clear and not to interject or harm the aldermen who don't want to do it. I will withdraw my motion and put it on the agenda so it is clear and we have time to look at it aldermen."

Mayor Michelle Markiewicz Qualkinbush: "That is why motion should be on the agenda. Thank you."

#### Withdraw motion

Alderman Jones moved, seconded by Alderman Collins, to withdraw the motion that all elected officials, that no publication go out in the City of Calumet City that doesn't have or include all elected officials city wide.

**MOTION CARRIED** 

Alderman Munda: "I thought the point of discussion was city wide literature. Because there was an incident of city wide literature that did not possess all our names on it.

Now in the past I would like someone to produce a piece of literature in a single ward that didn't have all the elected officials names on it. The discussion here is not about single ward literature.

We always put Treasurer Tarka, City Clerk and Madam Mayor on the literature."

Mayor Michelle Markiewicz Qualkinbush; "Alderman, that is not true."

Alderman Munda: "Could you produce the incident in which the ward piece had not included all the elected officials for a ward cleanup or something that went on in a specific ward.

I thought the point of discussion was a specific piece that went out city wide that didn't have all our names on it. I would like to see that one as well. Then we can crush it at the next meeting."

Alderman Jones: "And it was. I will make sure, I am sure the most glaring piece that will be produced as evidence will probably the 3<sup>rd</sup> Ward Newsletter that didn't have the city wide officials on it but had city officials in it.

That probably be the most glaring piece of evidence that will be produced."

Alderman Munda: "Alderman Jones with all due respect, I don't think I should be on your 3<sup>rd</sup> Ward Newsletter. Why do your residents need to see my name and face from all the way from the other side of town in a newsletter that doesn't have anything to do with what I am doing in my ward.

It is all about you and your ward and that is the name and face that should be on there and the city wide elected officials, Treasurer Tarka, City Clerk Figgs and Madam Mayor Michelle Markiewicz Qualkinbush should be on there as city wide elected officials in your one specific ward.

I don't need to be on there. I have nothing to do in your ward. You are the alderman. I have nothing to do with your newsletter unless I am doing something over there. Maybe I will do some cartwheels through your ward next week."

Alderman Jones: "I will make sure the motion is clear that is on the next agenda an possibly put two motions on there that has both and we can all vote up or down at it.
