ORDINANCE NUMBER 17-17

AN ORDINANCE AUTHORIZING THE REZONING OF PROPERTY COMMONLY KNOWN AS 383 YATES AVENUE FROM R-1 SINGLE FAMILY RESIDENTIAL DISTRICT TO R-2 TWO AND THREE FAMILY RESIDENTIAL DISTRICT IN THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, Tyeisha Spruiell (the "Applicant"), the contract purchaser of the property commonly known as 383 Yates Avenue, Calumet City, Illinois, which is legally described on Exhibit A (the "Property"), a copy of which is attached hereto and made a part hereof, filed a petition requesting a map amendment to rezone the Property from R-1 Single Family Residential District to R-2 Two and Three Family Residential District; and

WHEREAS, the Zoning Board of Appeals (the "Zoning Board") caused the appropriate notices to be published and mailed in accordance with the City Code; and

WHEREAS, on February 15, 2017, the Zoning Board held a public hearing to hear testimony and consider said petition, along with all other requested and supporting documents submitted by the Applicant; and

WHEREAS, after an examination of the issues and exhibits as well as the testimony presented before the Zoning Board, the members of the Zoning Board deliberated and recommended the zoning map amendment to the Mayor and City Council of the City of Calumet City (the "Corporate Authorities").

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The written findings of fact and recommendation of the Zoning Board relative to the petition to rezone the Property are hereby accepted and incorporated herein and made a part hereof, as Exhibit B, as if fully set forth in their entirety. All documents and exhibits submitted at the aforesaid public hearing are also incorporated by reference into this Ordinance.

Section 3. The Property, in accordance with the findings of fact and recommendations of the Zoning Board as herein set forth, is hereby rezoned from R-1 Single Family Residential District to R-2 Two and Three Family Residential District and the zoning map of the City is hereby amended in accordance thereof.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

Findings of Fact and Recommendation

0.0752 BOS. 6039

FINDING OF FACT AND RECOMMENDATIONS

Having deliberated and considered all the evidence on record, in the matter of granting a Zoning Classification Change from R1 Residential to R2 Residential for the property located at 383 Yates Avenue, Calumet City, Illinois, the Zoning Board of Appeals finds as follows:

That the granting of a zoning classification change will not impede the normal and orderly development and improvement of surrounding property for uses permitted in the district;

That the circumstances are not of the applicant's making;

That the granting of a zoning classification change mitigates unusual site conditions in that the property in question is obviously an apartment building and not a single family structure;

That the granting of a zoning classification change would not reduce property values of the surrounding neighborhood;

That the property in question is not incongruous with the existing uses of property within the general area;

That the description of the property reflects an R2 Residential zoning classification rather than the current R1 Residential zoning classification;

That the granting of a zoning classification change is consistent with the spirit and intent of the Calumet City Zoning Ordinances;

That without the granting of a zoning classification change, the petitioner would experience financial hardship;

That with the granting of a zoning classification change, the property shall in all other respects conform to the applicable regulations of the rezoning, except as such regulations may in each instance be modified by the City Council pursuant to the recommendations of the Zoning Board of Appeals.

THEREFORE, recognizing that the granting of a zoning classification change from R1 (Single Family Residential) to R2 (Two and Three Family Residential) for the property located at 383 Yates Avenue, Calumet City, Illinois, would not traditionally affect the public interest in an untoward manner, the Board finds that the petitioner has submitted sufficient evidence favoring the granting of a zoning classification change.

Having determined that the granting of a zoning classification change from R1 Residential to R2 Residential is appropriate and the Findings of Fact and the evidence presented support the petition, the Board voted in open session with six (6) ayes, zero (0) nays and zero (0) members absent. The Zoning Board of Appeals hereby recommends to the Mayor and City Council, that a zoning classification change from R1 Residential to R2 Residential be granted for the property located at 383 Yates Avenue, Calumet City, Illinois, this 15th day of February, 2017.
