Cook County Department of Transportation and Highways - Call for Projects FY 2018

Resolution No. 18-5

WHEREAS, the City of Calumet City, is applying to the County of Cook for an "Invest in Cook" grant and will commit to a 20% match of the total project cost,

WHEREAS, the City of Calumet City, submits an eligible project for funding consideration that is consistent with the priorities set forth in "Connecting Cook County",

WHEREAS, the project presented consists of the installation of pedestrian lighting along Sibley Boulevard between I-94 and Torrence Avenue,

WHEREAS, the project presented expands Cook County's involvement in multimodal projects that take stock of transportation assets and measures them against community and economic opportunities,

WHEREAS, the project presented meets the specific priorities of the Invest in Cook program relative to *Transit* and *Traffic Flow Improvement Projects*, and

WHEREAS, it is necessary that an application be made and agreements be entered into with the County of Cook.

NOW, THEREFORE, BE IT RESOLVED AS follows:

- 1. that the City of Calumet City applies for a Cook County Department of Transportation and Highway grant under the terms and conditions of the County of Cook, and shall enter into (and agree to) the understandings and assurances contained in said application and program;
- 2. that the Mayor and Village Clerk of the City of Calumet City, on behalf of the City of Calumet City, execute such documents and all other documents necessary for the carrying out of said application and program; and
- 3. that the Mayor and Village Clerk of the City of Calumet City are authorized to provide such additional information as may be required to accomplish the obtaining of such grant and the management and facilitation of the program.
