



**AN ORDINANCE AMENDING SECTIONS 11.3(f) AND 11.12(b)  
OF THE CITY OF CALUMET CITY ZONING CODE  
(SIGN REGULATIONS)**

**WHEREAS**, the City of Calumet City, Cook County, Illinois (the “City”) is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the Mayor and City Council of the City of Calumet City (the “Corporate Authorities”) may from time to time amend the text of the City Code of the City of Calumet City when it is determined to be in the best interests of the residents of the City; and

**WHEREAS**, the Corporate Authorities find is in the best interest of the health, safety and welfare of the City to amend the sign regulations of the City.

**NOW THEREFORE BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** Section 11.3(f) of Appendix B of the City of Calumet City Zoning Code (Sign Regulations) is hereby amended by deleting the stricken language and adding the underlined language, as follows:

*(f) Enforcement Authorization of Legal Non Conforming Signs:* Legal non-conforming signs shall be removed or modified to conform with this ordinance within 24 12 months from the effective date of this ordinance. Legal, nonconforming signs may not be structurally altered, enlarged, or expanded in any way which would increase their nonconformity.

**Section 3.** Section 11.12(b) of Appendix B of the City of Calumet City Zoning Code (Sign Regulations) is hereby amended by adding the underlined language, as follows:

*(b) Application; fee.* Application for a license for each sign shall be made in writing to the city clerk and shall be accompanied by a list of all such places, including billboards or natural structures, on which it is intended to place a sign or advertisement. This list shall be added to from time to time by the licensee as a right to post or place an advertisement or sign at additional places. The annual fee for such license for each sign shall be seventy-five dollars (\$75.00).

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

**Section 2:** That Chapter 90 (“Traffic and Vehicles”), Article VIII (“Vehicle License”), Section 90-582 (“Required”) of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the underlined language, as follows:

It shall be unlawful for any person residing in the city, or for any firm, association or corporation having its principal office or place of business in the city, to use, or to cause or permit any of his, her, their or its agents or employees to use, any motor vehicle in the transportation of persons or property or the conveyance of loads upon the street, avenues, or alleys of the city unless such motor vehicle is licensed as

provided in this article.

All motor vehicles registered to an address in the City, titled in the name of one or more owners who reside in the City, or which are stored or housed in the City, are required to display a current license as provided by this Article.

**Section 3:** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4:** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.







**Section 1.** That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

392 Luella Avenue

**Section 2.** The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.



**Section 1.** That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

352 Campbell

**Section 2.** The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.


**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.






