A Special Meeting is being called for Thursday, June 6, 2019, at 6:30 pm for consideration and possible action on the following:

Section 54-34 of the Municipal Code provides that the Mayor can order a business license application to be presented and approved by the City Council before issuance of a permit or license. I am ordering the following business license applications be presented to the City Council for the following reasons:

Application for a business license for Family Discount 1661-1663 Sibley Blvd.

- On April 15, 2019, the Calumet City Police Dept. executed a search warrant at this location and the business was closed as a result of this case and the agent/manager (who is the brother of the owner of the property) was charged with possessing and selling cannabis (11 lbs.) and selling cigarettes with improper tax stamps.
- Motion to deny or restrict any business to operate at this location pending the thorough investigation into the character of the new applicant applying for the new business license. (Section 54-35 of the municipal code)
- Direct the City Attorney to research an ordinance amendment stating that if a business license is revoked, the same or similar type of business cannot be operated at that location for one year.

Application for a business license for Expol Holdings, 2000 Dolton Road

- o Business license was issued in error without filling out business application properly
- Reapplied for a license which was denied as zoning does not allow for this type of business
- Motion to order this business to vacate from property within 10 days.
- Ord. 18-14 provides that a business license shall not be issued for the conduct of any business if the property does not fully comply with all requirements of the City, including indebtedness owed to the City.

- 2) Ordinance designating a One Way Street Street for Northbound traffic only Merrill Avenue, Wilson Avenue northbound to Sibley Boulevard.
- 3) Ordinance limiting the amount of Grocery Convenient stores on the Southside of Sibley Blvd from Jeffery Ave to Yates Ave.
- 4) Ordinance banning the sale of any type of tobacco products on the Southside of Sibley Blvd from Jeffery Ave to Yates Ave.
- 5) Ordinance imposing a temporary moratorium on the issuance of licenses for convenient and grocery stores on Southside of Sibley Blvd from Jeffery Ave to Yates Ave.
- 6) Ordinance stating that, replicating business licenses for the same or similar service shall not be issued or allowed to apply, if within 1000 ft. of another such business providing the same, or similar services (excluding gas stations and restaurants), on the south side of Sibley Blvd between Jeffery Ave East to Yates Ave. or without express consent from the City Council
