## AN ORDINANCE AMENDING CHAPTER 62 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS BY ADDING RETAIL THEFT: IMPOUNDMENT

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interest of the City; and

WHEREAS, the Corporate Authorities are charged with the responsibility of providing for the protection of the public health, safety and welfare of its citizenry.

**NOW**, **THEREFORE**, **BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2: That Chapter 62, OFFENSES AND MISCELLANEOUS PROVISIONS, ARTICLE I- IN GENERAL of the Municipal Code of Calumet City, is amended by adding the underlined section 62-22 below:

#### A) 62-22 RETAIL THEFT: IMPOUNDMENT

Any motor vehicle that is used in the commission of the offense of retail theft in violation of Section 5/16-25 of the Illinois Compiled Statutes (720 ILCS 5/16-25) and pursuant to Section 5/11-208.7 of the Illinois Compiled Statutes (625 ILCS 5/11-208.7

- (12) shall be subject to seizure and impoundment pursuant to Section 62-8 of this Code.
- B) Whenever a police officer has probable cause to believe that a vehicle is subject to seizure and impoundment pursuant to this section, the police officer shall provide for the towing of the vehicle to a facility controlled by the city or its agents. When the vehicle is towed, the police officer shall notify the person who is found to be in control of the vehicle at the time of the alleged violation, if there is such a person, of the fact of the seizure and of the owner's right to request a preliminary hearing to be conducted pursuant to section 62-8 of the Code.
- This subsection shall not apply: (1) if the vehicle used in the violation was stolen at the time and the theft was reported to the appropriate police authorities within twenty-four (24) hours after the theft was discovered or reasonably should have been discovered; or (2) if the vehicle is operating as a common carrier; or (3) the alleged owner provides adequate proof that the vehicle had been sold to another person prior to the violation.
- D) The provisions of section 62-8 of this Code shall apply to any motor vehicle seized and impounded pursuant to this section.
- E) For purposes of this section, the "owner of record" of a vehicle is the record titleholder.

Section 3: If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4: All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5:** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

Section 2: That Chapter 62, OFFENSES AND MISCELLANEOUS PROVISIONS, ARTICLE I-IN GENERAL of the Municipal Code of Calumet City, is amended by adding the underlined section 62-21 below:

#### A) 62-21 NO VALID DRIVER'S LICENSE: IMPOUNDMENT

Any motor vehicle that is used in the commission of the offense of driving without a valid driver's license in violation of Section 6-101 of the Illinois Vehicle Code (625 ILCS 5/6-101) shall be subject to seizure and impoundment pursuant to Section

- 62-8 of this code and Section 5/11-208.7 of the Illinois Compiled Statutes (625 ILCS 5/11-208.7). This section shall only apply to those operating a motor vehicle with an expired driver's license if the period of expiration is greater than one (1) year or if the operator of the motor vehicle had never been issued a driver's license or permit.
- B) Whenever a police officer has probable cause to believe that a vehicle is subject to seizure and impoundment pursuant to this section, the police officer shall provide for the towing of the vehicle to a facility controlled by the city or its agents. When the vehicle is towed, the police officer shall notify the person who is found to be in control of the vehicle at the time of the alleged violation, if there is such a person, of the fact of the seizure and of the owner's right to request a preliminary hearing to be conducted pursuant to section 62-8 of the Code.
- This subsection shall not apply: (1) if the vehicle used in the violation was stolen at the time and the theft was reported to the appropriate police authorities within twenty-four (24) hours after the theft was discovered or reasonably should have been discovered; or (2) if the vehicle is operating as a common carrier; or (3) the alleged owner provides adequate proof that the vehicle had been sold to another person prior to the violation.
- D) The provisions of section 62-8 of this Code shall apply to any motor vehicle seized and impounded pursuant to this section.
- E) For purposes of this section, the "owner of record" of a vehicle is the record titleholder.

Section 3: If any section, paragraph, clause or provision of this Ordinance shall be held

- Vehicle Code (625 ILCS 5/11-204.1) shall be subject to seizure and impoundment pursuant to Section 62-8 of this Code and Section 5/11-208.7 of the Illinois Compiled Statutes (625 ILCS 5/11-208.7).
- B) Whenever a police officer has probable cause to believe that a vehicle is subject to seizure and impoundment pursuant to this section, the police officer shall provide for the towing of the vehicle to a facility controlled by the city or its agents. When the vehicle is towed, the police officer shall notify the person who is found to be in control of the vehicle at the time of the alleged violation, if there is such a person, of the fact of the seizure and of the owner's right to request a preliminary hearing to be conducted pursuant to section 62-8 of the Code.

AN ORDINANCE AMENDING CHAPTER 62-8 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS BY ADDING AGGRAVATED FLEEING OR ATTEMPTING TO ELUDE A PEACE OFFICER; NO VALID DRIVER'S LICENSE AND RETAIL THEFT: IMPOUNDMENT

**WHEREAS**, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and the City Council of the City of Calumet City (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of Calumet City when it is determined to be in the best interest of the City; and

**WHEREAS**, the Corporate Authorities are charged with the responsibility of providing for the protection of the public health, safety and welfare of its citizenry.

**NOW**, **THEREFORE**, **BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2: That Chapter 62, OFFENSES AND MISCELLANEOUS PROVISIONS, ARTICLE I- IN GENERAL of the Municipal Code of Calumet City, is amended by adding the underlined section 62-8. (1) below:

#### A) 62-8. VEHICLE IMPOUNDMENT.

(1) The owner of a vehicle seized and impounded pursuant to section 62-9, driving while intoxicated; section 62-10, unlawful drugs in motor vehicle; section 62-11, use of vehicle for prostitution; section 62-12, unlawful firearm in motor vehicle; section 62-13, illegal dumping; section 62-14, sound device restrictions; section 62-15, unlawful fireworks in motor vehicle; or section 62-16, false, stolen, or altered state registration or temporary state registration; or section 62-18, driving on a suspended or revoked license; or section

62-20, aggravated fleeing or attempting to elude a peace officer; or section 62-21, no valid driver's license; or section 62-22, retail theft; of this Code and pursuant to any section of this Code which expressly makes this section applicable, shall be assessed an administrative penalty in the amount of five hundred dollars (\$500.00), towing and storage fees, any other fees deemed applicable and shall have the right to request a preliminary hearing in person and in writing at the city police department within fifteen (15) days after the vehicle is seized and impounded.

**Section 3:** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4:** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5:** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows: 545 Superior, 565 Paxton, 505 Bensley

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

AN ORDINANCE AMENDING CHAPTER 82 (TAXATION) OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY TO IMPOSE A MUNICIPAL CANNABIS RETAILERS' OCCUPATION TAX

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Illinois Cannabis Regulation and Tax Act, P.A. 101-0027, allows the City to enact reasonable regulations governing cannabis business establishments; and

WHEREAS, the Municipal Cannabis Retailers' Occupation Tax Law, 65 ILCS 5/8-11-22, permits the City to impose a tax upon all persons engaged in the business of selling cannabis, other than cannabis purchased under the Compassionate Use of Medical Cannabis Pilot Program Act; and

WHEREAS, the Mayor and City Council (the "Corporate Authorities") seek to implement a municipal cannabis retailers' occupation tax in accordance with Illinois law; and

WHEREAS, the Corporate Authorities find it to be in the best interest of the City to amend Chapter 82 (Taxation) of the Municipal Code of the City of Calumet City to impose a municipal cannabis retailers' occupation tax.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Ord. #19-50

**Section 1:** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2: That Chapter 82 (Taxation) of the Municipal Code of the City of Calumet City, Illinois is hereby amended by adding the following section:

#### ARTICLE XVI: MUNICIPAL CANNABIS RETAILERS' OCCUPATION TAX.

#### Sec. 82-532. Tax Imposed.

- (a) A tax is hereby imposed in accordance with the provisions of Section 8-11-22 of the Illinois Municipal Code upon all persons engaged in the business of selling cannabis at retail in the City at a rate of 3% of the gross receipts from the sales made in the course of that business.
- (b) This tax does not apply to cannabis purchased under the Compassionate Use of Medical Cannabis Pilot Program Act.
- (c) This tax is in addition to all other taxes and fees imposed by the City of Calumet City and State of Illinois.

#### Sec. 46-191. Tax Collection.

- (a) The tax imposed by this Ordinance and all civil penalties that may be assessed as an incident of the tax shall be collected and enforced by the Illinois Department of Revenue.
- (b) Persons subject to any tax imposed under this Section may reimburse themselves for their seller's tax liability hereunder by separately stating that tax as an additional charge, which charge may be stated in combination, in a single amount, with any State tax that sellers are required to collect.

#### Sec. 46.192. Records.

Every person who is subject to this tax shall keep and maintain accurate and complete documents, books, and records of each transaction or activity subject to this section, from start to complete, including all original source documents. All such books and records shall

be kept by the owner and shall, at all reasonable times during normal business hours, be open to inspection, audit, or copying by the Mayor or his/her designee.

#### Sec. 46-193. Cannabis License.

If any holder of a City adult-use cannabis business license fails to remain current in the payment of the tax imposed by this section, the adult-use cannabis business license may be suspended or revoked by the local cannabis commissioner or his or her designee, or the Mayor if the position of cannabis commissioner is not established, until said tax is made current. No adult-use cannabis may be sold from said premises until the tax has been paid.

#### Sec. 46.194. Effective Date.

This Ordinance shall be in full force and effect upon its passage, approval, and publication as provided by law, provided, however, that the tax provided for herein shall take effect for all sales on or after January 1, 2020. Copies of this Ordinance shall be certified and sent to the Illinois Department of Revenue prior to September 30, 2019.

**Section 3:** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4: All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
