**ORDINANCE NO.: 20-06**

**AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE  
OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS**

**BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

**Section 1.** That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

239 155<sup>th</sup> Pl.

388 Mackinaw Ave.

661 Exchange Ave.

332 Crandon Ave.

**Section 2.** The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.





**A RESOLUTION OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS,  
REQUESTING GRANT FUNDING FROM THE ILLINOIS DEPARTMENT OF  
RESOURCES (RECREATIONAL TRAILS PROGRAM) SFY2021 / FFY2020**

**Whereas**, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers");

**Whereas**, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") recognize a funding opportunity with Illinois Department of Natural Resources (the "IDNR"), Recreational Trails Program (the "RTP") in cooperation with the US Department of Transportation, Federal Highway Administration (the "US DOT" the "FHWA");

**Whereas**, the RTP funding opportunity provides assistance for acquisition, development, rehabilitation and maintenance of both motorized and non-motorized recreation trails, and the City has identified a scope of work that meets this RTP funding criteria;

**Whereas**, a trail is determined to be a route along a path or road that has been planned and marked for a particular purpose - whereby trails are not sidewalks, park cut throughs, or on-street striping;

**Whereas**, the City is one of the largest communities in the South Suburbs of Chicago as the proposed project will ultimately link to regional trails, whereby improving the quality of life and sustainability of the region;

**Whereas**, there is an equal opportunity to participate in programs of the IDNR and those funded by the US DOT and other agencies is available to all individuals regardless of race, sex, national origin, disability, age, religion, or other non-merit factors;

**Whereas**, RTP is a reimbursement grant program that provides up to 80% project funding and is administered by the IDNR in cooperation with the FHWA, therefore a minimum 20% match (non-federal resources) required from the City; and

**Whereas**, RTP requires a \$300.00 non-refundable application fee at the time of application submission.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

*Section 1.* That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

*Section 2.* The officials and officers of the City are hereby authorized and directed to take any and all such action as is required to enact the submission of the IDNR RTP application and any facilitation efforts.

*Section 3.* If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

*Section 4.* All ordinances, resolutions, motions, or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

*Section 5.* This Resolution shall be in full force and effect upon its passage, approval, and publication as provided by law.

It is understood that the project should be completed within the timeframe established in the project agreement and the Final Billing reimbursement request must be submitted within one year of the expiration date. Failure to do so will result in the Project Sponsor forfeiting all project reimbursements, and relieves DNR from further payment obligations on the grant.

Code 3070) 2) the federal Uniform Relocation Assistance & Real Property Acquisition Policies Act of 1970 (P.L. 91-646) and/or the Illinois Displaced Persons Relocation Act (310 ILCS 40 ct. seq.), as applicable, 3) the Illinois Human Rights Act (775 ILCS 5/1-101 et.seq.), 4) Title VI of the Civil Rights Act of 1964, (P.L. 83-352), 5) the Age Discrimination Act of 1975 (P.L. 94-135), 6) the Civil Rights Restoration Act of 1988, (P.L. 100-259) and 7) the Americans with Disabilities Act of 1990 (PL 101-336); and will maintain the project area in an attractive and safe condition, keep the facilities open to the general public during reasonable hours consistent with the type of facility, cease any farming operations, and obtain from the Illinois DNR written approval for any change or conversion of approved outdoor recreation use of the project site prior to initiating such change or conversion; and for property acquired with Bike Path assistance, agree to place a covenant restriction on the project property deed at the time of recording that stipulates the property must be used, in perpetuity, for public indoor or outdoor recreation purposes in accordance with the Bike Path programs and cannot be sold or exchanged, in whole or part, to another party without approval from the Illinois DNR.

BE IT FURTHER PROVIDED that the City of Calumet City certifies to the best of its knowledge that the information provided within the attached application is true and correct.


