CITY COUNCIL REPORTS

Mayor Michelle Markiewicz Qualkinbush Statement:

"On June 4, 2020 I signed a national pledge created by the Obama Foundation to review and reform police use of force policies in our City. This pledge is part of a national effort to enlist mayors to work within their communities to address this issue in the wake of the death of George Floyd at the hands of Minneapolis police. The pledge calls for city mayors to review their use of force policies, report their findings publicly and seek community feedback, and revise their policies. The Obama Foundation will report back in three months on the progress of each community that has taken the pledge.

"From the killings of George Floyd, Breonna Taylor, Ahmaud Arbery, and the loss of far too many Black lives to list, have left our nation anguished and outraged. More than 1,000 people are killed by police every year in America, and Black people are three times more likely to be killed than White people. We can take steps and make reforms to combat police violence and systemic racism within law enforcement. Together, we can work to redefine public safety so that it recognizes the humanity and dignity of every person.

Mayors and other City Council officials are uniquely positioned to introduce common-sense limits on police use of force. That's why the My Brother's Keeper Alliance is calling on mayors to commit to the following actions, and I Mayor Michelle Markiewicz Qualkinbush pledge:

- 1. I will REVIEW our police use of force policy.
- 2. I will ENGAGE our community by including a diverse range of input, experiences, and stories in my review.
- 3. I will REPORT the findings of the review to our community and seek feedback.
- 4. I will REFORM our community's police use of force policy.

It is my hope that individuals across the country will take action to urge their mayors to take these steps for change."

In addition to taking the Mayor's Pledge, I want to go on record to reinforce the values that we as a City believe in and envision for the present and the future of our City Government:

"Calumet City stands in solidarity against injustice, racism, discrimination, and violence."

As Mayor of Calumet City, I accept the responsibility to lead on this issue."

ORDINANCE NO. ___20-27____

AN ORDINANCE AMENDING ARTICLE I "IN GENERAL" OF CHAPTER 62 "OFFENSES AND MISCELLANEOUS PROVISIONS" OF THE MUNICIPAL CODE OF CALUMET CITY TO AUTHORIZE IMPOUNDMENT OF VEHICLES USED IN LOOTING

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the looting of the City's malls and businesses has a devastating effect on the health, safety and welfare of the City and its citizens and the City has a legitimate interest in deterring the looting of local businesses; and

WHEREAS, the towing and impounding of vehicles involved in criminal activity serves as a significant deterrent to criminal behavior; and

WHEREAS, the offense of looting is a felony under State law, can cause long lasting property and economic damage to business owners, and is often accompanied by other criminal acts; and

WHEREAS, the Mayor and City Council find it to be in the best interest of the City to amend the Municipal Code of the City of Calumet City, Illinois to authorize the towing and impoundment of vehicles used in the commission of the offense of looting.

NOW, **THEREFORE**, **BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their

entirety.

Section 2: Section 62-8(1) "Vehicle Impoundment" of Article I "In General" of Chapter 62 "Offenses and Miscellaneous Provisions" of the municipal code of the City of Calumet City is hereby amended by eliminating the stricken language and adding the underlined language as follows:

Sec. 62-8. - Vehicle impoundment.

The owner of a vehicle seized and impounded pursuant to section 62-9, driving while (1) intoxicated; section 62-10, unlawful drugs in motor vehicle; section 62-11, use of vehicle for prostitution; section 62-12, unlawful firearm in motor vehicle; section 62-13, illegal dumping; section 62-14, sound device restrictions; section 62-15, unlawful fireworks in motor vehicle; ex section 62-16, false, stolen, or altered state registration or temporary state registration; of section 62-18, driving on a suspended or revoked license; or section 62-21, retail theft; section 62-22, no valid drivers' license; section 62-23, aggravated fleeing or attempting to elude a peace officer, or section 62-24, looting, of this Code and pursuant to any section of this Code which expressly makes this section applicable, shall be assessed an administrative penalty in the amount of five hundred dollars (\$500.00), towing and storage fees, any other fees deemed applicable and shall have the right to request a preliminary hearing in person and in writing at the city police department within fifteen (15) days after the vehicle is seized and impounded. A towing adjudicator, appointed by the mayor or the chief of the police department, shall conduct such preliminary hearing within forty-eight (48) hours of the request, excluding Saturdays, Sundays and legal holidays, unless the vehicle was seized and impounded pursuant to section 62-10 and the police department determines that it must retain custody of the vehicle under applicable state or federal

forfeiture law or if the vehicle is being held pending an investigation. If, after the preliminary hearing, the towing adjudicator determines that there is probable cause to show that the vehicle was used in violation of this Code, the towing adjudicator shall order the continued impoundment of the vehicle unless the owner of the vehicle pays to the city the amount of the administrative penalty, plus fees for towing and storing the vehicle, and any other fees deemed applicable. If the vehicle is also subject to immobilization for unpaid final determinations of parking and/or compliance violations, the owner of the vehicle must also pay the amounts due for all such outstanding violations prior to the release of the vehicle. If the towing adjudicator determines that there is no such probable cause the vehicle shall be returned without penalty or other fees.

Section 3: Article I "In General" of Chapter 62 "Offenses and Miscellaneous Provisions" is hereby amended by adding the following section:

Sec. 62-24: Looting by individuals; impoundment.

- (a) A person commits the offense of looting when he or she knowingly without authority of law or the owner, enters any home or dwelling or upon any premises of another, or enters any commercial, mercantile, business, or industrial building, plant, or establishment, in which normal security of property is not present by virtue of a hurricane, fire, or vis major of any kind or by virtue of a riot, mob, or other human agency, and obtains or exerts control over property of the owner.
- (b) Any vehicle used in the commission of the offense of looting in violation of 720 ILCA 5/25-4 shall be subject to seizure and impoundment pursuant to 62-8 of this Code.
- (c) In addition to the administrative penalty of \$500, tow and storage fees, and any other fees deemed applicable pursuant to Sec. 62-8, a fine of \$2000.00 shall be imposed upon the owner of any vehicle seized or impounded for use in violation of this section.
- **Section 4:** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 5: All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6: This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by deleting the following language in subsection G (Signed areas), as follows: 747 Buffalo Ave.

- **Section 2.** The Commissioner of Streets and Alleys is hereby authorized and directed to remove such signs in accordance with the terms and conditions of this Ordinance.
- **Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

A RESOLUTION OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS
SUPPORTING THE CITY OF CALUMET CITY'S APPLICATION FOR COOK COUNTY CLASS 8
REAL ESTATE TAX ASSESSMENT CLASSIFICATION FOR THE PROPERTY LOCATED AT

1717 EAST WEST ROAD, CALUMET CITY, ILLINOIS

(SPECIAL CIRCUMSTANCES)

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and,

WHEREAS, the President and Board of Commissioners of the County of Cook have enacted an ordinance known as the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Classification Ordinance"), which provides for tax assessment incentive classifications designed to encourage development throughout Cook County by offering a real estate tax incentive for the development of new facilities, the rehabilitation of existing structures, and the utilization of abandoned buildings in order to create employment opportunities and expand the tax base; and

WHEREAS, the City of Calumet City is the lessee (the "Applicant") for a certain parcel of property commonly known as 1717 East West Road, Calumet City, Illinois, identified by a certain permanent index number 29-24-200-069-0000 and hereafter legally described on Exhibit A, a copy of which is attached hereto and made a part hereof (the "Property"); and

WHEREAS, the Applicant, has provided the economic disclosure statement and has a lease on said Property with the South Suburban Land Bank and will be procuring a deed for the Property in the near future, which Property has been vacant for over 24 months and qualifies for Class 8 consideration; and

WHEREAS, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") support and consent to the Cook County Class 8 Real Estate Tax Assessment Classification for Property, as said term is defined in the Classification Ordinance (the "Class 8 Tax Assessment Classification); and

WHEREAS, the adoption of a Resolution by the Corporate Authorities is required and must be filed by the Applicant with its application to the County of Cook in order for the Property to receive a Class 8 Tax Assessment Classification which is necessary for future development opportunities; and

WHEREAS, the Corporate Authorities understand that the redevelopment of the Property is occurring greater than a 24-month abandonment period as established in the Classification Ordinance but find that the Class 8

Tax Assessment Classification is essential to the revitalization of the Property due to the existence of special circumstances on the Property; and

WHEREAS, the Corporate Authorities find that the redevelopment and occupation of the Property will only occur if the Class 8 Tax Assessment Classification is authorized in order to overcome the special circumstances that are inherent to the Property; which will continue to thwart any viable redevelopment, including but not limited to: physical condition of the structure; and the proximity of the Property to Indiana; (the "Special Circumstances"); and

WHEREAS, the Corporate Authorities find that the overwhelming financial barriers created by the Special Circumstances can only be mitigated by the granting of a Class 8 Tax Assessment Classification for the Property and that but for the Class 8 Tax Assessment Classification, no economically viable and timely redevelopment of the Property will occur; and

WHEREAS, the Applicant proposes the future industrial or commercial economic development whose economic viability is dependent on the Class 8 Tax Assessment Classification of the Property; and

WHEREAS, the Corporate Authorities find that the redevelopment of the Property will promote industrial or commercial growth, create new employment opportunities within the City and will expand and further diversify the tax base of the City and that without a Class 8 Tax Assessment Classification for the Property it will remain vacant, abandoned and exasperate blight in the area surrounding the Property; and

WHEREAS, to ensure the viability of the in-door facility, the establishment of numerous employment positions in the City, and to increase the tax base of the City, the Corporate Authorities have determined that it is necessary and in the best interest of the City to approve the Class 8 Real Estate Tax Assessment Classification for the Property.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

- Section 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.
- Section 2: The Corporate Authorities find that the proposed redevelopment contemplated herein for the Property is necessary and appropriate and that without a Class 8 Tax Assessment Classification, the Special Circumstances that exist on the Property will not be addressed

and remain vacant and underutilized and cause the continued exasperation of blighted factors within the area surrounding the Property.

Section 3: The Corporate Authorities find that the Class 8 Tax Assessment Classification Incentive
Program established by the County of Cook is necessary for the use and habitability of the
Property, which is the subject of this Resolution.

Section 4: The Corporate Authorities support and consent to the filing of a Class 8 Tax Incentive
Eligibility Application by the Applicant for the Property, which is legally described on
Exhibit A

Section 5: If any section, paragraph, clause, or provision of this Resolution shall be held invalid, the invalidity hereof shall not affect any other provision of this Resolution.

Section 6: All ordinances or resolutions in conflict with this Resolution area hereby repealed to the extent of such conflict.

Section 7: This Resolution shall be in full force and effect upon its passage, approval, and publication as provided by law.
