Dolton State Street Industrial Region Corridor Study Mayor Michelle read the following statement regarding the Dolton Corridor: "DSIR (Dolton State Street Industrial Region) Corridor Study is Complete. The Plan is reflective of business vibrancy and community character - spanning nearly three miles between I-94 and State Line Road.

The overall purpose is to make recommendations for roadway and right-of-way improvements to best serve the growing business community in the area. The goal of the study is to recommend solutions for a safe and efficient truck route while also meeting the community's goals for improving access to regional bike trails and enhancing the overall character of the corridor.

The City has received grants toward making recommended improvements come to fruition.

An informational hearing is scheduled for August 20th at 6pm. The Study can be found on the City's Website."

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, Harborside Illinois Grown Medicine, Inc. doing business as Mission Illinois submitted a duly verified application and all supporting documents for a special use permit for a cannabis dispensary at the location of 1330 South Torrence Avenue, Calumet City, Illinois (the "Subject Property"); and

WHEREAS, the Subject Property is located in the SU (Special Use) zoning district wherein cannabis dispensaries are permitted upon the issuance of a special use permit; and

WHEREAS, the Subject Property is not located within 1500 feet of another dispensary nor within 500 feet of any school or daycare as required by Section 12.7(C)(b) of the Calumet City Zoning Ordinance; and

WHEREAS, the Zoning Board of Appeals of the City of Calumet City held a duly noticed public hearing on July 23, 2020 wherein it made certain findings, attached hereto as EXHIBIT A, and voted in favor of recommending the issuance of a special use permit; and

WHEREAS, the Mayor and City Council (the "Corporate Authorities") find it to be in the best interests of the health, safety, and welfare of the City to grant a special use permit to Harborside Illinois Grown Medicine, Inc., doing business as Mission Illinois, to operate a

cannabis dispensary at 1330 South Torrence Ave., Calumet City, Illinois.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2: A Special Use Permit, pursuant to §12.7 and §12.7.5 of the Calumet City Zoning Ordinance, is hereby issued to HARBORSIDE ILLINOIS GROWN MEDICINE, INC.D/B/A MISSION ILLINOIS for the property located at 1330 SOUTH TORRENCE AVENUE, CALUMET CITY, ILLINOIS PIN# 29-24-200-051-0000 for operation of a CANNABIS DISPENSARY.

Section 3: The Special Use Permit granted pursuant to this Ordinance shall be connected to the business, not the property, and shall expire and terminate upon the sale or closing of HARBORSIDE ILLINOIS GROWN MEDICINE INC., D/B/A MISSION ILLINOIS.

Section 4: If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 5: All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6: This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

WHEREAS, Harborside Illinois Grown Medicine, Inc. doing business as Mission Illinois submitted a duly verified application and all supporting documents for a variance in parking requirements for a cannabis dispensary at the location of 1330 South Torrence Avenue, Calumet City, Illinois (the "Subject Property"); and

WHEREAS, the Subject Property contains 63 available off-street parking spaces, where at least 70 off-street parking spaces are required by §10.3(ii) of the Calumet City Zoning Ordinance; and

WHEREAS, the Zoning Board of Appeals of the City of Calumet City held a duly noticed public hearing on July 23, 2020 wherein it made certain findings, attached hereto as EXHIBIT A, and voted in favor of recommending the issuance of a variance; and

WHEREAS, the Mayor and City Council (the "Corporate Authorities") find it to be in the best interests of the health, safety, and welfare of the City to grant a variance in parking regulations to Harborside Illinois Grown Medicine, Inc., doing business as Mission Illinois, for Ord. #20-39

AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

495 Hirsch Ave

- Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.
- Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
