

ORDINANCE NO. 20-57

AN ORDINANCE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS, LEVYING TAXES FOR TAX YEAR 2020 FOR CORPORATE AND SPECIAL PURPOSES

BE IT ORDAINED by the City Council of Calumet City, Cook County, Illinois, as follows:

Section 1

That the amount of \$25,646,175 is hereby levied upon all taxable property within the corporate limits of the City of Calumet City, Cook County, Illinois, for tax year 2020 for the following corporate purposes, which sums are set forth under the column entitled, "Amount to be Raised by Taxation":

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.


Section 3



If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.




