AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

275 Merrill Ave.

Section 2. The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

AN ORDINANCE OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS IMPOSING A TEMPORARY MORATORIUM ON THE ISSUANCE OF LICENSES FOR BARBER SHOPS, BEAUTY PARLORS AND HAIR BRAIDING SHOPS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Municipal Code of the City of Calumet City, Illinois (the "City Code") requires the licensing and regulation of businesses that want to operate within the corporate limits of the City; and

WHEREAS, the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") have determined it to be in the best interest of the health, safety and welfare of the residents of the City to impose a temporary moratorium on the acceptance of an application or issuance of a City license for barber shops, beauty parlors and hair braiding shops, as such terms are herein defined, in order to protect consumers and surrounding properties while allowing City staff to undertake a review of the City Code to investigate the feasibility of imposing additional zoning or licensing restrictions; and

WHEREAS, it is the intent of the Corporate Authorities to impose a temporary moratorium for a fixed period of time as herein specified to allow City staff to determine the necessity of appropriate restrictions and report such findings to the Corporate Authorities.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. For the purpose of this Ordinance, and the interpretation and application thereof, the following terms, phrases, words and their derivations shall have the meanings given herein, unless the context in which they are used shall indicate otherwise. When not inconsistent with the context, words used in the present tense include the future, words in the singular number include the plural number and words in the plural number include the singular number. Words or phrases not defined shall be given their common and ordinary meaning unless the context clearly indicates or requires a different meaning.

"Barber Shop" is herein defined to mean any location where an individual, partnership, limited liability company, corporation, joint venture, trust, or any other legal entity engages in the occupation of barbering as defined in 225 ILCS 410/2-1.

"Beauty Parlor" is herein defined to mean any location where an individual, partnership, limited liability company, corporation, joint venture, trust, or any other legal entity engages in the occupation of either cosmetology, as defined in 225 ILCS 410/3-1, or esthetics as defined in 225 ILCS 410/3A-1.

"Hair Braiding Shop" is herein defined to mean any location where an individual, partnership, limited liability company, corporation, joint venture, trust, or any other legal entity engages in the occupation of hair braiding as defined in 225 ILCS 410/3E-1.

Section 3. A temporary moratorium on the acceptance of an application or issuance of a City license for a Barber Shop, Beauty Parlor or Hair Braiding Shop at a location not in lawful operation as of January 1, 2021, is hereby enacted. The temporary moratorium shall be in full force

and effect for a period of time beginning on January 1, 2021, and expiring at 11:59 p.m. on July 31, 2021, unless prior to that time the City Council, in its sole and absolute discretion, terminates said temporary moratorium by ordinance duly adopted.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, the Mayor and City Council (the "Corporate Authorities") may specify the yearly holidays for certain employees; and

WHEREAS, the Corporate Authorities find it to be in the best interest of the City to amend the Municipal Code of the City of Calumet City, Illinois to recognize President's Day, Pulaski Day and Juneteenth as holidays in the City.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2: Section 20-501 "Holidays for certain employees" of Division 1 "Generally" of Chapter 2 "Administration" of the Municipal Code of the City of Calumet City is hereby amended by adding the underlined language as follows:

Sec. 2-501. - Holidays for certain employees.

(a) The following shall be legal holidays for all employees of the city hereinafter designated:

Ord. #21-06 2

New Year's Day.

Lincoln's Birthday.

Washington's Birthday.

President's Day.

Casimir Pulaski Day.

Memorial Day.

Good Friday.

Juneteenth.

Independence Day.

Labor Day.

Columbus Day.

Veterans Day.

Thanksgiving Day.

Friday following Thanksgiving.

Christmas Day.

The city council annually shall designate the date on which the city shall observe such holidays.

(b) The term "employee," as used herein, shall mean any person giving his full time services to the city for which payment is made in the form of wages or salaries and devotes no less than a minimum of thirty (30) hours per week. Any employee who is eligible for holiday benefits, and who is required to work on a day designated as a city holiday, shall receive straight time pay in addition to regular pay for that day. Any employee who is eligible for an unworked holiday and does not work on the holiday shall be paid his regular wages. This section shall not apply to policemen, firemen or personnel under a union contract.

Section 3: If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4: All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5: This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, Ameri Realty, Inc., an Illinois corporation (the "Developer") has submitted a letter of intent to the City regarding the acquisition and reoccupation of the industrial facility commonly known as 1 Dutch Valley Drive in Calumet City (PINs 29-13-300-008, 29-13-300-032, 29-13-300-038, 29-13-301-015, 29-13-301-030, 29-13-301-032) (the "Subject Property"); and

WHEREAS, the Developer has requested certain economic incentives related to the Subject Property as further outlined in the Economic Incentive Agreement attached hereto as Exhibit A; and

WHEREAS, the Mayor and City Council have determined that it is in the best interests of the City and its residents to approve the Economic Incentive Agreement with the Developer in order to facilitate the development of the Subject Property;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

SECTION 1: The recitals set forth above are incorporated herein by reference and made a part hereof.

SECTION 2: AGREEMENT FORM AND TERMS AUTHORIZED. The terms and conditions as shown in the Economic Incentive Agreement attached as Exhibit A to this Ordinance are hereby approved.

SECTION 3: AUTHORIZATION TO EXECUTE AND ACT IN ACCORDANCE WITH AGREEMENT. The City Council further authorizes the Mayor to execute the Economic Incentive Agreement attached hereto as Exhibit A and any and all documentation that may be necessary to carry out the intent of this Ordinance. The officers, employees, and/or agents of the City shall take all action necessary or reasonably required by the City to carry out, give effect to, and consummate the intent of this Ordinance.

SECTION 4: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

SECTION 5: All resolutions and ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6: This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

A RESOLUTION OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS SUPPORTING A CLASS 8 REAL ESTATE TAX ASSESSMENT CLASSIFICATION FOR THE PROPERTY LOCATED AT 1 DUTCH VALLEY DRIVE, CALUMET CITY, ILLINOIS

WHEREAS, the City of Calumet City, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and,

WHEREAS, the President and Board of Commissioners of the County of Cook have enacted an ordinance known as the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Classification Ordinance"), which provides for a tax assessment incentive classification designed to encourage development throughout Cook County by offering a real estate incentive for the development or new facilities, the rehabilitation of existing structures and the utilization of abandoned buildings in order to create employment opportunities and expand the tax base; and,

WHEREAS, Ameri Realty, Inc. has an interest and is legally responsible for property taxes (the "Applicant") on a certain parcel of property within the City commonly known as 1 Dutch Valley Drive, Calumet City, Illinois, identified by certain permanent index numbers (PINs 29-13-300-008, 29-13-300-032, 29-13-300-038, 29-13-301-015, 29-13-301-030, 29-13-301-032), hereafter legally described on Exhibit A, a copy of which is attached hereto and made a part hereof (the "Property"); and,

WHEREAS, Applicant has requested that the Mayor and City Council of the City of Calumet City (the "Corporate Authorities") support and consent to the Cook County Class 8 Real Estate Tax Assessment Classifications for Property, as said term is defined in the Classification Ordinance (the "Class 8 Tax Assessment Classification"); and,

WHEREAS, the Applicant has provided an Economic Disclosure Statement to the City; and

WHEREAS, the adoption of a resolution by the Corporate Authorities is required and must be filed by the Applicant with its application with the County of Cook in order for the Property to receive the Class 8 Tax Assessment Classification; and

WHEREAS, the Applicant is planning to redevelop the property by renovating the interior and exterior of the Subject Property in order for the Applicant to open a commercial business by repairing and redesigning the building interior and installing machinery used in the Applicant's food processing business, all of which is dependent on the approval and grant of the Class 8 Tax Assessment Classification; and

WHEREAS, the redevelopment proposed by the Applicant will improve the tax base of the City, create additional temporary employment opportunities during construction and, generate real estate tax revenues for both the City and the County of Cook, as a result of the aforesaid redevelopment; and

WHEREAS, the Corporate Authorities understand that the redevelopment of the Property is occurring after a purchase by the Applicant and with over a 24-month vacancy of the Property; and

WHEREAS, the Corporate Authorities find that the redevelopment contemplated for the Property will

promote commercial growth, create new employment opportunities within the City and will expand and further diversify the tax base of the City and that without a Class 8 Tax Assessment Classification for the Property it will remain vacant, abandoned and exasperate blight in the area surrounding the Property; and

WHEREAS, to ensure the viability of the facility, the creation of numerous employment positions in the City and to stimulate the tax base of the City, the Corporate Authorities have determined that it is necessary and in the best interests of the City to approve the Class 8 Real Estate Tax Assessment Classification for the Property for the redevelopment and revitalization of the Property, pursuant to the Classification Ordinance.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Corporate Authorities find that the proposed redevelopment contemplated herein for the Property is necessary and appropriate and that without a Class 8 Tax Assessment Classification the Property will remain vacant, abandoned and underutilized and cause the continued exasperation of blighted factors within the area surrounding the Property.

Section 3. The Corporate Authorities find that the Class 8 Tax Assessment Classification incentive program established by the County of Cook is necessary for the redevelopment herein contemplated to occur on the Property which is the subject of this Resolution.

Section 4. The Corporate Authorities support and consent to the filing of a Class 8 Tax Incentive Eligibility Application by the Applicant for the Property, which is legally described on Exhibit A.

Section 5. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 6. All ordinances, resolutions, motions or orders in conflict with this Resolution area hereby repealed to the extent of such conflict.

Section 7. This Resolution shall be in full force and effect upon its passage, approval and publication as provided by law.
