**A RESOLUTION AUTHORIZING AND APPROVING
AGREEMENT WITH PROPERTY REGISTRATION
CHAMPIONS, LLC, DBA PROCHAMPS**

WHEREAS, Calumet City is an Illinois home rule unit of local government with authority to enter into contracts; and

WHEREAS, the care of neglected lawns and exterior maintenance of properties is becoming a health and welfare issue in the City; and

WHEREAS, the City desires to enter into an agreement with Property Registration Champions (“PRC”) in order to provide services to register vacant, rental, and foreclosed properties so that the City can properly address violations of the property maintenance codes.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of Calumet City, Cook County, Illinois, as follows:

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

Section 2. Authorization. The Mayor and Clerk are hereby authorized to execute the agreement with PRC attached hereto as Exhibit A.

Section 3. Effective Date. This Resolution shall be in full force and effect upon its passage and publication in pamphlet form, in accordance with law.
