Whereas, Michael Gerard Tyson was born June 30, 1966 and is an American former professional boxer who competed from 1985 to 2005;

Whereas, he was nicknamed "Iron Mike" and "Kid Dynamite" in his early career, and later known as "The Baddest Man on the Planet";

Whereas, Tyson is considered to be one of the greatest heavyweight boxers of all time and he reigned as the undisputed world heavyweight champion from 1987 to 1990;

Whereas, Tyson won his first 19 professional fights by knockout and holds the record as the youngest boxer ever to win a heavyweight title;

Whereas, he has been inducted into the International Boxing Hall of Fame and the World Boxing Hall of Fame; and

Whereas, Tyson is among the fifty business persons and/or companies who have recognized the great opportunities available in the Calumet City business district.



**RESOLUTION NO. 22-45**

**A RESOLUTION EXPRESSING THE CITY OF CALUMET  
CITY'S RECOGNITION OF LISA HOLDER WHITE**

**WHEREAS, on Thursday, July 7, 2022, Lisa Holder White took the judicial oath to become the first black female justice in the 203-year history of the Illinois Supreme Court;**

**WHEREAS, Lisa Holder White was selected by outgoing Supreme Court Justice Rita Garman as her replacement and approved by the full Court in May 2022;**

**WHEREAS, Lisa Holder White graduated magna cum laude from Lewis University in 1990 and graduated from the University of Illinois College of Law at Urbana Champaign in 1993;**

**WHEREAS, Lisa Holder White began her legal career as an assistant state's attorney in Macon County. She worked in private practice for several years before being appointed to an associate judge position in Illinois' 6<sup>th</sup> Judicial Circuit;**

**WHEREAS, in 2008, the Illinois Supreme Court appointed Lisa Holder White to a circuit judge position to fill a retirement vacancy. Lisa Holder White was elected to the same position in 2010. In 2013, Lisa Holder White was sworn in as an appellate justice;**

**NOW THEREFORE, BE IT RESOLVED that the Mayor and City Council of the City of Calumet City recognizes and congratulates Lisa Holder White for her accomplishment in becoming the first black female justice in the history of the Illinois Supreme Court.**



**ORDINANCE NO. 22-14**

**AN ORDINANCE AMENDING CERTAIN PROVISIONS OF CHAPTER 90, ARTICLE V, DIVISION 1 OF THE MUNICIPAL CODE OF CALUMET CITY, COOK COUNTY, ILLINOIS GOVERNING HANDICAP PARKING**

WHEREAS, Calumet City is an Illinois home rule unit of local government with authority to legislate in matters concerning its local government and affairs; and

WHEREAS, the Council approved certain petitions for handicap parking spaces and desires to designate certain locations as handicap parking only;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of Calumet City, Cook County, Illinois, as follows:

**Section 1.** That Chapter 90, Article V, Division 1, Section 90-317 (g) of the Calumet City Municipal Code is hereby amended to add the underlined text and locations as indicated:

**Sec. 90-317. Handicapped parking.**

(g) *Signed areas.* The following areas are hereby designated as restricted handicapped parking areas by the city council, and appropriate signs shall be posted clearly indicating such areas:

341 Luella Ave

**Section 2: Superseder.** In the event a conflict exists between the terms of this Ordinance and any other ordinance or resolution of the City, the terms of this Ordinance shall govern.


**Section 3: Severability.** This Ordinance and every provision thereof shall be considered severable and the invalidity of any section clause, paragraph, sentence or provision of this Ordinance will not affect the validity of any other portion of this Ordinance.

**Section 4: Effective Date.** This Ordinance shall be in full force and effect upon its passage and publication in pamphlet form, in accordance with law, and the provisions of the Calumet City's Municipal Code amended herein shall be reprinted with the changes.




