#### **The purpose of the meeting is for consideration of the following matters:**

3. Discussion and action on the approval of the Tax levy Resolution for the corporate authorities for the city of calumet city.

Discussion and action on Resolution of the City of Calumet City for an Interfund Borrowing between the City of Calumet City Corporate Fund and the City of Calumet City 2023 Capital Project Fund for a total of \$5.5 million for the corporate fund due to the second installment of the 2022 real estate tax levy collections being issued late by Cook County, Illinois.
5. Discussion and action on the following motion "Motion to approve the borrowing of \$200,000 to the Calumet City Library Fund from the City's Corporate Fund. The City Treasurer will coordinate with the Library Executive Director on transferring the Funds.
