Calumet City (Owner) is requesting Bids for the construction of the following Project:

**Calumet City 2023 Green Alley MWRD Partnership Program**

Bids for the construction of the Project will be received at the **Community and Economic Development Office by mail or in person at 204 Pulaski Rd**, Calumet City, IL 60409 until **Wednesday July 10, 2024**, at **10:00 a.m. CST** local time. Bids must be submitted in a sealed envelope marked "2023 Green Alley MWRD Partnership Program. "

Contracts for work under this bid will obligate the contractor and sub-contractors not to discriminate in employment practices and shall be in compliance with applicable State of Illinois Statutes pertaining to the selection of labor and the prevailing rate of wages.

The Project includes the following Work:

**Reconstruction of 4 alleys totaling approximately 2,200 feet in length to convert alleys from gravel surface to permeable paver. Work specifically will include the removal of existing aggregate, reconstruction of driveway aprons and reconstruction of alley to provide an 8" concrete edging with permeable paver interior. Work will also include installation of a single dry well and an observation well at each alley along with restoration.**

The Project has an expected completion date on or before November 15, 2024.
