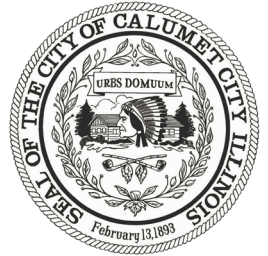

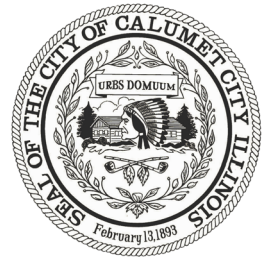

3. **PLUMBERS** – 0-55 / 0-58 ALL PLUMBERS MUST APPLY IN PERSON WITH 0-58 / JOURNEYMAN PHOTO LICENSE AND LETTER OF INTENT FOR EACH PERMIT APPLICATION SUBMITTED.
4. **ELECTRICIANS** – MUST PROVIDE A COPY OF THE CURRENT COMPANY LICENSE.
5. **HVAC** – MUST PROVIDE A COPY OF CURRENT EPA LICENSE.
6. **ROOFING**-MUST PROVIDE ROOFING LICENSE

I UNDERSTAND THAT THE PRESENTATION OF REGISTRATION IS CONDITIONAL UPON COMPLIANCE WITH ALL CITY ORDINANCES. PERMITS ARE REQUIRED FOR ALL WORK AND A SIGNED CONTRACT. THE CONTRACTORS HAS THE RESPONSIBILITY TO OBTAIN A PERMIT PRIOR TO THE START OF ANY WORK.
